Meeting Minutes

CALL TO ORDER

Commissioner Ezekiel called the meeting to order at 4:37 p.m. in Council Chambers, 301 E. Huron Street.

SPECIAL PRESENTATIONS

Bridget Callahan – Food System Economic Partnership (FSEP) – Land Link Program Research

Bridget Callahan, a student at the University of Michigan, gave a slide presentation on the Food System Economic Partnership regarding Land Link Program. Land Link Programs throughout the country facilitate the transfer of farmland from farmland owners to farmland seekers. She explained that financing land, finding land and linking into farming networks can be challenging for beginning farmers who do not have a farming background and the program helps with that endeavor. Land Link programs also provide services for leasing agreements that can lead from partnership to ownerships to the new farmers. Some programs also direct participants to land conservancies and other development rights arrangements. PDR and Land linking Programs make purchasing farm land more affordable for beginning farmers and they encourage landowners to preserve farmland.

Ms. Callahan concluded by stating that Ann Arbor Greenbelt and a Land Link Program could fit together with a common goal of working to protect farmland. Land link could direct individuals towards the Greenbelt Program and vise versa.

C-2 Staff Update

Ginny Trocchio said that she has been finalizing the details for the bus tour scheduled for September 22, 2012. They are considering taking a tour along the eastern portion of the greenbelt this time and are working with partners along the Superior greenway. Information regarding the tour would be posted on the website as well as emails going out to commissioners.

Ms. Trocchio updated the commission on the Farm Bill. She said that a lot of questions have been asked regarding the bill. The latest that she has heard about the Farm and Ranch Grants Program is that there have been significant cuts proposed for conservation programs and the latest that she has seen is about \$50 million to FRPP for next year nationwide. She said she would update the commission further when more information is provided.

Chairperson Ezekiel announced he was asked to appear on the show Issues With The Environment on WEMU. The program is scheduled to air on October 22, 2012. He said that the Greenbelt has been featured on that program from time to time and they reached out to him and asked if he would appear on the show.
