Two letters have been received protesting the 202 South Division Street PUD rezoning proposal. Staff has verified that the owners submitting the protests, Ben J. Burkhart, Peter N. Heydon and Henrietta M. Heydon, own over 20 percent of the land included within the area extending outward 100 feet from the boundary of the 202 South Division Street property. As a result, <u>adoption of the rezoning will require at least eight affirmative votes</u> (Chapter 55, Section 5:107(5)).


