The Newton Property in Ann Arbor Township - 63 Acres  
The Joe Block Property in Ann Arbor Township - 23 Acres  
Conservation Easement on the Boyd Property in Northville Township - 136 Acres*

*The closings have preserved over is over 300 acres, and the total acres preserved in the greenbelt is now over 3700 acres.*

*Ms. Trocchio said they still have not heard from Farm and Ranch about the grants that were submitted. She knew that there were over 30 applications submitted, totaling over \$5 million.*

*Commissioner Ezekiel said that a farm lecture took place recently. It was an amazing community event. He added that Commissioner Brine's places had a booth there and was a partial sponsor of the event. The speaker said a lot of things that were challenging that people would have to go home and ponder about some more. The slide presentation showed many different land preservation and small grower initiatives going in the area.*
