## UNFINISHED BUSINESS

Commercial Quadricycle Discussion

*Assistant City Attorney Mary Fales provided Commission members with a draft ordinance regarding the regulation of commercial quadricycles.*

*Councilmember Lumm also provided members with a draft ordinance that was provided to her from the City of Frankenmuth.*

*Attorney Fales briefed the new members on the history of the discussion, stating she had reached out to various stakeholders last Fall regarding the operation of commercial quadricycles in the City. Ms. Fales stated generally the DDA and the downtown businesses and bar owners were supportive of the operation in the downtown; however some concern was raised regarding possible traffic back-ups.*

*Councilmember Ackerman moved, supported by Councilmember Smith, that any proposed ordinance language not be limited specifically to the DDA, but apply to the entire City. On a voice vote, the motion was approved.*

*The discussion continued and Attorney Fales reminded members that previously the Ann Arbor Police had raised a concern regarding the operation of commercial quadricycles during special events, including football Saturdays.*

*Committee members began to develop a consensus on a number of items relating to a future ordinance that would need to be considered:*

*1. Do we want to regulate or allow State law?*

*If regulated:*

- 1. Hours of Operation*
- 2. Consumption of Alcohol - if allowed, limitations on quantity, types of containers?*
- 3. Parking issues ("standing" at stops on the route)*

*Councilmember Kailasapathy stated she does not agree with allowing drinking onboard, stating drinking is not allowed for pedestrians or other drivers.*

*Commissioners directed Attorney Fales to draft an ordinance taking into consideration the following:*

- 1. Allow commercial quadricycles to operate in the City.*
- 2. Prohibit drinking onboard.*
- 3. Additional regulations regarding hours of operation (not on Main Street during rush hour), restriction of certain days (e.g. Football Saturdays).*
- 4. Parking (stopping/standing)*
- 5. Speed (allow only on streets with speed less than 25mph)*
- 6. Training of operators*
- 7. Seatbelts?*
- 8. Safety of vehicle, including required lighting*

**INFORMATION/UPCOMING BUSINESS**

*Committee members agreed to meet again on Friday, April 29 at 4:00 p.m. to continue the discussion regarding Commercial Quadricycles.*
