*A free residential upholstered furniture collection event is scheduled for Friday, October 22, 2010 through Sunday, October 24, 2010 from 12-5 p.m. each day at the intersection of East University and Oakland Streets. The event is for Ann Arbor residents and Ann Arbor property managers only. Ms. McCormick warned that those leaving any other types of materials, depositing furniture from non Ann Arbor properties or using the site during off-hours would be subject to illegal dumping fees. *LEAF COLLECTION*

*Leaves are being collected this fall in compost carts or bags on the curb, rather than being picked up loose in the streets. Ms. McCormick stated that another option for removal of leaves is to use a mulching mower to enrich the lawns with leaves. Residents may also bring their leaves to the City of Ann Arbor Compost Site. Ms. McCormick stated several residents had asked about hired contractors dropping off leaves at the drop-off center and whether the contractor would be charged as a non-resident. Provisions have been made to allow residents' contractors to drop off their leaves at no charge. Notice will be given to residents who do place their leaves loose in the street, reminding them of the change in policy.*

*October 20, 2010 is the scheduled date for a ribbon cutting ceremony for the completion of the Geddes Road/US-23 interchange project. The project includes the addition of a non-motorized, multi-use path along the south side of Geddes Road, connecting to a new bridge spanning US-23.*

*STONEYFIELD FARMS BID WITH YOUR LID PROGRAM*

*Between August 1 and October 1, 2010, numerous Ann Arbor grocery stores hosted the Stoneyfield Farms Bid with Your Lid Program. Shoppers that purchased Stoneyfield Farm products could return to any of the participating local grocery stores and cast their vote for one of three Ann Arbor Parks and Recreation Services using their lids. The three programs to choose from were Mack Indoor Pool, the Ann Arbor Senior Center or the Ann Arbor Parks and Recreation Scholarship Fund. The Senior Center was the winner. They will receive a donation of \$15,000.00 from Stoneyfield Farm.*

*CONSTRUCTION UPDATES*

*The contractor released to the City on October 15, 2010, a section of the new Police/Court building for the IT department. They currently do not have a Certificate of Occupancy permit, but have been able to move materials in. This was done because the first floor of City Hall was given to the contractors to begin demolition and remodeling of the first floor.*

*Police personnel currently in City Hall and the City Center will move into the new building in approximately three weeks.*

*Site work on the south side of building is under way, including underground stormwater improvements.*

*Work on the interior basement drywall ceilings is complete and they are in the process of laying ceiling grid where it's necessary. Mechanical, electrical and plumbing work continues in the basement of Larcom, as well as metal panel installation on the elevator towers is nearly complete. New air handling equipment has also been installed in the 7th floor mechanical room.*

**COMMUNICATIONS FROM COUNCIL***COUNCILMEMBER DEREZINSKI*

*Councilmember Derezinski commented on the report from the City Administrator regarding leaf collection. He said that it has been a very controversial issue this year, particularly in the 2nd Ward because of the tremendous number of trees in the area.
