Kathy,

First, the financials have been consistent for as long as I've been involved in the matter – the only thing that has changed since a couple of years ago has been the prospect of private funding being raised to help defray the construction costs – the costs quoted to you reflect those that the City would have to incur if we assumed the entire charge. If prior quotes were less than they were predicated on private funding to complement the City's contribution. No funding has ever been allocated to the project that I'm aware of. Second, just because the City participates in a committee does not constitute a formal or official approval of a given project – as you noted in tonight's public comment, the TSC is advisory only. Issues and recommendations that evolve from groups like the TSC are considered on their merits by the City Administrator and/or City Council on a case-by-case basis.

I made no attempt to "re-write" history and quite frankly, am unclear as to what you're alluding to. I merely provided you with a summary of staff's assessment. By the way, you indicated that Chief Jones visited the site (yes he di) and implied his support – for the record he too does not view the construction of a new path to be warranted.

Lastly, there is no cronyism and I challenge you to provide evidence to clarify and/or and substantiate your claim. All we can do is judge the facts, and as articulated, they fail to project the matter to a high enough priority that would justify construction of a new path at this time. I'm sure that we would be happy to reassess the issue if new and compelling facts became evident.

Kathy,

I'd like to report out on your request for the construction of a new sidewalk, south of King Elementary School and on the east side of Waldenwood Dr. and relocation of the marked pedestrian crossing near the school's eastern driveway.

Staff has assessed the situation from the perspectives of feasibility, finance and operations. A new path, approximately 200' in length, would have to be constructed in the City's ROW. The new path would require grading on the adjacent two properties fronting Pemberton Lane. Costs for a concrete path to tie into new ADA ramps at the Pemberton/Waldenwood intersection ranges from \$15,000-\$20,000. A non-standard asphalt path with concrete ADA ramps would cost \$10,000. Both options would require winter maintenance.

From a traffic and pedestrian standards and safety point of view, the traffic speed limit is low at 25 mph, sight distance is sufficient, and traffic volume is low. In the last 10 years and within 500' of the existing mid-block crossing there have been no reported pedestrian related accidents, and only one reported minor automobile accident. There does not appear to be a groundswell of concern over pedestrian safety within the neighborhood. And our on-location visit seem to concur with the notion that safety issues there are seemingly minor.

Both the AAPS and abutting property owners indicated they will not participate in the construction cost or the maintenance of the sidewalk.

It is staff's view that constructing the sidewalk with a provision for maintenance will not be an effective solution given the marginal improvement it would bring. Relative to other higher volume and higher traffic speed pedestrian crossings in the city, and coupled with the safety history of the current crossing, would not cause the construction of a new path to be considered a high priority. In addition, the City's CIP budget doesn't currently contemplate construction at this location and most likely would not be altered given the low priority need for the new path.

Thus, staff is not recommending the expenditure and construction of a new path on Waldenwood Dr., especially in the absence of a sidewalk maintenance agreement.

I appreciate that the aforementioned position is not likely to satisfy your ongoing concerns. I hope that you'll respect the thoroughness of the assessment performed by staff and their findings.

Dear Mayo Hieftje;

The King School crosswalk was scheduled to be moved last fall. This minor project was within the authority of city staff. It was engineered and scheduled last fall without the need for council approval. City staff identified funding for the crosswalk and neighbors agreed to fund raise and coordinate the construction of the extension to the existing blacktop path.

However, the project was put on hold by the City Administrator after a neighbor opposed the project because neither the City nor AAPS would agree to shovel/maintain the crosswalk ramps and sidewalk/blacktop path on his property (in right-of-way along the street, similar to other sidewalks and ramps shoveled/maintained by homeowners.)

Therefore, a council resolution is required now to direct the City Administrator to move the crosswalk.

As background, this is a two-year old request and the crosswalk move is supported by the Transportation Safety Committee (TSC), the King School Principal, the AAPS Director of Transportation and many neighbors who have contacted you and other council members.

Your response to me in the hallway of city hall (which I referred to in my original email in this thread) was, "We have all summer." I interpreted that to mean time to move the crosswalk, not time to debate this project and allow cronyism to delay a needed safety improvement.

I remain available to provide any needed support on this crosswalk move and any other pedestrian safety initiatives.

Howard Zinn's The Bomb

Howard Zinn's The Bomb

The late Howard Zinn's new book "The Bomb" is a brilliant little dissection of some of the central myths of our militarized society. Those who've read "A Terrible Mistake: The Murder of Frank Olson and the CIA's Secret Cold War Experiments," by H.P. Albarelli Jr. know that this is a year for publishing the stories of horrible things that the United States has done to French towns. In that case, Albarelli, describes the CIA administering LSD to an entire town, with deadly results. In "The Bomb," Zinn describes the U.S.

military making its first use of napalm by dropping it all over another French town, burning anyone and anything it touched. Zinn was in one of the planes, taking part in this horrendous crime.

In mid-April 1945, the war in Europe was essentially over. Everyone knew it was ending. There was no military reason (if that's not an oxymoron) to attack the Germans stationed near Royan, France, much less to burn the French men, women, and children in the town to death. The British had already destroyed the town in January, similarly bombing it because of its vicinity to German troops, in what was widely called a tragic mistake. This tragic mistake was rationalized as an inevitable part of war, just as were the horrific firebombings that successfully reached German targets, just as was the later bombing of Royan with napalm.

Zinn blames the Supreme Allied Command for seeking to add a "victory" in the final weeks of a war already won. He blames the local military commanders'

ambitions. He blames the American Air Force's desire to test a new weapon. And he blames everyone involved

-- which must include himself -- for "the most powerful motive of all: the habit of obedience, the universal teaching of all cultures, not to get out of line, not even to think about that which one has not been assigned to think about, the negative motive of not having either a reason or a will to intercede."

When Zinn returned from the war in Europe, he expected to be sent to the war in the Pacific, until he saw and rejoiced at seeing the news of the atomic bomb dropped on Hiroshima, 65 years ago this August. Only years later did Zinn come to understand the inexcusable crime of the greatest proportions that was the dropping of nuclear bombs in Japan, actions similar in some ways to the final bombing of Royan. The war with Japan was already over, the Japanese seeking peace and willing to surrender. Japan asked only that it be permitted to keep its emperor, a request that was later granted.

But, like napalm, the nuclear bombs were weapons that needed testing. The second bomb, dropped on Nagasaki, was a different sort of bomb that also needed testing.

President Harry Truman wanted to demonstrate nuclear bombs to the world and especially to Russia. And he wanted to end the war with Japan before Russia became part of it. The horrific form of mass murder he employed was in no way justifiable.

Zinn also goes back to dismantle the mythical reasons the United States was in the war to begin with. The United States, England, and France were imperial powers supporting each other's international aggressions in places like the Philippines. They opposed the same from Germany and Japan, but not aggression itself.

Most of America's tin and rubber came from the Southwest Pacific. The United States made clear for years its lack of concern for the Jews being attacked in Germany. It also demonstrated its lack of

opposition to racism through its treatment of African Americans and Japanese Americans. Franklin D.

Roosevelt described fascist bombing campaigns over civilian areas as "inhuman barbarity" but then did the same on a much larger scale to German cities, which was followed up by the destruction on an unprecedented scale of Hiroshima and Nagasaki -- actions that came after years of dehumanizing the Japanese. Zinn points out that "LIFE magazine showed a picture of a Japanese person burning to death and commented: 'This is the only way.'" Aware that the war would end without any more bombing, and aware that U.S. prisoners of war would be killed by the bomb dropped on Nagasaki, the U.S. military went ahead and dropped the bombs.

Americans allowed these things to be done in their name, just as the Germans and Japanese allowed horrible crimes to be committed in their names. Zinn points out, with his trademark clarity, how the use of the word "we" blends governments together with peoples and serves to equate our own people with our military, while we demonize the people of other lands because of actions by their governments. "The Bomb" suggest a better way to think about such matters and firmly establishes that --what the U.S. military is doing now, today, parallels the crimes of the past and shares their dishonorable motivations; --the bad wars have a lot in common with the so-called "good war," about which there was little if anything good; --Howard Zinn did far more in his life for peace than for war, and more for peace than just about anybody else, certainly more than several Nobel Peace Prize winners.

Dear Friends,

I write to ask for your help in gaining the freedom of a good man, a man of peace, and a man of conscience.

In the Jewish scriptures there is great emphasis on justice and freedom and it is for such, for one man, that I write to seek your help.

He will not be aware that I am writing this Appeal, but I do so in the hope that, with your help, it will produce his freedom, and not (and this I must risk) cause yet more punishment and cruelty to be inflicted upon him.

However, I feel when I tell you the story, it will touch your hearts and there will be those amongst you who will be able to help him gain his freedom.

In May, 2010, this man was returned to prison to serve three months for allegedly breaking his prison release

restrictions and speaking to Foreign Media. On Sunday

11th July, 2010, he had his first visit in seven

weeks. His brother, Meir, was granted a 30 minute

visit. There was a glass window between them and they spoke via the phone. He wore a prison uniform. He is held in the hardest prison section there is in the prison. It has the most notorious criminals in the country, well known hard murder cases. All about a dozen are in severe isolation conditions. He is in a cell by himself for 24 hours a day, no window but a small wire covered crack at the top part of one wall.

He has about an hour's walk a day in a very tiny yard.

He was simply thrown in a cell by the security agents, the door locked, and left to suffer there all alone.

He has not spoken to anyone in all the seven weeks and this visit was (apart from a short visit of his lawyer

6 weeks ago) the first conversation he had in seven weeks. His food is limited in quality and quantity, and his reading material two books he has with him. Of course his spirits are down as a result of being put in such harsh, inhuman and cruel conditions.

His name is Mordechai Vanunu, and he is in an Israeli prison cell. Mordechai is no stranger to prison. In

1986 Mordechai Vanunu told the world that Israel had a Nuclear Weapons Programme and he was given 18 years imprisonment for doing so. He is the Israeli Nuclear whistle blower and 24 years later continues to be punished for trying to warn the Israelis and protect both Israel and the world from a Nuclear weapons

disaster. Mordechai Vanunu served the full 18 years

of his sentence (eleven years in solitary) and upon release, instead of allowing him to leave Israel, the Israeli Government put severe restrictions upon him, including forbidding him to leave Israel and not to speak to foreign media. It was the allegedly breaking of these restrictions and speaking to Foreign media, which resulted in Mordechai being returned to prison for 3 months. He has 6 weeks left to serve in these

harsh prison conditions, and even upon release from prison will still have to remain in Israel until next April, 2011 when the restrictions will be reviewed and probably renewed yet again, as they have been renewed

each year for the past 6 years. Some people say

Vanunu will never be allowed to leave Israel but will die there, if indeed in the meantime his spirit is not broken by his ill treatment and he losses his sanity.

The Shabak continues to tell the Israeli Government he is a security risk and must not be released and the Israeli Judiciary and Government obey them and keep him imprisoned. Vanunu is no risk to Israeli National Security. He has no nuclear secrets. I have asked some Israelis why they think Israel refuses to allow Mordechai Vanunu to leave Israel. Various reasons are given but the most frequent answer is they feel the Israeli Government does not trust its citizens and holding Mordechai Vanunu, forever, if necessary sends out the signal to Israeli Citizens to behave themselves.

It seems, if this is so, that the strategy is working.

To date only a few courageous Jewish people have raised their voices against such cruelty and injustice perpetrated upon Mordecai, and called for him to be allowed to leave Israel. But I don't believe Mordechai will never be allowed to leave Israeli and will die in

Jerusalem. I have met Mordechai many times since he was released from prison on 21st April, 2004. He is a good man, a man of peace, and a true Gandhian spirit.

Instead of punishing him, Israel should be proud of Mordechai Vanunu, and I believe that future generations of Israelis will look back and realize that there lived amongst them a great visionary and man of peace, not only for Israel, but for the human family. It was with great joy I nominated him several times for the Nobel Peace Prize, as did many other prominent names during the past 24 years. He richly serves the NPP as he lives and acts in the true spirit of Alfred Nobel, who left his prize for those who would work for peace and disarmament.

However, it is with the deepest sadness that I acknowledge that in spite of world campaigns by many, including Amnesty International (and personal letters from myself to President Obama, President Shimon

Peres,) Mordechai Vanunu continues 24 years later to be most cruelly imprisoned and punished by Israel. Most

Political and Spiritual leaders, and International Bodies, of our time are silent in the face of Israel's abuse of Vanunu's basic human right to freedom of speech and liberty, which is in violation of many International Laws.

However, I have hope that he will be free and I place my hope in those Jewish people who read this story and are moved to right a wrong continuing to be done to Mordechai Vanunu, and they will demand that their Government give him his freedom, and allow him to leave Israel.

HIV Devastates Minorities

VIENNA - The Centers for Disease Control and Prevention today released a first-of-its-kind analysis showing that 2.1 percent of heterosexuals living in high-poverty urban areas in the United States are infected with HIV. This analysis suggests that many low-income cities across the United States now have generalized HIV epidemics as defined by the United Nations Joint Program on HIV/AIDS (UNAIDS).

UNAIDS defines a generalized epidemic as one that is firmly established in the general population, with an overall HIV prevalence in the general population of more than 1 percent. While subpopulations with higher risk (such as men who have sex with men and injection drug users) may still contribute disproportionately to the spread of HIV in these areas, heterosexual transmission is also sufficient to sustain an epidemic independent of those groups.

The analysis also shows that poverty is the single most important demographic factor associated with HIV infection among inner-city heterosexuals. Contrary to severe racial disparities that characterize the overall U.S. epidemic, researchers found no differences in HIV prevalence by race/ethnicity in this population. The analysis will be presented at the XVIII International AIDS Conference in Vienna, Austria.

"This study reveals a powerful link between poverty and HIV risk, and a widespread HIV epidemic in America's inner cities," said Kevin Fenton, M.D., Ph.D., director of CDC's National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention. "In this country, HIV clearly strikes the economically disadvantaged in a devastating way."

The analysis, led by Paul Denning, M.D., a medical epidemiologist in CDC's Division of HIV/AIDS Prevention, included more than 9,000 heterosexual adults (aged 18-50) in high-poverty areas of 23 cities who participated in the 2006-2007 heterosexual cycle of the CDC's National HIV Behavioral Surveillance System.

This system monitors HIV risk behaviors, HIV testing patterns, and use of HIV prevention services among U.S.

populations at risk.

High-poverty areas were defined according to the U.S.

Census Bureau, and included areas in which at least 20 percent of residents have household incomes below the poverty line.

Nationally, the United States is considered to have a concentrated HIV epidemic, meaning that it is confined mainly to individuals who engage in high-risk behaviors, which in the United States are primarily gay and bisexual men and injection drug users.

For this analysis, researchers followed UNAIDS criteria for determining a generalized epidemic, and excluded groups at highest risk for becoming HIV infected. Those groups not included in this analysis were gay and bisexual men - who continue to represent the majority of new HIV infections in the United States - injection drug users, and sex workers and their clients.

"These findings have significant implications for how we think about HIV prevention. We can't look at HIV in isolation from the environment in which people live," said Jonathan Mermin, M.D., director of CDC's Division of HIV/AIDS Prevention. "This analysis points to an urgent need to prioritize HIV prevention efforts in disadvantaged communities. We are pleased that President Obama's new National HIV/AIDS Strategy reflects this type of approach, in terms of targeting HIV prevention resources to those in greatest need."

Prevalence was especially high in those with the lowest socioeconomic status. Within the low income urban areas included in the study, individuals living below the poverty line were at greater risk for HIV than those living above it (2.4 percent prevalence vs. 1.2 percent), though prevalence for both groups was far higher than the national average (0.45 percent). There were no significant differences in HIV prevalence by race or ethnicity in these low income urban areas: prevalence was 2.1 percent among blacks, 2.1 percent among Hispanics, and 1.7 percent among whites. By contrast, the U.S. epidemic overall is characterized by severe racial/ethnic disparities: the HIV prevalence rate for blacks is almost 8 times that of whites, and the HIV prevalence rate among Hispanics is nearly 3 times that of whites.

The absence of race-based differences in this analysis is likely due to existing high prevalence of HIV in poor urban areas, which - regardless of race or ethnicity - places individuals living in these areas at greater risk for exposure to HIV with each sexual encounter.

Authors note that other factors associated with poverty also likely contribute to high HIV prevalence in these settings. Some of these factors include limited health care access, which can reduce utilization of HIV testing and prevention services; substance abuse, which can increase sexual risk behavior; and high rates of incarceration, which can disrupt the stability of relationships.

This analysis provides greater insight into factors that may be driving heterosexual HIV transmission in the United States, which accounts for 31 percent of new infections each year. This study did not examine HIV prevalence among groups at higher risk for HIV in these areas, including MSM and IDU. Nationally, MSM account for 53 percent of new infections, IDU account for 12 percent, and those exposed through both MSM and IDU account for 4 percent.

National Actions Against Pritzkers and the Hyatt Hotels

National Actions Against Billionaire Pritzkers and the Hyatt Hotel Chain

On June 9, blue-chip Hyatt stockholders anxiously anticipating dividend announcements that would, perhaps, justify a nice evening on the town - maybe in one of the city's acclaimed five-star restaurants - assembled inside the plush Hyatt Regency McCormick Place in Chicago. Protesting outside, were hotel workers who had their own concerns about how to put food on the table. Hyatt employees average less than \$30,000 a year in most of the country.

Stockholders, on the other hand, had good reason to expect a nice, big slice of the pie. Hyatt shares have ballooned 50 percent since the formerly privately owned company went public in late 2009. In that deal, Pritzker family owners alone netted close to \$1 billion. The cash register has been ringing ever since.

The hotel union, UNITE-HERE, reports, "as recently as March 2010, Hyatt had \$1.3 billion cash on hand - on average, nearly five times as much as any other hotel company." National hotel industry profits overall are also rebounding upwards.

The union's Local 2 in San Francisco, for example, reports revenue growth for city hotels "projected to be

4 percent for the remainder of 2010, 12 percent in 2011 and 14 percent in 2012." "We haven't seen these dramatic double-digit numbers since the 1970s," emphasized Local 2 press coordinator Riddhi Mehta.

Everyone seems to be cashing in - except employees. As a result, 400 UNITE-HERE Local 2 members in San Francisco walked off the job at the Hyatt Regency on June 8 for a three-date strike, launching an employee- endorsed boycott of the hotel.

On the picket line, union representative Tina Chen summed up the feelings of the workers "who know well that the company is making loads of money. A one-year contract we offered them last year would have kept our current health insurance, maintained our pensions and provided a modest wage increase, while still only increasing labor costs by 1.5 percent. Why do they try to squeeze us?"

This is the question that just won't go away. Support for hotel workers is growing nationally as contracts expire in major cities like San Francisco, Chicago, Los Angeles, Vancouver and Honolulu where coordinated actions against the Hyatt were to take place the week of June 9.

Among the protesters in Chicago were 100 religious leaders who were stopped at metal detectors as they attempted to peacefully enter the stockholders' meeting. As they vowed not to leave before speaking with a Hyatt representative, Hyatt Human Resources chief Robb Webb finally did show up.

"I applaud your interest and I applaud the concern,"
Webb piously began. When questioned about the abrupt firing of 100 housekeepers in Boston (who were replaced with cheaper, outsourced labor), he reassured the clergy that it was "not consistent with

the values of the company. We're not proud about how that was handled." However, he also reported that the difficult "business decision" was final and the workers would not be rehired. (All Webb quotes by Chicago Breaking Business reporter Julie Wernau.)

Trifecta of Power, Money and Greed

The Hyatt Hotel Corporation boasts a portfolio of 434 properties in 45 countries. It is a formidable entity as is its major shareholder, the billionaire Pritzker family of Chicago. The Pritzkers are not only extremely wealthy - having been listed on Forbes' "America's Richest Families" since it originated in 1982 - but they are also quite good at buying influence.

Penny Pritzker conveniently became national finance chair of the Obama presidential campaign shortly after family business interests suffered a major public embarrassment. Superior Bank, a lender chaired by Pritzker, collapsed in 2001, causing millions in losses to the government and depositors.

For years, Superior reported profits and paid its owners dividends of nearly \$200 million "without regard to the deteriorating" condition of the bank, according to a 2002 report by the Federal Deposit Insurance Corporation (FDIC).

Cozying up to Obama was one of a series of calculated moves to repair the family's damaged personal reputation and to cultivate a "Mad Men," carefully crafted image of social concern. For example, the Pritzker Foundation recently made a \$10 million, tax- deductible donation to Stanford University "to create a scholarship fund dedicated to supporting Chicago students with the greatest financial need."

There is evidence that this apparent generosity is self-serving pretense - or public relations "investment." Simultaneously, the Pritzkers continually cut staff and increase workloads at their hotels. As a result, the Hyatt had the highest reported rate of injury in 2009 for housekeepers in an academic study of 50 major hotels as reported by the progressive blog Firedoglake.

Despite this long record of financial malfeasance and labor hostility, President Obama continues to cast Pritzker in the unlikely role as advocate for American working families as well as financial adviser to the Obama presidential campaign. Predictably, "penny- pinching" Pritzker joined with other billionaires on the Economic Recovery Advisory Board to oppose the Employee Free Choice Act legislation which would allow millions of workers to select a union free from well-documented patterns of employer harassment.

No Easy Settlement Expected

The Pritzkers value their treasured personal bank accounts, but also power. They seek the power to limit employee expectations now and into the future, a power that assures owners a growing share of corporate revenues at the expense of workers, over the long term.

On the other hand, a fair agreement at the Hyatt would allow Local 2 to keep the best contract in the industry intact while setting standards for other hotels with expired contracts as well.

"Power never takes a back step - only in the face of more power," argued Malcolm X. This is one such contest, between two very determined forces, one with the solid support of the workers and a growing list of community allies, the other with the entrenched influence of wealth.

Facing down the Pritzkers, hotel workers in five cities made a show of force last week against the third-largest hotel chain in the country. These actions mark an important, strategic escalation.

Clearly, this will not be the last strike, protest and boycott if hotels continue stalling negotiations. More nationally coordinated actions will certainly develop as contracts for around 50,000 hotel workers expire soon in major cities across the country.

The towering San Francisco Hyatt Regency sits on the edge of the famed bay waterfront where police and long shore strikers battled during the 1934 victorious general strike. Today, there is a plaque nearby honoring martyred picketers Nicolas Bordoise and Howard Sperry, who were felled.

Working-class cafes and lunch spots have long ago been replaced by elite shops and fancy bistros shaded by magnificent, imported, palm trees lining the entire length of the city's grand waterfront traffic lanes overlooking the bay.

While times and San Francisco's character change, the hotel workers' actions today hearken back to the very best traditions of this historic district and herald dramatic showdowns that lie ahead in this great city and across the country.

Dear Mayor Hieftje and City Council Members,

The Washtenaw Bicycling and Walking Coalition (WBWC) would like to extend our gratitude to Mayor Hieftje and Council Member Hohnke for working with us over the past nine months to bring forward revisions to Section 10:148 of Chapter 126. We strongly believe the current ordinance lacks the clarity and strength to protect pedestrians trying to cross at marked crosswalks. Please read our attached position paper for more background on our work on this issue the past year. We also encourage you to watch the following video, produced for WBWC by Matt Grocoff, for a reminder of why this ordinance needs revisions. http://www.youtube.com/watch?v=xsT5ZJUnBg0.

We fully support the following proposed language for Section 10:148. The language in Section A has been used successfully in Boulder, Colorado for the past 21 years and we believe it will also provide Ann Arbor with the solid legal foundation for future pedestrian education and enforcement campaigns:

- (a) When traffic-control signals are not in place or are not in operation, the driver of a vehicle shall yield the right-of-way to every pedestrian approaching or within a crosswalk.
- (b) A pedestrian shall not suddenly leave a curb or other place of safety and walk or run into a path of a vehicle that is so close that it is impossible for the driver to yield.
- (c) Every pedestrian crossing a roadway at any point other than within a marked crosswalk or within an unmarked crosswalk at an intersection shall yield the right-of-way to all vehicles upon the roadway.

We hope we can count on all of your support to amend this ordinance, as well as in the years ahead as we seek to address how to make sure the new law becomes second nature for drivers in Ann Arbor.

WBWC Pedestrian Campaign Step One: Revise Ann Arbor's Pedestrian Ordinance (10:148)

Problem: Motorists fail to yield to pedestrians at crosswalks in Ann Arbor creating barriers in our community for the disabled, elderly and children, a safety issue for all of us and furthering the "cars-rule" mentality prevalent in Michigan.

Goal: All pedestrians, regardless of ability or age, can cross the street safely and with ease at marked crosswalks across the City.

Proposed Solution:

- Step 1: Revise Ann Arbor's ordinance (10:148) to require motorists to yield for pedestrians both waiting to cross and within a marked crosswalk.
- Step 2: Develop and launch a innovative public education campaign to educate motorists of their responsibilities.
- Step 3: Develop and implement an on-going, coordinated targeted enforcement and public education campaign for motorists that fail to follow the law.

Background

In May 2009, WBWC hosted "Walk, Talk and Chalk" — an event which brought together community members for a walk around Ann Arbor's west side with the objective of identifying key issues that affect pedestrians. Participants identified a number of barriers to walking such as connectivity, sidewalk maintenance, poor enforcement, motorist behavior, and urban design, however motorist behavior at crosswalks jumped to the top of the list as one of the top barriers to walking in Ann Arbor.

The Need for Improved Walkability in Ann Arbor

Although it is true that Ann Arbor has many of the attributes of a walkable city (and we have many awards we can take pride in) we still have much work to do. You need only look to North Main Street with its crumbling sidewalks, urban design problems, connectivity issues and lack of focus on the pedestrian experience to know we still have work to do.

Furthermore, we're seeing a disturbing trend in Ann Arbor. The number of individuals walking to work has decreased in Ann Arbor—from 18% in 1980 to approximately 14% today. And, the number of pedestrian and vehicle crashes has increased in Ann Arbor each year since 2004 (43 crashes, 45 in 2005, 52 in 2008).

It is vital that City staff and policy makers remain committed to making Ann Arbor a more walkable city. Walking is by far the most popular recreational activity in Ann Arbor (2005-2011 PROS Plan). And in addition to having great public support, walking also has great public health and environmental benefits and it creates a stronger sense of place by getting people out and interacting with the community in which they live. And the icing on the cake... walkable cities are a key ingredient to attracting new residents. Research continues to show that young professionals and empty-nesters want to live in walkable communities.





For many of the group members, 3rd and Huron (the intersection where the YMCA is located) was frustrating, but crossable, if the walkers were willing to dart across the street when there was a break in traffic. However, for

a few of our disabled walkers, the intersection provided to be impassable. Because motorists did not stop at this marked intersection to allow them to cross, they were unable to get across the street without endangering themselves. We were also informed that some of the residents at Lurie Terrace (the senior center on Huron Street) are actually taxied across the street to the YMCA to work out because Huron Street presents too great a risk for them to cross.

After the Walk, Talk and Chalk event, we visited other crosswalks across Ann Arbor to see if pedestrians faired better elsewhere. Sadly, they do not. For a look at motorist behavior at crosswalks across town, check out our video available at: http://www.youtube.com/watch? v=xsT5ZJUnBg0

In October 2009, WBWC hosted a pedestrian forum, the first in the city and perhaps the state, examining the issue of motorist behavior at crosswalks and it's relationship to our pedestrian ordinance. WBWC wanted to determine if 1) our pedestrian ordinances provided sufficient protection for pedestrians and simply need to be enforced or 2) if revisions were necessary before the start of an education and enforcement campaign.

The Forum was moderated by WBWC and the panel included the following experts and community leaders: Susan Pollay, DDA Director; Eli Cooper, Transportation Manager; Pat Cawley, Project Manager Engineering; Officer Elizabeth Patton from AAPD, Kristen Larcom, City Attorney; Carolyn Grawi, Advocacy and Education Director for the Center for Independent Living; Robert Wagner, Director of Lurie Terrace the Senior Center on Huron Street; and Rory Neuner, Urban Policy Specialist for the Michigan Environmental Council.

The forum produced clear findings. Ann Arbor's current ordinance lacks clarity for enforcement and doesn't meet the needs of pedestrians trying to cross the street. Simplification of the ordinance and broadening it to require motorists to yield not only for pedestrians in the crosswalk, but also for pedestrians waiting to cross, is an important first step. Once the ordinance is revised, an on-going public education and targeted enforcement campaign will be vital to changing motorist behavior.

You and many others in Arizona have kindly sent many emails trying to help those of us on Ann Arbor's City Council understand Arizona's circumstances. Thank you for this. Thank you also for the tone of your letter, which was much more civil than many others.

Please understand, Ann Arbor did not vote to boycott Arizona. I understand that many other communities have done so; Ann Arbor did not.

Ann Arbor's City Council voted for a resolution that urged the Federal Government to enforce existing immigration laws, and fix the immigration system.

Ann Arbor's City Council stated that immigration is the <u>responsibility of the Federal Government</u> and that States are ill equipped to enforce immigration law.

And as such is something Ann Arbor's City Council stated, it also urged the <u>Michigan</u> legislature not to enact any legislation similar to Arizona's law.

I know that, for years -- and presidential administrations -- the Federal Government has failed to adequately enforce immigration laws. Whether those laws deal with overstaying visas or people crossing borders illegally, the results are the same. I am not opposing Arizona's law to give more power to drug runners, smugglers, or those who seek amnesty for illegal aliens. However, I don't believe a patchwork of immigration law enforcement as seen by 50 different states is the answer, either.

I am absolutely shocked that your city would boycott the state of Arizona. I thought Americans were suposed to care about humankind and the rules of law. I am a decent taxpaying citizen and I believe SB1070 is the only way to stop the humanitarian crisis going on in Arizona. I am an Arizona native and I am sick about what has happened to my state because of our federal government's failure to secure our borders. My ancestor's have lived in Arizona generation's before it was even a state. I have seen many changes happen to Arizona but nothing compared to what is happening because of the open border. I would be grateful if you would the time to hear another side of the issue.

I want you to know about rape rooms, yes it is exactly as it sounds. In the Sonoran desert where the illegal tresspassers smuggle human beings into America there are makeshift rooms that are constructed by draping garbage bags around cactus, trees and bushes to make an enclosed area to rape smuggling victims. Then they hang their bras and undergarments on the trees, for what purpose they hang these garments, I do not know, but I imagine it is some kind of conquest reminder or a threat to those who will come next, and there are at approximately 3,000 per day, yes that estimate is correct 3,000 per day.



By contrast, 2.7 million people visited two sites associated with Franklin D. Roosevelt.



The Teamsters Civilian Supervisors and the Teamsters Police Professional Assistants have both voted to ratify contracts which provide savings to the City. Both of these bargaining units have also agreed to increase their contributions to the City's health care and to their pension plans, while taking no raises.

During these difficult economic times, the cooperation of these Unions, as well as the cooperation of the non-union employees of the City, is appreciated by the Council, and by the residents of the City. It should be noted that the changes in health care which we are ratifying in these contracts tonight provide the City with short term, immediate savings. However, the changes also provide long term savings related to retiree health care in the future.

The City continues to negotiate in good faith with the Police Officers and Police Command Units and the Firefighters to achieve similar savings within their bargaining groups. Given the importance of this situation, the Council is keeping a close eye on developments in these negotiations. The costs of health care continue to rise every year. Currently, the firefighters, the police officers and the police command officers pay only a deductible of \$250 per person or \$500 per family. They do not pay a monthly premium or co-insurance. The new plans ratified tonight include an increased deductible, a 20% co-insurance and the option of a monthly premium for lower deductibles and out of pocket maximums.

We are hopeful that negotiations with the remaining groups will be successful and lead to the type of savings that other bargaining units have already achieved and ratified. However, if negotiations are unsuccessful, we are supportive of staff pursuing Act 312 binding arbitration to resolve these contracts.
