Mayor Hieftje called the meeting to order at 7:10 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

- 1. Tom Partridge - Progress Agenda: Expand employment, voting and human rights, public transportation, affordable housing and environmental protections. (I-5, I-6, I-7, I-8, I-11)**

Tom Partridge, Ann Arbor resident, addressed Council regarding a progressive agenda, which would include discussions on expanding employment, voting, human rights, public transportation, affordable housing and environmental protections.

- 2. James D'Amour- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)**

James D'Amour, 2771 Maplewood Ave., representing the Sierra Club of Ann Arbor, spoke in support of the proposed resolution requiring voter approval of long term non-park or non-recreational uses of parkland. He said that Ann Arbor residents demand public input on this issue.

3. Elizabeth Donoghue Colvin- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)

Elizabeth Donoghue Colvin, 1053 Maiden Lane, spoke in opposition to the proposed resolution requiring voter approval of long term non-park or non-recreational uses of parkland. She said the current process provides plenty of opportunity for public input into the process.

4. Rita Mitchell- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)

Rita Mitchell, 621 Fifth St., encouraged Council to support the proposed resolution requiring voter approval of long term non-park or non-recreational uses of parkland. She said that this resolution would provide support for City parkland, which is jointly owned by all Ann Arbor taxpayers.

5. Lawrence Baird- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)

Lawrence Baird, 1770 Riverwood Dr., spoke in support of the proposed resolution to require voter approval of long term non-park or non-recreational uses of parkland. He said there is a loophole in the 2008 charter amendment that could allow the City to enter into long term lease agreements for non-park purposes and essentially repurpose the land. He added that this not only violates the spirit of the amendment, but also violates the spirit of the voter approved Greenbelt program.

6. Carl Goines - Funding for Preliminary Site Work at 415 W. Washington (DC-2)

Carl Goines, Executive Director of 555 Nonprofit Gallery and Studios, said that he and a team of professionals have been working with the Mayor's Taskforce to determine the next steps for creating an art space at 415 W. Washington. He asked for Council's support for the proposed resolution to fund preliminary site work at 415 W. Washington.

7. Jack Eaton- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)

Jack Eaton, 1606 Dicken Dr., spoke in support of the proposed resolution requiring voter approval of long term non-park or non-recreational uses of parkland and spoke in opposition to postponing the vote on this issue until after the Primary Election on August 7, 2012. He said that supporting the resolution does not amend the Charter; it allows voters to express their opinion on amending the Charter.

8. Sally Petersen- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)

Sally Petersen, 2976 Hickory Lane, urged Council to approve the proposed resolution to place a question on the ballot, requiring voter approval of long term non-park or non-recreational uses of parkland. She said that not doing so would be inconsistent with the intent of the City's Open Space and Parkland Ordinance.

9. Gwen Nystuen- Ballot Question for Charter Amendment Requiring Voter Approval of Long-Term Non-Park or Non-Recreational Uses of Park Land (DC-1)

Gwen Nystuen, 1016 Olivia Ave., spoke in support of the proposed resolution requiring voter approval of long term non-park or non-recreational uses of parkland. She said that the proposed resolution does not prevent changing the use of parkland or the sale of parkland. It shows that this issue is important enough to put it to a vote of the citizens. It requires that the citizens be made fully aware of proposed changes and have an opportunity to vote on them.

10. Blair Shelton - Appointment of John Seto as Safety Services Administrator and Police Chief (DC-3)

Blair Shelton, 609 E. William, spoke in opposition to the proposed resolution to appoint John Seto as Police Chief and Safety Services Administrator of Ann Arbor.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER SMITH

Councilmember Smith announced that the Huron River North Main Task Force held its first meeting. Site tours have been scheduled July 25, and August 1, 2012. Their first action meeting has been scheduled for August 8, 2012, location to be determined.

A grand opening of the Library Lot underground parking structure took place recently. The structure is not completely open, but is planned to be fully open to the public prior to the start of the 2012 Ann Arbor Art Fairs.

MAYOR HIEFTJE

Mayor Hieftje also commented on the new parking structure. He noted that no General Fund dollars went into the building of the structure. The mayor stated that the City has to make a decision about its future regarding transportation and whether more parking structures will be built or if public transit will be expanded.

COUNCILMEMBER BRIERE

Councilmember Briere said that she attended the grand opening of the parking structure and that she has three passes to the structure available. She said that if anyone was interested in the passes to contact her directly.

COUNCILMEMBER LUMM

Councilmember Lumm also attended the grand opening of the parking structure. She said that there was another gathering this past Saturday on the top of the parking lot regarding the vision that many City residents have regarding the future of the surface lot itself and the possibility of creating a public space.

COUNCILMEMBER ANGLIN

Councilmember Anglin reported on the Jackson Road lane change project and the

meeting that recently took place. He said over 100 residents attended the meeting and the community is split on the future of the corridor. Councilmember Anglin thanked staff for engaging the citizens regarding the project.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that he watched the Ann Arbor French Dukes perform this past weekend. He said that the Ann Arbor should be proud of the French Dukes. They performed in front of President Nixon in the past and are people who have brought great value and pride to the community.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

UPDATE ON CITY'S WATER SUPPLY

City Administrator Steve Powers asked Craig Hupy, Interim Public Services Area Administrator, to update Council on the City's water supply given the unusually dry summer season.

Mr. Hupy said that with the continuing warm weather, a question has come up on how the drought and the reduced rainfall have affected the City's water supply. He said that conditions are not currently affecting the water supply. The water is drawn from well fields and the river. The river is the majority of the water supply. The river is running between 80 and 90 cubic feet per second (cfs). There are two power dams; Barton and Superior. Both dams are currently shut down and are not producing power because the river flow is low enough and there is not enough energy there to produce power. The next trigger point for reporting would be 50 cfs, which the City would be required to report to the MDEQ. MDEQ may or may not ask the City to start the drought contingency plan, which is a 3-tiered plan, if the City reaches this threshold. The first tier would be voluntary odd/even watering bans and then escalating up through mandatory total watering bans at the highest level.

Mr. Hupy added that historically the City has had good responses from citizens when they have gone to voluntary watering bans. This may be required in the next few weeks if the drought conditions continue.
