#### C-1 Project Update - SRE Building/Environmental Assessment/Airfield Lighting

The general contractor continues to understaff the project which continues the slow pace of work. The bonding company is also involved at this point. The FAA has made comments on the draft EA and responses are being prepared. This may take some time to complete. The airfield lighting/signage project has wrapped up. A few sign faces are incorrect and will be replaced soon. The Airport and the ATCT are completing a Letter of Agreement in regards to operating the new pilot controlled lighting system.
