1. Tom Partridge - County and State transportation improvements essential. Approve the proposed 4-Party Countywide transportation agreement.

Tom Partridge, Ann Arbor resident, spoke in support of the proposed AATA 4-Party countywide transportation agreement. He also addressed Council regarding the election of President Obama and the Democratic Party candidates in the November 2012 Election.

2. Sumi Kailasapathy - Fuller Park (DS-1)

Sumi Kailasapathy, 2530 Mallard Ct., spoke in opposition to the proposed Fuller Road Station Project. She said that she greatly regrets that one of the cherished City parks is moving one step closer to being converted into a railway station/parking garage. She urged Council to stop spending taxpayer money on this proposed project, until a public vote is taken.

3. Nancy Shiffler - Ann Arbor Rail Passenger Station (DC-4, DS-1)

Nancy Shiffler, 2877 Sorrento Ave., chair of the Huron Valley Group of the Sierra Club, addressed Council regarding the proposed Ann Arbor Rail Passenger Station resolutions. She expressed concern regarding the process outlined for the environmental assessment and the selection of the Smith Group JJR to complete the assessment.

4. Rita Mitchell - Ann Arbor Rail Passenger Station (DC-4)

Rita Mitchell, 621 Fifth St., member of Protecting Ann Arbor A2 Parks, spoke in opposition to the proposed Ann Arbor Rail Passenger Station resolutions. She said that Council has not received adequate information to make a decision on this issue and that the information provided to Council and the public keeps changing.

5. Orián Zakai - Human Rights Minutes (I-7)

Orián Zakai, 220 N. First Street, addressed Council regarding the Imagine Community Project, which is a nonprofit organization working to create a 24-hour warming center in Ann Arbor for the homeless. She added that the building at 721 N. Main St., a City-owned facility, is a good space for this project. She urged Council to consider this location.

6. James D'Amour - Ann Arbor Rail Passenger Station Project (DS-1)

James D'Amour, 2771 Maplewood Ave., addressed Council regarding the Ann Arbor Rail Passenger Station Project. He said that he is in support of public transportation. However, he stated he felt that a decision at this point is premature, without further thought and information about the consequences of the proposed project. He asked that the resolution be postponed.

7. Jack Eaton - Fuller Road Transportation Station (DC-4)

Jack Eaton, 1606 Dicken Dr., spoke in opposition to the proposed Fuller Road Transportation Station Project. He said that a train station at this location is not consistent with parkland use. He asked that Council consider the precedent they would be setting with the approval of the proposed project on land designated as City parkland.

8. Mary Conway - Homeless (I-7)

Mary Conway, 801 E. Ann St., addressed Council regarding the homeless in Ann Arbor and their needs. Camp Take Notice will soon be disbanded. The Delonis Center is not able to help many of the people that live at Camp Take Notice because of addiction and behavioral problems of some of those at the camp. The needs of these people must be addressed, she stated. Ms. Conway suggested that Council consider using the space at 721 N. Main as an alternate site for these folks.

9. Alexandra Hoffman - Human Rights (I-7)

Alexandra Hoffman, 801 E. Ann St., addressed Council regarding homelessness and basic human rights. She said that to end homelessness, people have to change themselves and how they think about the homeless. Attention needs to be focused on a society that provides warmth and shelter for all.

10. Lily Au - Human Rights (I-7)

Lily Au, 682 Peninsula Ct., addressed Council regarding homelessness and the fact that Camp Take Notice is being shutdown on June 22, 2012.

COMMUNICATIONS FROM COUNCIL**COUNCILMEMBER DEREZINSKI**

Councilmember Derezinski reported that the Planning Commission held their annual retreat this past week and the main topic was the South State Street corridor. He said commissioners reviewed the State Street corridor to see what improvements could be made in the area. He said that there are challenges, as well as opportunities for improvements along State Street and the Commission is looking forward to their work on the transit study for the area.

COUNCILMEMBER ANGLIN

Councilmember Anglin said that a number of speakers have for many years taken their time and effort to develop and learn about the issues that the City has to face, ranging from public housing to recreation, sustainability, the environment, parks and

the like. Groups have met on their own time, requested documents through the FOIA process, and have presented at different times, good suggestions to the Council on current issues facing the City. Councilmember Anglin said that he hoped that the Council is listening and are grateful to the residents and their dedication to this City. They are the taxpayers; they are the people that Council represents.

COUNCILMEMBER BRIERE

Councilmember Briere said that John German needs to be reappointed to the Environmental Commission and that there would be another vacancy coming up on the Commission as well. She suggested that he be appointed at the next Council meeting.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman noted that there are still two vacancies on the Taxicab Board. He welcomed the public to apply for the positions.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Steve Powers reported on the following:

GRAFFITI ARREST

Mr. Powers acknowledged the investigative work of the Ann Arbor Police Department, which resulted in the arrest of two perpetrators; one in the recent graffiti incident and one of two perpetrators in the Broadway Party Store robbery.

MEMORIAL DAY WEEKEND

Mr. Powers reported that Ann Arbor parks were quite busy over the Memorial Day weekend. They grossed over \$72,000.00 between the Argo cascades and the golf courses around town.

ANN ARBOR PUBLIC SCHOOLS

Mr. Powers said he met with the Ann Arbor Public Schools Superintendent regarding public transportation plans. The Superintendent has asked City staff to join her ad hoc transportation working group. This request is not to have City staff duplicate efforts with the Ann Arbor transit plans and school transportation plans, but to collaborate on mutual interest and efforts, such as walkways and pathways and maintenance of alternative transportation routes.

MAYOR'S GREEN FAIR

The Mayor's Green Fair is scheduled for this Friday, June 8, 2012 from 6-9 p.m. on Main Street. One hundred and fifty local businesses and nonprofits will be sharing ideas and products with the community. Mr. Powers encouraged all to come out for the event.
