Budget Planning for FY11

Chief Jones, Ann Arbor Police Department, was present to speak about the possibility of the Washtenaw County Sheriff's Department taking over the City's Emergency Management responsibilities. He recommended that the City keep control of Emergency Management.

Dan Rainey, City IT Director, spoke to Council about outsourcing the Information Technology department. Mr. Rainey did not recommend this option.

Chief Jones spoke out impacts of the budget on the Police Department.

Councilmember Higgins asked what the responsibilities of Emergency Management were, other than to be available for University of Michigan football games; and what amount of general fund support is allocated to Emergency Management. She also requested information about all City collaborations with other local entities.

Councilmember Smith asked what services within the City are currently privatized. She also asked how much revenue Community Standards had earned on ticket payments.
