**C-1 New GAC Member**

**C-2 Staff Update**

*Remy Long informed the commission that they are coordinating with all of the Greenbelt RCPP partners to launch the program. A public announcement is needed in regards to the RCPP with a 30 day application window included, in which landowners can submit application*
