**Council Liquor License Review Committee**

CALL TO ORDER

*The Chair, Tony Derezhinski, called the meeting of the City Council Liquor License Review Committee to order at 1:40 p.m. in the City Council Chamber, 301 E. Huron Street, Ann Arbor.*

*City Clerk Jacqueline Beaudry, Fire Marshal Kathleen Chamberlain, Sgt. Bob Pfannes of the Ann Arbor Police Department, Ralph Welton, Chief Building Official, and Assistant City Attorney Mary Fales were in attendance.*

**A motion was made by Councilmember Anglin, seconded by Councilmember Lumm that the resolution be recommended for approval.**

*Sgt. Pfannes stated he received a letter from the Michigan Liquor Control Commission with concerns about an unauthorized transfer in ownership of the license. He stated the AAPD was not ready to recommend approval until this issue was resolved with the State.*

*It was decided to postpone the item until the next meeting to allow time for this issue to be reviewed.*

**A motion was made by Councilmember Anglin, seconded by Councilmember Lumm, that the Resolution be Postponed to the Council Liquor License Review Committee and should be returned by 2/23/2012. On a voice vote, the Chair declared the motion carried.**

*A motion was made by Councilmember Lumm, seconded by Councilmember Anglin, that the committee direct the City Clerk to send annual renewal letters recommending approval for all on-premised licensed businesses who were not identified by any staff departments for further review and/or objections. It was further moved that the City Clerk send letters to all identified business who had delinquent personal property taxes and/or building department issues a letter stating the applicant had until February 23 to address the staff concerns to avoid further action from the committee. The Elks Lodge was removed from the list to allow the City Attorney to follow-up on some other concerns from Planning and Development regarding the zoning, and the use of the Club License. On a voice vote, the motion carried.*

*A motion was made by Councilmember Anglin, seconded by Councilmember Lumm, that the committee direct the City Attorney to proceed with an objection to the annual renewal of the license for Dream Nite Club due to objections raised by the Ann Arbor Police Department and the City Attorney. On a voice vote, the motion carried.*
