Thomas Partridge, Ann Arbor resident, spoke about the Christmas season and the need to take care of the most vulnerable residents.

Councilmember Kunselman stated there is currently a vacancy on the Taxicab Board. He urged City residents to apply.

COUNCILMEMBER LUMM

Councilmember Lumm noted that the Washtenaw County Water Resources Manager has scheduled a temporary lane closure on Huron Parkway due to the access road construction that is part of the Malletts Creek restoration project.

COUNCILMEMEBER BRIERE

Councilmember Briere stated that the path at Argo is open and there are kayakers out there now.

MAYOR HIEFTJE

Mayor Hieftje spoke about recent efforts to address abandoned and boarded-up properties in the City. The Mayor stated that he and Councilmember Kunselman met with City staff and discussed the possibility of establishing a fund to address the problem, using monies from the demolition of the Michigan Inn.

COUNCILMEMER SMITH

Councilmember Smith addressed comments from a member of the public regarding coordinating funding of human service funds. She said that she and Councilmember Teall have worked on the coordinated funding process and the current system is working.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Steve Powers reminded Council and the public that property taxes will be due on Tuesday, January 3, 2012 due to the early closure of City Hall on Friday, December 30.

Mr. Powers thanked City Council for the introduction of DC-2, resolution approving the General Obligation Limited Tax Refunding Bonds, and DC-4, resolution to amend the 2012 City Council calendar, to the agenda tonight. He noted that the refunding of the City's bonds will save the City approximately \$200,000.

Mr. Powers informed Council that information regarding the City's wastewater treatment plant project will be presented at the January 17 Council Work Session. A resolution will be on the January 9 City Council agenda regarding the bonding for the project.

Michael Benson, 2450 Stone Road, stated he supports the proposed changes to the ordinance. He stated it is a good start, but more education is needed.

An unidentified member of the audience expressed concerns about the ordinance and its impact on persons with disabilities.

Kathy Griswold, 3565 Fox Hunt, stated it needs to be made clear that this ordinance is not about pedestrian safety, but pedestrian rights.

Thomas Partridge, City resident, expressed concern with the proposed changes to the ordinance.

Steven Ranzini, City resident, spoke about the recent survey on AnnArbor.com regarding the proposal.

“(a) When traffic-control signals are not in place or are not in operation, the driver of a vehicle shall stop before entering a crosswalk and yield the right-of-way, to any pedestrian stopped at the curb, CURB LINE or ramp leading to a crosswalk and to every pedestrian within a crosswalk...”

VEHICLE IS TRAVELING OR WHEN THE PEDESTRIAN IS APPROACHING SO
CLOSELY FROM THE OPPOSITE HALF OF THE ROADWAY AS TO BE IN
DANGER. ...

10:148. - Pedestrians crossing streets.

...(b) A pedestrian shall not suddenly leave a curb or other place of safety and walk or run into a path of a vehicle that is so close that it is [impossible] UNSAFE for the driver to yield. ...

Councilmember Lumm moved to amend the Ordinance as follows:

...10:148. - Pedestrians crossing streets.

(a) When traffic-control signals are not in place or are not in operation, the driver of a vehicle shall stop before entering a crosswalk and yield the right-of-way to any pedestrian [stopped at the curb or ramp leading to a crosswalk and to every pedestrian] within a crosswalk. [Delete remaining language following the word "crosswalk."]
