The exterior is purposely forward looking and will be principally glass. First floor side walls will be a dark colored burnished block, areas above will be clad with architectural high-performance cement panels and wood trim. A thin metal panel fin accentuates the street elevation. A common lobby will serve both the first floor retail and upper floors of office. Zoning is D1 Base District, South University Overlay District. (Ward 1)
