Moved by Commissioner Kathryn Fortener, seconded by Commissioner Anna Epperson, that the Historic District Commission issue a certificate of appropriateness for the portion of the application at 529 Detroit Street, a contributing property in the Old Fourth Ward Historic District, to do the following work, with conditions: restore the exterior of the main building including recreating the historic cornice and barn door openings and replacing non-original windows with aluminum clad wood windows that match the original opening sizes; demolish the sheds on the north side; pave and formalize the parking lot; clad the rear stair addition and office addition with metal siding; construct a new second floor on top of the office addition; and construct a new two-story stair/lobby addition on the north side of the building on the condition that the new stair/lobby roof does not exceed 1/3 of the height of the current tower roof and is approved by the officers of the Historic District Commission before the site plan application is submitted to the City. The work as conditioned is compatible in exterior design, arrangement, texture, material and relationship to the surrounding resources and meets the Ann Arbor Historic District Design Guidelines, especially those for all addition, and The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 1, 2, 9 and 10 and the guidelines for alterations for a new use, additions, windows, and district/neighborhood setting.

Moved by Commissioner Kathryn Fortener, seconded by Commissioner Jessica Quijano, to make a friendly amendment to the motion, that the Historic District Commission issue a certificate of appropriateness for the portion of the application at 529 Detroit Street, a contributing property in the Old Fourth Ward Historic District, to do the following work, with conditions: restore the exterior of the main building including recreating the historic cornice and barn door openings and replacing non-original windows with aluminum clad wood windows that match the original opening sizes; demolish the sheds on the north side; pave and formalize the parking lot; clad the rear stair addition and office addition with metal siding; construct a new second floor on top of the office addition; and construct a new two-story stair/lobby addition on the north side of the building on the condition 'that a new redesign of the new stair/lobby roof to be below the parapet of the historic building' is approved by the officers of the Historic District Commission before the site plan application is submitted to the City. The work as conditioned is compatible in exterior design, arrangement, texture, material and relationship to the surrounding resources and meets the Ann Arbor Historic District Design Guidelines, especially those for all addition, and The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 1, 2, 9 and 10 and the guidelines for alterations for a new use, additions, windows, and district/neighborhood setting.
