Thank you for your note. Please be advised that Kayla has taken another role in the City. I am following up regarding your inquiry and will continue to coordinate with my transportation department colleagues. As you may be aware, the intersection of Huron and Seventh is under MDOT jurisdiction. Our staff have been working with MDOT to make improvements to the conditions at that intersection. We are taking your input, and the data collected as part of the engineering study into consideration as improvements are being considered. You may also want to include the MDOT Brighton TSC, MDOT - Brighton TSC, 10321 Grand River, Suite 500 Brighton MI 48116, as part of your outreach efforts. Please let me know if I can be of any additional assistance.

I am an Ann Arbor mom of a family of four living in the 800's in Seventh St. My kids are elementary students at Ann Arbor Open, 1st and 4th graders. We bike to and from Ann Arbor Open School. Since the school year started I have noticed more pedestrian traffic crossing the intersection of 7th St. and W. Huron. Also, I witnessed an increase of hazardous situations there that could end in an avoidable accident. Currently, it seems that the pedestrian buttons which supposedly control traffic lights don't seem to be adding much safety. I think we can do better.

Attached you may find a letter I would like to be included in the Transportation Commission agenda. I wish I could attend but two kids and not affordable child care makes joining your meeting a complicated adventure. The document included in this email illustrates what are these potential hazards I have seen and offers some suggestions of how to address them. I hope I can contribute to improving pedestrian safety at that intersection.
