• Allied World: Quote indication of approximately \$45,000

Allianz: Quote indication of approximately \$45,000

• Aspen: Declined to quote, not able to insure underground storage tanks



Discussion Items

- 1. Changes to coverage terms with Chubb:
 - a. Chubb has reduced the deductible for Underground Storage Tanks from \$100,000 to \$50,000
 - b. New form added Chubb Public Entity endorsement which includes several new exclusions to coverage:
 - i. Fluorinated Compounds (PFAS)
 - Lead Contaminated Water
 - iii. Lead at Shooting Ranges
 - iv. Odors and Atmospheric Migration
 - v. Prisons, Detention Facilities or Jails
 - vi. Products Liability
 - c. Hylant is continuing to negotiate with Chubb to remove the new exclusions where possible, which may result in increased premium. Alternate option to move coverage to either Allied World or Allianz with higher premium currently estimated at \$45,000.
 - i. Note that all environmental markets are excluding PFAS

2. Coverage options:

- a. Terrorism coverage is available for additional premium \$1,688. Signed acceptance or declination of coverage required (previously declined)
- b. Chubb provided an optional quote that includes coverage for Indoor Environmental Conditions (mold, legionella) -additional premium \$3,459.
 - i. Premium for terrorism coverage increases to \$1,861 if Indoor Environmental Conditions coverage is elected.

3. Subjectivities:

- a. Completed, signed and dated Chubb Environmental application
- b. Signed and dated terrorism disclosure form, but only if rejecting terrorism coverage
- c. Chubb engineering phone survey

For consideration of Indoor Environmental Conditions (IEC):

- d. Receipt and review of insured's mold & legionella plans and water intrusion prevention plans
- e. Completion of the IEC related questions in the renewal application
