#### CALL TO ORDER

*L. Stambaugh called the meeting together at 7:02 p.m.*

#### APPROVAL OF MINUTES

#### **Follow Up of Outside Group Work**

##### **City Council**

*CM T. Radina discussed a request he received from the public at City Council meeting inquiring whether the HRC would be interested in encouraging or requiring Ann Arbor businesses to post the protections people have under the Non- Discrimination Ordinance (NDO) in visible places to help educate the public.*

##### **Facial Recognition**

*A. Sova reported that the Facial Recognition Technology working group spoke with Deputy City Attorney, Arianne Slay, on the status of the new draft ordinance, but at this time there is still nothing to share.*

#### **Follow Up on Ongoing HRC Work**

##### **Community Outreach**

*A. Ghazi Edwin discussed plans for the newly formed HRC community outreach group. They will focus on reaching a broader audience in all communities with information about the HRC and the NDO, how to respond to discrimination and file complaints, and with information about events and so on that are especially relevant to them.*

##### **Conversion Therapy Logistics**

*L. Stambaugh discussed reaching out to minors who are most effected by Conversion Therapy and D. Cass had volunteered to do that outreach. She has applied to Ann Arbor Public Schools and received notice that the HRC is now an AAPS community partner. She has also reached out to Neutral Zone's Riot Youth and is planning to meet with them at the beginning of the new year.*

##### **Fair Chance Housing Update**

*M. Radabaugh gave a summary about the injunction filed against the city's Early Leasing Ordinance and the Fair Chance Access to Housing Ordinance. M. Radabaugh was happy to report that the judge denied the request for the injunction, citing the likelihood of success on the merits of*

*the case overall.*

### **Complaints**

*L. Stambaugh discussed how the HRC takes complaints on violations of the Non Discrimination Ordinance (NDO) and wants to make sure the public knows that the complaint form is on the HRC website along with answers to many questions and contact information to address any others.*

### **Refining the Complaint Process**

*L. Stambaugh discussed the plan, first introduced by Commissioner Cowan, to build a database for complaints going back to 2014, to help the HRC more efficiently identify any patterns that exist. L. Stambaugh asked for volunteers to meet and discuss what questions we need to know for the database. Commissioners; K. Cowan, L. Winker, A. Sova and A. Ghazi Edwin will help. In January 2022, K. Cowan and A. Sova will join the HRC team handling complaints.*

### **Trespass**

*L. Winkler reported on the trespass memo. The memo needs to be updated based on feedback received from ICPOC Vice Chair, Frances Todoro Hargreaves. The editing will include a longer introduction and a history on the HRC's work with trespass. In the future the HRC will set up a joint meeting with ICPOC and AAPD Police Chief, Michael Cox. Afterwards a copy will be sent to all commissioners.*

### **NEW BUSINESS**

#### **Meeting Schedule for 2022**

*L. Stambaugh discussed the 2022 HRC meeting schedule. A. Sova moved to accept the meeting schedule, seconded by J. Garber. The motion carried.*

#### **City Council Unarmed Response Resolution**

*L. Stambaugh discussed City Council's Resolution to deal with mental-health emergency calls, giving the City Administrator two options: 1) to come up with a plan on how to implement a mental-health response to emergency calls, or 2) to write a report by December 31, 2021, explaining why he thinks this isn't a good idea. L. Stambaugh noted that*

*this topic involves important human rights issues and we should respond to it. The materials to consider will be provided.*

#### **Traffic Stop Data Subgroup**

*L. Stambaugh gave an update on the HRC's collaboration with ICPOC on Traffic Stop Data. ICPOC has arranged to have available police data on the traffic stops analyzed by researchers at EMU. ICPOC wants to specify that additional information on traffic stops be collected in the future to ensure that a more comprehensive picture can be realized and is gathering input to consider in a future proposal. Commissioners D. Das, A. Sova, A. Ghazi-Edwin and K. Cowan will participate in this project.*

#### **COMMISSIONER COMMUNICATIONS**

*P. Dent reminded the commission to upload their proof of vaccination by the deadline on Monday, December 13, 2021.*
