PETITION

TO THE WATER RESOURCES COMMISSIONER OF WASHTENAW COUNTY

The undersigned public corporation hereby petitions for the cleaning out, relocating, widening, deepening, straightening, tiling, extending or relocating along a highway, constructing branches, relief drains or connections to the County Farm Drain as shown in Exhibit A, to serve the area described in Attachment 1, which storm improvements better described in the attached Memorandum and Resolution, are necessary to prolong the life of the infrastructure and improve the integrity of the stormwater system. The County Farm Drainage District is located within the limits of the City of Ann Arbor, the petitioner herein.

This petition is filed by the City pursuant to the provisions of Section 463 of Chapter 20 of Acts No. 40 of the Public Acts of 1956, as amended.

It is understood that none of the proposed drain project attributable to the part of the project in the City will be paid for by a special assessment levied against persons in the City.

PROJECT NAME:

County Farm Drain Streambank Stabilization

PROJECT DESCRIPTION:

Stabilize streambank along the open segment of County Farm Drain to reduce bank erosion, channel incising, sedimentation and tree fall.

PROJECT LOCATION:

Between Platt and Manchester immediately south of Washtenaw.

DRAIN ROUTE AND COURSE:

Commencing at a junction with the Pittsfield-Ann Arbor Drain at a point just south of Washtenaw Avenue, being in the NW ¼ of Section 2, City of Ann Arbor, Pittsfield Township, Town 3 South, Range 6 East, Washtenaw County, Michigan; thence proceeding westerly, crossing Huron Parkway south of Washtenaw Avenue; thence proceeding southwesterly to a crossing of Platt Road, said crossing being 620 feet +/-southerly from the center line of Washtenaw Avenue; thence proceeding westerly 250 feet +/- and northwesterly 1050 feet+/- to junction point No. 1; thence continuing westerly to a termination point at Manchester Road.

Also a branch beginning at previously described junction point No. 1 and proceeding northwesterly to a termination point at the north right-of-way line of Washtenaw Avenue.
