Re: Recommendation of Preferred Proposal

With the withdrawal of the proposal from Whisper Aviation for the FBO building located at 719 Airport Drive, the subcommittee was tasked with reviewing the Airport's options for re-use of the building. As part of this effort, the subcommittee reached out to the two remaining proposers to determine if they were still interested in the building, reached out to new parties that had expressed interest in the building, considered a new proposal process, looked at different aviation uses for the site and discussed internal redevelopment of the facility.

The two remaining proposers each expressed their interest and confirmed the terms of their proposals as still valid. Two additional parties that had expressed interest were contacted and one move forward with a written proposal. The subcommittee felt comfortable that from these three proposals, a recommendation could be made. An interview of the new proposer, KARB Ventures, was held by the subcommittee to review the proposal and address questions. After a comprehensive review and discussion of the three active proposals, the following recommendation is offered by the subcommittee.

Recommendation

The subcommittee is recommending that the Airport Advisory Committee move forward to the due diligence phase with the proposal submitted by KARB Ventures. A copy of their proposal is attached. The proposal would bring another experienced FBO operator to ARB. In addition to traditional FBO services, KARB Ventures will provide avionics, aircraft upholstery and painting, and aircraft sales to our aviation users. There were numerous other positive items that were shared during the interview that the subcommittee would be happy to discuss at the meeting if Committee members are interested.





Structure of Deal

- We will make all necessary renovations to facility, up to \$200,000 and demonstrate liquidity for renovations and operations
- Will bring FBO and aircraft dealership online within agreed upon time period
- Lease rate to be discussed
- Lease duration Would like to be a long term operation at Ann Arbor, and bring real value to Ann Arbor airport and community
 - Desire is a long term lease with 1 renewal option to absorb CapEX from renovations
 - Note, other nearby airports offer 30 year lease term with 10-30 year extensions
- Would like option for additional adjacent land lease option for construction of T-hangars to accommodate 50' wingspans.
