Trespass Status of Discussion: J. Garber reported the HRC-ICPOC working group met over zoom with AAPD and the Deputy City Attorney to review and discuss recommendations it made regarding the enforcement of the trespass ordinance. Discussion focused on Trespass policies and procedures and the form that is used when Trespass is "read". They plan to meet again. No date has been set.
