I'd like to briefly respond to some of the offensive and inaccurate comments made by Ken Land during tonight's meeting about the students who supported the amendment to the Early Leasing Ordinance (ELO).

The ELO amendment was supported by multiple student governments on campus which collectively represented all 50,000+ students. Having personally served as the student body VP of the College of LSA which is a very diverse institution, I take serious issue with Mr. Land's accusation that the supporters of this ordinance were a group of white, upper class, transient, elite students who suddenly decided to bully local landlords. I was one of the core supporters of this amendment and I am the son of a North African immigrant, I graduated last month with over \$11,000 in debt (thanks to need-based scholarships this number was not higher), I am now a full time employee at the Rogel Cancer Center, and I intend on living in this city, which I love dearly, for as long as I am able.

The ELO has allowed many people like myself to relax for several months after movein in September and evaluate whether they would like to continue living in their current apartment. Before the ELO was amended, most students were seriously stressed and panicked only a few days after move-in about where they were going to rent for the following year. Instead of focusing on schoolwork and midterms, we were forced to spend our time looking for apartments that we would not even move into for almost an entire year.

While I am very confident that this amendment was a major improvement in the renting landscape of our city, the most frequent complaints from tenants that I have heard regarding the ELO is that landlords have been refusing to follow it. Landlords have been circumventing our city law by creating unofficial wait lists, often with required (and frequently nonrefundable) deposits. They have been spreading blatantly false information via email to their tenants about the ELO that I have seen with my own eyes and as you know all too well, they also decided to waste a significant amount of our city's resources with a frivolous and failed lawsuit.

I urge you to consider supporting the introduction of a Right to Renew Ordinance that would close many of the current loopholes and I look forward to working with all of you as a member of the newly started Renters' Commission. Please do not hesitate to reach out to me to talk about my experience as a renter or what I hope to accomplish as a member of the Renters' Commission.
