DDA Curb Management Study

The Downtown Development Authority recently kicked off a curb management study that will analyze use of existing on-street parking, loading zones, and other activities along the curb and make recommendations on how to make improvements. Staff from the DDA and their consultant will give a presentation and solicit feedback from the Commission.

Capital Improvement Plan Update

Last month, staff presented an overview of the CIP process including the Transportation Commission role. This is a "full-plan" year, rather than a "modification" year, which allows greater opportunity for input. Transportation staff will give a brief overview of the materials shared with the Vision Zero Implementation Committee at their meeting on May 26, 2022 and July 11, 2022; Transportation Commission liaisons to this Committee will also share their thoughts about the meetings. The meetings centered on the deployment of the seven quick build projects which will take place this summer, the development of the speed management program, and a discussion about the Michigan Fitness Foundation on a pedestrian safety education campaign and the underlying data which is guiding this initiative.
