Sustainability & Innovations Corner

- **Ann Arbor Passes Climate Action Millage.** Ann Arbor voters joined a small but growing number of communities to pass a local millage to fund climate action. Through the Community Climate Action Millage, Ann Arborites will invest an estimated \$7 million per year for 20 years to fund local clean energy, waste reduction, energy efficiency, sustainable food, and resilience programs and services.

The newly adopted millage will support programs and initiatives such as:

- Direct rebates for home, rental, and business energy improvements, including rebates for energy waste reduction, renewable energy installations, appliance electrification, and energy storage systems.
- Year-round composting and recycling collection for commercial and multi-family units.
- Renewable energy deployments at affordable housing sites, community centers across the city, and the city's capped landfill.
- Support for resilience centers, local food production and heat and flood preparedness initiatives.
- The installation of more streetlights, crosswalks and protected bike lanes across the city.
- More electric vehicle charging infrastructure and incentives to support multi-modal transportation.

Funding for these programs will be included in the upcoming city budgeting process and be available for expenditure starting July 1, 2023.

Consent Agenda (10). There are ten items on the consent agenda.

Public Hearings (2) – Please see below and under second readings.

- **A Public Hearing and Resolution to Approve the Annexation of Three Parcels of Land Totaling 2.42 acres Associated with North Maple Apartments PUD Site Plan. The Addresses Include 1855 North Maple Road, 1875 North Maple Road, and 1921 Calvin Street. (CPC Recommendation: Approval - 7 Yeas and 0 Nays).** Approval of this resolution will allow annexation of these properties from Scio Township into the city.

Ordinances – Second Readings (1)

- **A Public Hearing and an Ordinance to Amend Chapter 55 (Unified Development Code), Rezoning of 190 Parcels in the W Stadium and N Maple Area to TC1 (Transit Corridor District), City-Initiated Rezoning, (CPC Recommendation: Approval - 6 Yeas and 0 Nays) (ORD-22-16).** Approval of this ordinance will rezone 190 parcels in the West Stadium Boulevard and North/South Maple Road area to TC1.

Ordinances – First Readings (1)

- **An Ordinance to Amend Sections 4:58 and 4:59 of Chapter 49 (Sidewalks) of Title IV (Streets and Sidewalks) of the Code of the City Relative to Responsibility to Repair of Adjacent Sidewalks.** On November 3, 2020, Ann Arbor voters approved a new 4-year Streets, Bridges, and Sidewalks Millage, which replaced a similar millage that ended June 30, 2022. The proposed amendments to Chapter 40 are intended to update the ordinance to match the millage dates (July 1, 2022 through June 30, 2026) in certain provisions that apply to properties in the Downtown Development District.

Other

Natural Area Preservation Workdays and Events in December. Even as winter approaches, Ann Arbor Natural Area Preservation's (NAP) work protecting and maintaining the parks and nature areas continues! And volunteer help is always needed and appreciated. NAP has several events planned for December, including a stewardship workday in honor of World Soil Day and a guided nature walk.
