

AMENDMENT 3

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc. with offices at One Tyler Drive, Yarmouth, Maine 04096 ("Tyler") and the City of Ann Arbor, Michigan, with offices at 301 East Huron Street, Ann Arbor, Michigan 48104 ("Client").

WHEREAS, Tyler and Client are parties to an agreement dated July 3, 2019 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the terms of the Agreement as provided herein.

Subsequent annual Assist Basic fees will be invoiced in accord with the Agreement.
- 2. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
- 3. Except as expressly indicated in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
