Partners in Access: A. Gossage reported L. Keeler and CM A. G. Edwin met and discussed the upcoming meeting with Larua Orta, Director of Operational Equity regarding the hiring of the City Accessibilily/Disability coordinator. CM A. G. Edwin met with Orta to ensure CODI is integrated into policy, decisions and processes in future city initiatives. A. U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE - MATTHEW SOLOMON

M. Solomon provided an update on the Council for Disability Concerns. The council met on January 10, 2023 with a presentation by Jessica McQuade who is the head of a pilot program called LSA Disability Navigators a 3 year pilot, currently in their second year. This program coordinates services for U of M employees who have disabilities. Accessible meeting support is available with offset travel cost for employees needing ADA rooms on site. Their program agenda success was discussed and a overall comprehensive look at U of M with an accessibility lens that ties into Emergency Preparedness. M. Solomon suggested some elements of this model should be considered creating a job description for Accessibility Coordinator and encouraging commissioners to investigate, access then activate. CM A.G. Edwin mentioned she is working on a Disability Ambassador Program.
