Mr. Mendoza,

I've reviewed the email sent to Mr. Landefeld following the PAC meeting and offer the following response. Council certainly is responsible for setting fees and rates throughout the City. Historical Parks offers seasonal discounts and promotional rates, as you've mentioned. They may be reductions on pass rates to groups and seniors or reduced fees for veterans on Veterans Day, staff has worked hard to promote the system and make adjustments where appropriate. Staff never adjusts the rate of a pass or fee above what is established by Council. This practice has been in place for decades and, as you and I discussed on the phone, is currently under review to make sure it is consistent with City Policy and requirements.

I regret that what you went through to receive the discount in 2021, it appears to have been unnecessary. It is my hope that what you experienced was an isolated incident and has been corrected since. I have not received similar concerns so I'm encouraged that it has.

Please find attached, and below, Staff's response to PAC regarding your questions and concerns.

If you have questions regarding this year's pass rates or process please feel free to forward those to staff and we'd be glad to respond.

It's unfortunate that adjustments made this year to season pass holders tee time accessibility, (along with your previous negative experience), inspired you to question the overall system. I am confident that the intent of staff's decisions has always been to promote the system appropriately and improve the experience for all users in an equitable manner. I'm sure we have not always been perfect in that pursuit but I am confident it is and has always been the intent.

Hello PAC,

Here is the response from staff regarding Mr. Mendoza's comments at the February PAC meeting regarding golf passes and other golf related items. There have been a number of issues raised by Mr. Mendoza and staff have looked into them and I hope to address them below.

Listed below are all of the current season (2023) passes available between the two courses. These fees are consistent with the council approved rates set in 2009. While the rates have remained consistent, some operational policies and decisions related to them have varied since 2009. The document that Mr. Mendoza shared shows that the original Senior and Junior rates at Leslie are for Weekdays and Weekends after 4 pm The table below shows the current policy.

Leslie Park Golf Course season pass rates

- **Adult 7-day pass:** \$995, *valid Monday -Friday anytime & weekends after 12PM at both Leslie Park and Huron Hills.
- **Adult 5-day pass:** \$795, *valid Monday through Friday anytime at both Leslie Park and Huron Hills.
- **Senior (60+) 5-day pass:** \$595 *valid Monday through Friday anytime at both Leslie Park and Huron Hills.
- **Junior (17 & under) 5-day pass:** \$395 *valid Monday through Friday anytime at both Leslie Park and Huron Hills.

Please note: 5-day passes will no longer have any weekend playing privileges.

Riding (power cart) membership

For \$500 more, a season pass holder can upgrade their membership to use a riding cart each time they play.

Huron Hills Golf Course Season Passes

- **Adult 7-day pass:** \$695 *Valid 7 days per week at Huron Hills.
This will also get you a discount for your golf carts at \$6 for 9-holes and \$12 for 18 holes at both courses.
- **Adult 5-day pass:** \$595 *Valid Monday through Friday at Huron Hills.
- **Senior (60+) 5-day Plus pass:** \$395 *Valid Monday through Friday and weekends after 2 p.m. at Huron Hills.
- **Junior (17 & under) 5-day Plus pass:** \$100 *plus a play fee of \$2 for each 9-hole round & \$4 for each 18-hole round.

Riding (power cart) Membership: For \$500, a current season pass holder can upgrade their membership to use a power cart each time they play.

The secondary issue raised by Mr. Mendoza is in regard to staff's ability to adjust fees, policies or processes after Council approves fees. Historically, staff have been given discretion to make operational decisions following approval of fees by Council. Some examples of this are adjusting hours of operation, offering promotional discounts or incentives, offering refunds based on experiences, pro-rating fees based on timing and adjusting policies to improve operational and fiscal efficiencies. In most cases, these decisions are made by staff to increase usage at our facilities and as attendance or usage changes, staff have had the ability to abandon certain discounts or fees.

Golf staff have reviewed the passes purchased since 2019 and identified any discounts that have been given. You will find an attached copy of the pass list with discounted passes highlighted to match the summary list below. In many cases, some of these discounts were approved years ago and staff have continued to honor them. A case in point is the

group rate for passes which has been used since before 2009 and was included in the majority of parks programs guides between 2009 and 2020, including the 2017 brochure that is included.

- 350 PASS SALES
- 23 BLUE SALES – Upgrades / additions to passes – carts, additional days
- 20 YELLOW SALES – These are a large group discount that has been publicized in the past. This has historically been \$100 off greens portion of the pass and \$100 off cart portion of the pass. (Something we have been doing in the City since early 2000's)
- 4 PURPLE SALES – Passes sold to ex-City employees, this has currently been stopped
- 3 LIME GREEN SALES – These were discounts off a pass due the to the pass holder paying a Green Fee to play and then deciding they wanted to buy a pass after the round(s).
- 1 GRAY – Junior Pass.
- 15 ORANGE – These are discounts given for prorating the pass due to the time of the year (Dates of sale support proration)
- 10 PINK PASSES – Staff continue to review these passes as they do not fit into any of these other categories.

Additionally, the golf course uses a management system, ForeUp, to manage tee times and passes. This system is a significant upgrade from our previous system, however, as with any management system it has its limitations. The creation of this pass report brought a significant limitation to our attention. We continue to work with ForeUp to improve on the Point of Sale processes along with its reporting.

Another issue raised was regarding resident vs non-resident rates. Over the last number of years, Parks has moved away from non-resident rates in our facilities. This is largely an effort to be more inclusive in our parks and greatly reduce the chance that unconscious biases and microaggressions enter into transactions at a golf course or any other Parks facilities. Additionally, the Business Plan for Golf Operations, presented to City Council in 2007 recommended that “different rates between residents and non-residents are eliminated” to intentionally attract more golfers from outside the community.

Staff are very aware that Council is responsible for setting the fees for our programs. The season passes are the same rates that were approved in 2009 even though there have been changes to the daily rates since that time. Due to the popularity of golf through pandemic, staff proposed and council approved a fee increase for weekend rates in 2020. This decision was based on weekends being in high demand from the general public. The continued demand is why we chose to restrict general passes at Leslie on the weekend before noon, however, Huron Hills is still available during that time.

Staff have taken Mr. Mendoza’s concerns very seriously. In response to the concerns, we are looking deeper into our fees and on course practices and protocols to ensure that we are providing an experience consistent with mission, values and responsibilities as directed by administration and council. Staff have always worked to provide the best experience to the greatest number of users. The decisions made this year and previously have always been to provide excellent customer service and encourage as much usage of the course by the community at large.

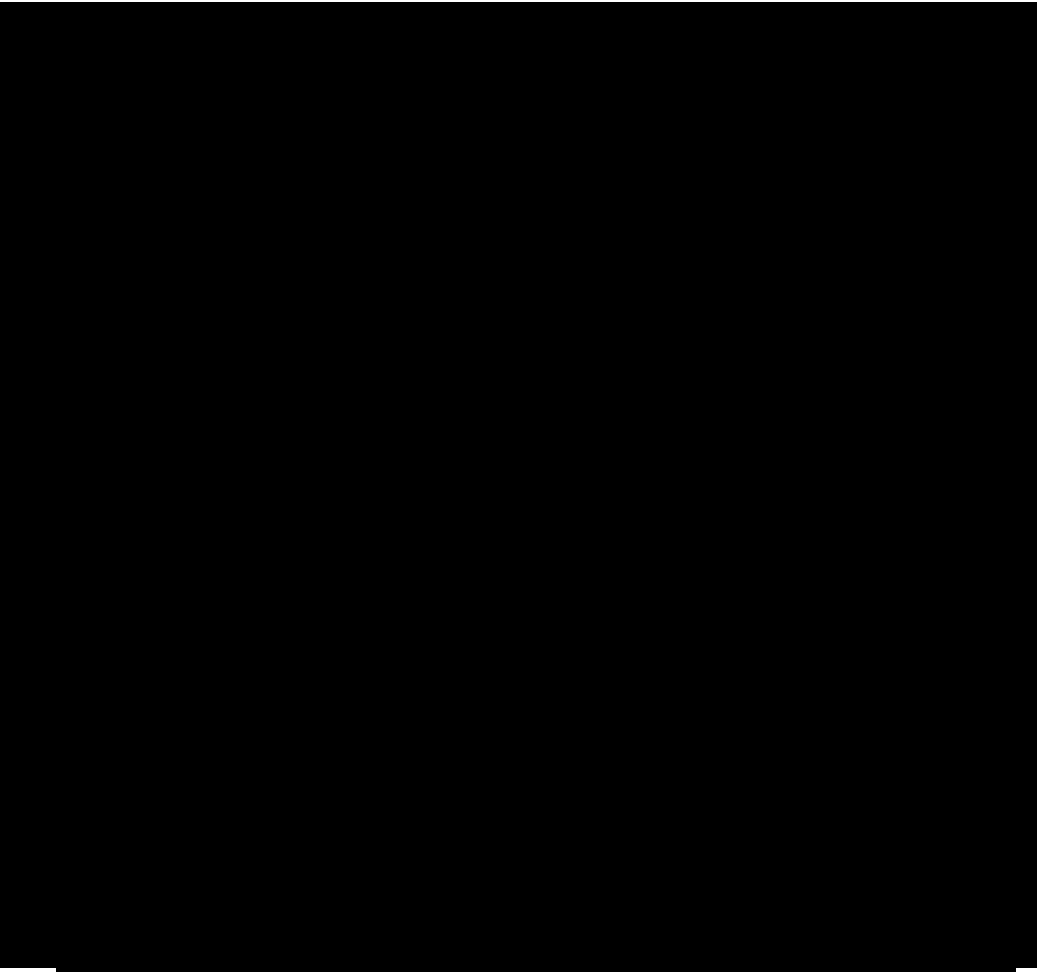

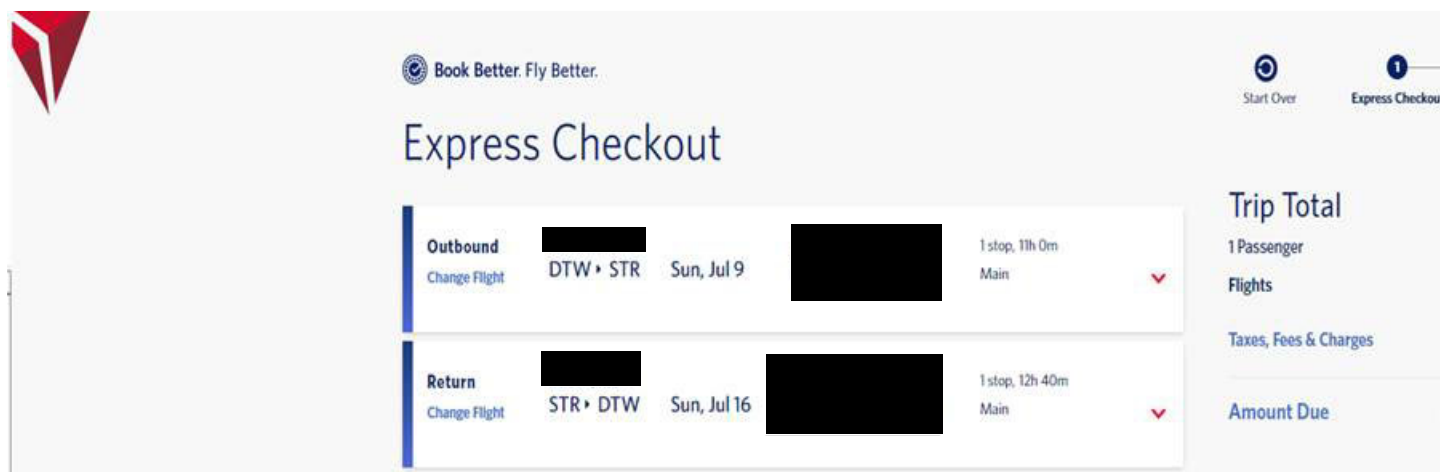

Although the 164 for-sale units will be all-electric, the 320 apartments will have gas furnaces. This should not be acceptable. We're confronting a climate emergency, and we cannot afford to lock in new fossil fuel emissions for decades to come. The A2Zero plan assumes that all new construction will be all-electric and net zero energy, beginning in 2022. This project, as planned, seems to directly violate the city's climate policies.
