CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:11 p.m. in the Washtenaw County Board of Commissioners Room, 220 N. Main Street.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

Mayor Hieftje led Council in the recitation of the Pledge of Allegiance.

- 1. Dennis Hayes Medical Marijuana Ordinance (C-1)

Dennis Hayes, 120 N. Fourth Ave., addressed Council regarding the Medical Marijuana Ordinance. He expressed concerns about the licensing requirements as currently proposed, including confidentiality issues with the prescription and package labeling.

2. Chuck Ream - Medical Marijuana Ordinance (C-1)

Chuck Ream, 1911 Packard St., expressed concern with the medical marijuana licensing ordinance requiring local registration. He expressed concern for the protection of patient privacy.

3. Jonathan Shaheen - Regulations for Parking Lot Snow Plowing

Jonathan Shaheen, City resident, addressed Council regarding the need for regulations for private parking lot snow plow. He stated that it is a great burden on residents if the landlords do not plow the parking lots in apartment complexes. He noted that the City of Ypsilanti has an ordinance that addresses snow plowing in private lots.

4. Douglas Smith - FOIA Appeal

Douglas Smith addressed Council regarding an appeal of the denial of part of a Freedom of Information Act request he made regarding two AAPD reports related to sexual assaults by UM athletes.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER DEREZINSKI

Councilmember Derezinski announced that the City is hosting two informational meetings and a public hearing on the proposed Corridor Improvement Authority on Washtenaw Avenue. The project involves four communities; Ypsilanti City, Ypsilanti Township, Pittsfield Township, and the City of Ann Arbor The first meeting, which is targeted towards business owners on Washtenaw Avenue, is scheduled for February 23, 2011 at Paesano's Restaurant from 7:30 a.m. to 9:00 a.m. The second meeting is scheduled for March 2, 2011 at 7:00 p.m. at Cobblestone Farm and is targeted for City residents. The public hearing will take place at the City Council meeting on March 7, 2011. The public is encouraged to attend all meetings.

COUNCILMEMBER ANGLIN

Councilmember Anglin expressed concern with the City's snowplow efforts after the last snow storm. He said that a number of residents were inconvenienced due to the City's slow response and there should be a better mechanism in place to handle the volume and type of snow that fell during the last storm. He also expressed concern with the plow trucks throwing huge amounts of show back into citizen driveways.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

SNOW REMOVAL

City Administrator Roger Fraser read a report from staff regarding the recent snowfall. The report explained that the City has 14 large snow plow trucks, two of which were down at the start of the last storm. Mr. Fraser noted that the City's smaller equipment does not have the capability to move the volume and weight of snow that fell during this last event and is used primarily to clean up areas that large plows have already cleared. Mr. Fraser also stated that this reason storm brought more snow than what was anticipated. City crews began Sunday morning with a pre-treatment at 10 a.m. in expectation of 1-2 inches of snow and ice accumulation. The amount of snow that fell was more than expected and was the heaviest in weight to date.

GOVERNOR'S BUDGET PROPOSAL

Mr. Fraser said questions were raised regarding the governor's budget proposal and the suggestion that revenue sharing be dramatically changed. Revenue sharing comes in two different forms. There are two types of revenue sharing from the State, a portion that is constitutional and a separate statutory portion.

The governor is recommending that the statutory portion be eliminated. Currently, Ann Arbor is expected to receive approximately \$1.9 million in statutory revenue sharing. The governor's proposal would eliminate approximately 30% of the statutory portion. The remainder of the funds would be placed in a pool and awarded to cities based on their innovation, collaboration and demonstrated abilities to better serve their communities more efficiently. The governor is also calling for a reduction in the Fire Grant Program and Ann Arbor could lose \$165,000.00 through that cut as well.

WATER EVENT IN CITY HALL

Mr. Fraser updated Council regarding the recent flooding in the Larcom City Hall basement. He stated a pipe froze during the ongoing construction and burst over the weekend, flooding the basement. The frozen pipe was the contractor's responsibility and the damage and repair to the newly remodeled basement will be at the contractor's expense, not the City. However, Mr. Fraser noted that the clean-up and repair will delay the construction and relocation of staff by approximately one month. Police Patrol Services will likely remain at the Wheeler Center for another month as the police locker rooms are located in the Larcom basement and were affected by the flood.
