What Is a franchise

* Franchise

A contract between a local unit of government and a utility that:


- Governs the use of the public rights of way
- Sets the conditions under which the company may, for a set period, provide the specified utility service

Franchises can also include additional terms and several local governments across the country (e.g., Chicago, Salt Lake City, and San Diego) have successfully advanced affordability, equity, and clean energy goals via franchise negotiations while optimizing use of the public rights of way.

- Adopted in 1997
- 30-year franchise
- Traditional franchise
- Expires in 2027
- Revocable at will

- Need a franchise to provide a utility service
- Looking to integrate resident's desires for clean, safe, healthy, affordable, and reliable heat into any future franchise(s).



What we've done to-date

- Reviewed other city franchises
- Spoke with peers around the nation
- Reviewed our previous franchise
- Spoke with staff about opportunities for enhancement
- Began identifying other cities and utilities working on projects that advance safe, healthy, clean, and affordable heating solutions
- Council adopted a resolution directing
 Administrator to start negotiating a new franchise
- Launched educational website

On March 20, 2023, Ann Arbor City Council <u>passed a resolution</u> directing the administrator to negotiate a new heating franchise with interested providers to initiate a responsible, careful transition to renewable energy choices for heat in Ann Arbor.

The City of Ann Arbor's methane gas franchise with a subsidiary of DTE is set to expire in 2027; so the time is now to chart a future toward our A²ZERO goal of becoming carbon neutral by 2030 and heating our homes and businesses with safe, clean, healthy, and reliable energy.


1. How does the fossil gas franchise relate to the City of Ann Arbor's work to reduce carbon emissions and increase renewable energy for heating?

The Ann Arbor City Council passed a resolution on March 20, 2023 calling on the City Administrator to begin negotiations with DTE, and potentially other interested providers, to facilitate a careful transition of heating services to renewable, sustainable and cleaner sources of energy.

We are taking this action because Ann Arbor residents are demanding energy that is affordable, clean, reliable, safe and healthy, and we need our utility providers to be aligned with that future.


