Matt,

I agree with Ilene's comment, why max 10,000 sf instead of 8,500 sf? That seems too large.

I had just a few other comments:

- 1. Non-conformance, page 2, third bullet point. Who will establish the time limit on the building construction? We don't want construction to start and then stall for months and months with an uncompleted house. Can we recommend a time limit for completed construction?
- 2. Analysis, page 2, 1st paragraph, last sentence, maybe add the phrase in bold: If these structures...to zoning standards, with respect to lot size and set back only, in effect...
- 3. R4C Districts/Rezoning, page 3, paragraph 2: you might want to include the date of the original City Central Area Plan, Dec. 1992. It has been almost 19 years since these areas were identified in the 1992 plan as areas that "should be rezoned for lower density residential use". While it is impossible to predict what would have happened to the properties in the Hoover/Davis and Dewey/Packard/Brookwood areas if the zoning recommendation had been implemented when the recommendation was made, it is worth speculating: there were fewer students enrolled at the UM, a smaller demand for housing, and so perhaps less pressure for homes to be converted student housing. If the zoning had been changed to R2A at that time, many of the existing large structures and 6 bedroom home conversions might not have occurred.

- 4. Minor point, page 4, in first paragraph you mention there are 1,978 parcels and in the third paragraph the number is 1,970 lots. Which number is correct?
- 5. Key Features, page 8, perhaps add this additional bullet point:
 - Preserves open space and perhaps eliminates the conversion of side and/or back yards into parking lots.





CALLING ON THE PRESIDENT TO WORK WITH LEADERS OF OTHER NUCLEAR WEAPON STATES FOR ELIMINATION OF NUCLEAR WEAPONS BY 2020 AND CALLING ON CONGRESS TO CUT FUNDING FOR NUCLEAR WEAPONS AND TO REDIRECT THOSE FUNDS TO MEET THE NEEDS OF CITIES

WHEREAS, more than two decades after the end of the Cold War, nearly 23,000 nuclear weapons, over 95% of them in the arsenals of the United States and Russia, continue to pose an intolerable threat to cities and people everywhere;

WHEREAS, recent studies have shown that a nuclear war involving no more than 100 Hiroshimasized bombs—about 0.3% of the global nuclear arsenal—could have catastrophic, long-lasting effects on the global climate leading to a drop in average surface temperatures, reduction of the ozone layer, a shortened agricultural growing season resulting in a global famine of unprecedented proportions;

WHEREAS, the 2010 U.S. Nuclear Posture Review did not lead to substantial changes in the U.S. nuclear force structure, only marginally reduced the role of nuclear weapons in national security policy, explicitly rejected reducing the high-alert status of Intercontinental Ballistic Missiles and Submarine Launch Ballistic Missiles, and retained the capability to deploy U.S. nuclear weapons on tactical fighter-bombers and heavy bombers, including at NATO bases in Europe, while proceeding with a modification of the bombs carried on those planes;

WHEREAS, a plan submitted to Congress by President Barack Obama projects investments of well over \$185 billion by 2020 to maintain and modernize U.S. nuclear weapons systems, including construction of three new nuclear warhead production facilities and an array of new delivery systems;

WHEREAS, although the U.S. stockpile contains one-fifth as many warheads as it used to, the Administration's Fiscal Year 2012 budget request is the largest ever for maintenance and modernization of nuclear warheads, and after accounting for inflation, the \$7.63 billion request is 21 percent more than President Ronald Reagan's largest nuclear weapons budget;

WHEREAS, reflecting President Obama's commitment to modernize all three legs of the strategic triad of nuclear weapons delivery systems, the FY 2012 budget request also includes \$197 million for research and development on a new Air Force long-range nuclear bomber, \$2.6 million to study a future Intercontinental Ballistic Missile, and \$1.07 billion to develop a new replacement ballistic missile submarine slated to be in operation through 2080, all of which will lead to far greater expenditures if production follows;

WHEREAS, with the economic downturn forcing mayors and cities to make deep cuts in critical public services, and with more than 100 metropolitan areas projected to have double-digit unemployment by the end of this year, the budget deal worked out between the Administration and Congress contains a 16.2 percent reduction in Community Development Block Grant formula funding – a \$647 million cut for the current year, eliminates Energy Efficiency and Conservation Block Grants, and includes huge reductions to other domestic programs of importance to mayors and cities, the size of which have not been seen in recent times;

WHEREAS, Mayors for Peace membership has grown to over 4,700 cities in 150 countries and regions, including half of the world's capital cities, with more than 170 U.S. members;

WHEREAS, the United States Conference of Mayors unanimously adopted resolutions in 2004, 2006 and each year since, expressing its strong support for Mayors for Peace, its demand for negotiations for the global elimination of nuclear weapons by 2020, and its Cities Are Not Targets campaign;

WHEREAS, Mayors for Peace has been endorsed by national mayoral associations in Europe, Latin America, Asia and Africa;

WHEREAS, the final document of the 3rd Congress of United Cities and Local Governments, adopted in Mexico City November 20, 2010 expresses "our support for the call of the Mayors for Peace Campaign for a world free of nuclear weapons by 2020 through a new international Convention";

WHEREAS, United Nations Secretary-General Ban Ki-moon, in Hiroshima for the 65th anniversary of the U.S. atomic bombing on August 6, 2010 expressed his strong support for the Mayors for Peace 2020 Vision Campaign for the global abolition of nuclear weapons by 2020, declaring, "The 2020 vision is a perfect vision"; and the United Nations, on March 24, 2011 recognized the importance of Mayors for Peace by inaugurating a permanent installation at its New York headquarters exhibiting more than 1 million signatures on the Mayors for Peace Cities Are Not Targets petition;

NOW, THEREFORE, BE IT RESOLVED, that the U.S. Conference of Mayors reaffirms its call on President Obama to work with the leaders of the other nuclear weapon states to implement the United Nations Secretary-General's Five Point Proposal for Nuclear Disarmament forthwith, so that a Nuclear Weapons Convention or a related framework of mutually reinforcing legal instruments can be agreed upon and implemented by the year 2020, as urged by Mayors for Peace; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors calls on the U.S. Congress to terminate funding for modernization of the nuclear weapons complex and nuclear weapons systems, to slash spending on nuclear weapons programs well below Cold War levels, and to redirect those funds to meet the urgent needs of cities; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors, in its contacts with national associations of local authorities of the other nuclear weapon states, calls upon them to also press their governments to enter into negotiations for the establishment of a nuclear-weapon-free world and to sharply curtail expenditures on nuclear arms; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors expresses its continuing support for Mayors for Peace, pledges to assist in recruiting new U.S. members in order to help reach the goal of 5,000 member cities by the August 6, 2011 Hiroshima anniversary, at which time Mayors for Peace will represent one billion people; and, as since 2005, supports USCM representation at the international Mayors for Peace 2020 Vision Campaign Executive Committee and General Meetings later this year; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors agrees to take up this matter at its 80th Annual Meeting in June 2012, and that mayors shall remain engaged in this matter until our cities and citizens, and cities and citizens throughout the world, are no longer under the threat of nuclear annihilation and catastrophic climate change.

WHEREAS, recent studies have shown that a nuclear war involving no more than 100 Hiroshima-sized bombs—about 0.3% of the global nuclear arsenal—could have catastrophic, long-lasting effects on the global climate leading to a drop in average surface temperatures, reduction of the ozone layer, a shortened agricultural growing season resulting in a global famine of unprecedented proportions;

WHEREAS, the 2010 U.S. Nuclear Posture Review did not lead to substantial changes in the U.S. nuclear force structure, only marginally reduced the role of nuclear weapons in national security policy, explicitly rejected reducing the high-alert status of Intercontinental Ballistic Missiles and Submarine Launch Ballistic Missiles, and retained the capability to deploy U.S. nuclear weapons on tactical fighter-bombers and heavy bombers, including at NATO bases in Europe, while proceeding with a modification of the bombs carried on those planes;

WHEREAS, a plan submitted to Congress by President Barack Obama projects investments of well over \$185 billion by 2020 to maintain and modernize U.S. nuclear weapons systems, including construction of three new nuclear warhead production facilities and an array of new delivery systems;

WHEREAS, although the U.S. stockpile contains one-fifth as many warheads as it used to, the Administration's Fiscal Year 2012 budget request is the largest ever for maintenance and modernization of nuclear warheads, and after accounting for inflation, the \$7.63 billion request is 21 percent more than President Ronald Reagan's largest nuclear weapons budget;

WHEREAS, reflecting President Obama's commitment to modernize all three legs of the strategic triad of nuclear weapons delivery systems, the FY 2012 budget request also includes \$197 million for research and development on a new Air Force long-range nuclear bomber, \$2.6 million to study a future Intercontinental Ballistic Missile, and \$1.07 billion to develop a new replacement ballistic missile submarine slated to be in operation through 2080, all of which will lead to far greater expenditures if production follows;

WHEREAS, with the economic downturn forcing mayors and cities to make deep cuts in critical public services, and with more than 100 metropolitan areas projected to have double-digit unemployment by the end of this year, the budget deal worked out between the Administration and Congress contains a 16.2 percent reduction in Community Development Block Grant formula funding – a \$647 million cut for the current year, eliminates Energy Efficiency and Conservation Block Grants, and includes huge reductions to other domestic programs of importance to mayors and cities, the size of which have not been seen in recent times;

WHEREAS, Mayors for Peace membership has grown to over 4,700 cities in 150 countries and regions, including half of the world's capital cities, with more than 170 U.S. members;

WHEREAS, the United States Conference of Mayors unanimously adopted resolutions in 2004, 2006 and each year since, expressing its strong support for Mayors for Peace, its demand for negotiations for the global elimination of nuclear weapons by 2020, and its Cities Are Not Targets campaign;

WHEREAS, Mayors for Peace has been endorsed by national mayoral associations in Europe, Latin America, Asia and Africa;

WHEREAS, the final document of the 3rd Congress of United Cities and Local Governments, adopted in Mexico City November 20, 2010 expresses "our support for the call of the Mayors for Peace Campaign for a world free of nuclear weapons by 2020 through a new international Convention";

WHEREAS, United Nations Secretary-General Ban Ki-moon, in Hiroshima for the 65th anniversary of the U.S. atomic bombing on August 6, 2010 expressed his strong support for the Mayors for Peace 2020 Vision Campaign for the global abolition of nuclear weapons by 2020, declaring, "The 2020 vision is a perfect vision"; and the United Nations, on March 24, 2011 recognized the importance of Mayors for Peace by inaugurating a permanent installation at its New York headquarters exhibiting more than 1 million signatures on the Mayors for Peace Cities Are Not Targets petition;

NOW, THEREFORE, BE IT RESOLVED, that the U.S. Conference of Mayors reaffirms its call on President Obama to work with the leaders of the other nuclear weapon states to implement the United Nations Secretary-General's Five Point Proposal for Nuclear Disarmament forthwith, so that a Nuclear Weapons Convention or a related framework of mutually reinforcing legal instruments can be agreed upon and implemented by the year 2020, as urged by Mayors for Peace; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors calls on the U.S. Congress to terminate funding for modernization of the nuclear weapons complex and nuclear weapons systems, to slash spending on nuclear weapons programs well below Cold War levels, and to redirect those funds to meet the urgent needs of cities; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors, in its contacts with national associations of local authorities of the other nuclear weapon states, calls upon them to also press their governments to enter into negotiations for the establishment of a nuclear-weapon-free world and to sharply curtail expenditures on nuclear arms; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors expresses its continuing support for Mayors for Peace, pledges to assist in recruiting new U.S. members in order to help reach the goal of 5,000 member cities by the August 6, 2011 Hiroshima anniversary, at which time Mayors for Peace will represent one billion people; and, as since 2005, supports USCM representation at the international Mayors for Peace 2020 Vision Campaign Executive Committee and General Meetings later this year; and

BE IT FURTHER RESOLVED, that the U.S. Conference of Mayors agrees to take up this matter at its 80th Annual Meeting in June 2012, and that mayors shall remain engaged in this matter until our cities and citizens, and cities and citizens throughout the world, are no longer under the threat of nuclear annihilation and catastrophic climate change.

Nuclear Weapons at What Cost?

It is nearly impossible to calculate total annual U.S. spending on nuclear weapons in a consistent manner. As explained by the Federation of American Scientists: "Most U.S. Government spending on nuclear weapons-related programs is unclassified. But it is functionally secret since such spending is widely dispersed across many programs in several agencies and it is not formally tracked or reported." Further complicating the calculation is determining the scope of programs functionally intertwined with the most obvious ones: research, development, testing and production of nuclear warheads and their delivery systems.

According to an analysis by the Carnegie Endowment, the U.S. spent over \$52 billion in FY 2008 for nuclear weapons and related programs. This includes nuclear forces and operational support, deferred environmental and health costs, missile defense, nuclear threat reduction, and nuclear incident management. It does not include classified programs, air defense, anti-submarine warfare, or nuclear weapons related intelligence programs.

Obama's Nuclear Weapons Budget

His nuclear disarmament rhetoric not withstanding, on May 13, 2010, at the midpoint of the Nuclear Non-Proliferation Treaty Review Conference, in connection with submission of the new START U.S. – Russia nuclear arms reduction treaty to the Senate, President Obama submitted a classified report on a Congressionally-mandated plan to maintain and modernize U.S. nuclear forces for the foreseeable future. According to a White House fact sheet: "The plan includes investments of \$80 billion to sustain and modernize the nuclear weapons complex...." and "well over \$100 billion in nuclear delivery systems to sustain existing capabilities and modernize some strategic systems" by the year 2020.

A second White House fact sheet, released November 17, 2010, <u>An Enduring Commitment to the U.S. Nuclear Deterrent</u>, increased the amount projected "to modernize the U.S. nuclear weapons complex that supports our deterrent," to "more than \$85 billion over the next decade."

In testimony before the House Armed Services Subcommittee on Strategic Forces on March 2, 2011, Dr. James Miller, Principal Deputy Under Secretary of Defense for Policy increased the numbers again, stating: "The Administration's FY2012 budget reflects our commitment to the modernization of our nuclear arsenal for the long term, including some \$125 billion over the next ten years to sustain our strategic delivery systems, and about \$88 billion over the same period to sustain our nuclear arsenal and modernize infrastructure."

Unprecedented Nuclear Weapons Spending

Calling it an "unprecedented investment in ensuring the nuclear security of our country and our allies," Thomas D'Agostino, Administrator of the National Nuclear Security Agency (NNSA), a semiautonomous division of the Department of Energy, on February 16, 2011 <u>declared</u>: "Despite the economic challenges facing our nation and the budget pressures being felt throughout the federal government, the President demonstrated his commitment to our mission by proposing an unprecedented investment in ensuring the nuclear security of our country and our allies." The President's FY 2012 budget request includes over \$7.6 billion for programs directly related to nuclear warheads. <u>As stated in the official budget document</u>: "The Weapons Activities request is an increase of 8.9 percent over the President's FY 2011 Request. This level is sustained and increased in the later out years."

The FY 2012 request includes increased funding for three new nuclear weapons production plants: the Chemistry and Metallurgy Research Replacement building, a new plutonium "pit" manufacturing facility at the Los Alamos Lab in New Mexico; the Uranium Processing Facility, a production facility for thermonuclear components under construction at the Oak Ridge National Lab in Tennessee; and a replacement for the Kansas City Plant in Missouri, where NNSA manufactures most nonnuclear nuclear weapon components. The 2012 budget request also includes "Life Extension Programs" (rebuilds) for three warhead types including the B61 warhead, a U.S. bomb still deployed at NATO bases in Europe.

According to Dr. Robert Civiak, former Program Examiner for Department of Energy nuclear security activities at the federal Office of Management and Budget: "Even though the U.S. stockpile contains only one-fifth as many warheads as it used to, the 2012 request is the largest ever for Weapons Activities. After accounting for inflation, the \$7.63 billion request is 21 percent more than Ronald Reagan's largest nuclear weapons budget and 19 percent more than President George H.W. Bush's highest spending level."

The Department of Energy budget covers only nuclear warheads. In addition, in response to the Department to modernize all three legs of the "strategic triad" of nuclear weapons delivery systems, the Department of Defense FY 2012 budget request includes \$197 million for research and development on a new Air Force long-range bomber that would be ready for fielding in the mid-2020s. In all \$3.7 Billion is slated to be spent in developing this nuclear-capable aircraft over the next five to six years. On January 6, 2011 Defense Secretary Robert Gates announced that the Air Force would begin development of this new nuclear-capable strategic bomber, which can be remotely piloted. At present, there are no nuclear capable "drones" in the U.S. arsenal. Plans are for 80 to 100 of these aircraft to be built.

<u>The Pentagon budget request</u> also includes \$2.6 million to study a future Intercontinental Ballistic Missile and \$1.07 Billion to develop a new ballistic missile submarine to replace today's Ohio-class vessels.

Nuclear Weapons Forever?

On May 9, 2011, House Armed Services Committee Chairman Buck McKeon released details about H.R. 1540, the National Defense Authorization Act for FY 2012. The chairman's "mark" of the annual defense authorization bill would fully fund NNSA at the President's requested levels. The document also reveals the long planning horizon for nuclear weapons, specifying, "The planned Ohio-class ballistic submarine replacement is expected to be in operations through 2080."

A 1998 study by the Brookings Institution found, as a conservative estimate, that the U.S. spent \$5.5 Trillion dollars on nuclear weapons from 1940–1996 (in constant 1996 dollars). Nuclear weapons spending during this period exceeded the combined total federal spending for education; training, employment, and social services; agriculture; natural resources and the environment; general science, space, and technology; community and regional development, including disaster relief; law enforcement; and energy production and regulation.

Nuclear weapons have threatened human security since they were used by the United States against Japan nearly 66 years ago. In a time of unprecedented global economic, environmental and political upheaval, can we afford to pay for them for another 70 years, hoping they won't be used again?

Dear Mayor Hieftje,

I understand that the DDA intends to proceed with a bond issue to build a subterranean parking structure for Village Green Apartments at First and Washington Streets.

At this time a coupon rate of 5.5%, similar to the library parking lot bond issue, can be anticipated for the \$9 million bond issue. Therefore, calculating the interest payments and allowing for a bond sinking fund (assuming maturation in 20 years), the annual bond servicing expense to the DDA calculates to \$945.000.

If every parking space in the new structure is used every hour of every chargeable day then parking fees from the additional 244 parking spaces will generate only \$884,256. But experience indicates that Ann Arbor's parking spaces are used only an average of 50% of chargeable time, so the newly generated parking revenue will more likely be \$442,128. How will the DDA cover a shortfall of \$502,872 required by the bond issue servicing?

Presently, the DDA is projecting deficit spending largely because of the recently added responsibility of servicing the bond issue for the partially constructed library parking structure which drains about \$5,145,000 a year. (BTW, the 670 parking spaces planned for the new library parking structure will only generate \$1,214,040 annually assuming half occupancy as has been the experience.)

How does the DDA expect to finance the bond servicing for the Village Green parking structure? I am sure the voters in Ann Arbor do not want another millage nor an income tax.

Furthermore, building the parking structure for Village Green should be considered a "gift" to the private enterprise. Whether the DDA can do this and allow Village Green to use parking spaces in the lot as its own presents a legal question, especially if the bond issue has tax preference.

City Council members and yourself should convince the DDA that using a bond issue to finance the parking structure for Village Green Apartments is not in the city's best financial interest and the offer should be withdrawn. If the Village Green developer can not proceed without the assistance of the DDA then the project should not progress. The prospects are poor that the Village Green Apartments will be a successful venture anyway.

Mr. Stanton reports that the DDA will issue \$9 million in municipal bonds in order to finance the construction of a 244 car 4-story underground parking structure which is part of the Ann Arbor City Apartments plan.

My wife and I are concerned that the bond issue may be a financial burden for Ann Arbor residents. We will appreciate your comments on our financial analysis of the bond costs, and your opinion regarding the financial risks adopted by the city through the DDA's floating of the bonds.

We presume the \$9 million bond issuance will have a coupon rate of 3.9% which will be identical to the coupon rate for the \$49.3 million dollar underground library-parking-structure bond issuance. Thus, the DDA will have to pay bond holders a total of \$351,000 each year as interest. In addition, the DDA must have a sinking fund and contribute \$450,000 yearly in order to retire the bonds when they mature in 20 years. Therefore, the DDA must obtain a total of \$801,000 each year in order to properly service the bond issue. (After 20 years the DDA will have spent \$16,020,000 for the bond issuance.)

Where will the DDA find the \$801,000 each year in order to service the bonds?

Also, can the DDA's financing of the Ann Arbor City Apartments parking facility be considered a subsidy to the developers? Do municipal bond laws allow the DDA to issue bonds that benefits a private enterprise?
