#### WS-3 Council discussion of candidates

Scott Riley of Affion Public spoke to Council about feedback he had received from the service area administrators regarding the two City Administrator candidates. Mr. Riley stated that the administrators felt that Ms. Oppenheim was articulate and a good communicator with a very diverse background. He stated she was described as high-energy and results-oriented.

*Mr.* Riley stated the service area administrators liked that *Mr.* Powers was very specific in his interview answers, providing specific thoughtful examples to the questions. He was described as having a good communication style, a team-builder and a facilitator. The administrators liked that *Mr.* Powers had experience working in the Michigan economic climate.
