Dear Members of the Ann Arbor Design Review Board:

The Downtown Design Guidelines Citizen's Review Committee is an independent group representing eight near-downtown residential neighborhood organizations. Formed in 2009, we worked with Mayor and Council to set up the Mayor's Downtown Design Review Task Force in 2010. Two of our members, Norm Tyler and Peter Pollack, were members of that Task Force. In 2011 we were pleased to support City Council's unanimous adoption of the Design Guidelines process.

Our members were present at the first Design Review Board meeting this June when you presented your advisory comments to the "Varsity" developers at 425 East Washington. We have been involved in every public meeting related to the Varsity proposal ever since.

The "Varsity" project goes before City Council for approval this week. On Wednesday, November 16, the Design Review Board will meet to discuss the newly proposed project at 618 South Main Street. We believe this new project presents an opportunity to incorporate changes to improve the design review process.

The Design Review Board recommendations are intended to educate developers, architects, planners and the entire community on possibilities for improving the design of new downtown buildings. That goal is helped when comments by Design Review Board members are related to specific design guidelines during the Board meeting. We believe Planning Staff did a good job of doing this in their "Summary of Priority Issues," which was included in the Planning and Development Services Staff Report for the Planning Commission public hearing in September.

However, it would help all of us if the design guidelines learning process begins during the Design Review Board meeting and if the "Summary" is easily available as soon as possible after that meeting. Those who attend the required Citizen's Participation meeting that follows the Design Review Board meeting would benefit from these comments from professionals.

Another group that would benefit tremendously from this change would be the Planning Commission itself. In the case of the "Varsity" project, Planning Commission members

seemed uninformed about Board comments even though the Board's comments were part of their packet at the public hearing. We believe a thorough discussion of the specific design elements should be a part of the discussions of the Planning Commission and the City Council before downtown projects are approved.

We are looking forward to the Design Review Board's discussion of the 618 S. Main project, with specific references to the project's compliance with the Design Guidelines, and hope that the Board's summary will have the earliest and widest possible distribution, including to the Planning Commission, City Council and to the public. Inclusion of the Board's Design Guidelines review in discussions and deliberations will help realize the thinking that led to the unanimous adoption of the Design Guidelines and Design Review Board process, will serve to educate our citizens about the city's Design Guidelines, and ideally will lead to development that maintains the integrity of our cityscape.

Hi Sabra.

I'm still uncomfortable with the wording of the pedestrian ordinance.

- Only pedestrians or others using the crosswalk can "enter" it. Vehicles "pass through" crosswalks. Better language might be "...the driver of the vehicle shall stop "before proceeding through the crosswalk...." or "....shall stop before reaching the crosswalk....", or "....shall "not breach the crosswalk".
- "... and shall yield the right-of-way to every pedestrian who is stopped at the curb or ramp leading to the crosswalk and who appears prepared to cross the street. Vehicles must stop from all directions for every pedestrian present in any portion of the crosswalk even if the vehicle can pass through the crosswalk without impeding the progress of the pedestrian."

I feel like this language is a little clearer. It appears that we are trying to use as few words as possible in the ordinance, but in doing do, we don't adequately convey the intent.

I hope this is helpful.

NEW YORK, NY- NAACP President Benjamin Todd Jealous and 1199SEIU President George Gresham joined civil rights leader Rev. Al Sharpton, National Urban League President Marc Morial, Hispanic Federation President Lillian RodrÃ-guez López, United Federation of Teachers President Michael Mulgrew, President of the New York Civil Liberties Union President Donna Lieberman, Asian-American Legal Defense & Education Fund Executive Director Margaret Fung and others today at City Hall to announce the "Stand for Freedom" voting rights campaign. The coalition of nearly 20 groups also announced plans for a major mobilization on December 10th - United Nations Human Rights Day - to protest the attack on voting rights throughout the country.

Stand for Freedom is an aggressive nationwide effort to stop changes to state election laws that would suppress the rights of millions of Americans to vote in 2012 and beyond.

"We are in the midst of the greatest coordinated legislative attack on voting rights since the dawn of Jim Crow," said Jealous. "Voter ID laws are nothing but reincarnated poll taxes and literacy tests, and ex-felon voting bans serve the same purpose today as when they were created in the wake of the 15th Amendment guaranteeing ex-slaves the vote- suppressing voting numbers among people of color."

"The so-called problem of voter fraud is a myth, the percentage is miniscule," said George Gresham, President of 1199SEIU. "These new laws are suddenly being pushed after the historic 2008 presidential election when Americans headed to the polls in droves. Now as we prepare for the

2012 elections, it's difficult to believe that this isn't some kind of ploy to keep poor people, working people, or people of color away from the polls."

In dozens of states, new rules will create a modern-day poll tax by requiring voters to obtain and present official photo ID in order to cast a ballot. In many of these same states, new laws significantly cut early voting and Sunday voting opportunities as well.

"National Action Network and I see the assault on voters with Voter ID laws, the end of early voting, and other measures as a blatant attempt to undermine the Voter Rights Act," said Rev. Al Sharpton, President, National Action Network. "The Nation cannot honor Dr. King and undo his work at the same time. We will fight it in the courts and in the streets."

"From the beginning of our nation's founding, Americans have understood that voting was fundamental to their pursuit of freedom and equal opportunity," said Lillian RodrÃ-guez López, President of the Hispanic Federation. "Any attempt to undermine the right to vote, especially when that effort is directed at historically marginalized groups, must be treated as an attack on the very ideals that created our country: democracy and equality. And that is why we stand up for freedom and continue to fight for the right to vote for all Americans."

African-Americans, Latinos, Asian Americans, Native Americans, seniors, students, working women and immigrants will be disproportionately affected by the new laws, since many in these communities are less likely to have identification that complies with these strict rules.

"These block the vote efforts are a response to two factors: the unprecedented levels of political participation in 2008 by voters of color, and significant growth by communities of color, as reflected in the 2010 Census," concluded John Payton, LDF President and Director-Counsel. "This is a call to action for us to empower those communities to confront and to overcome this voting rights assault."

While voters in some states can request free photo IDs from state motor vehicles departments, they must still pay to obtain underlying documents, such as birth certificates, necessary to get the photo ID, possibly discouraging them from voting as a result.

"Now, just as before, they are seeking to block us from voting in order to make it easier to come after our other rights," Said Mike Mulgrew, President of the United Federation of Teachers. "Everything we care about is at stake, from the right to a quality education to the right to a fair wage."

"We are standing up for the fundamental pillar of our democracy," said Judith Browne-Dianis, Co-Director of the Advancement Project. "Election Day is the one time we are all equal in America- rich or poor, black, Latino, Asian, Native American or white, young or old, we can all cast an equal vote to determine the shape of our government. Next year, millions of people could be barred from the voting booth. We cannot allow our rights to be stolen."

"Instead of getting in the way of civic engagement, we should be working together to encourage all Americans to exercise their right to vote," said New York Civil Liberties Union Executive Director Donna Lieberman.

Supporters of the new legislation, which according to The New York Times has advanced in 13 states over the past two months, claim the new rules prevent voter fraud, but opponents contend they create roadblocks to deter voters.

Rafael Collazo, Campaign Political Director for the National Council of La Raza (NCLR), added "It's just plain dishonest to claim that you are cutting back the days people can early vote or eliminating them entirely to cut down on fraud- there's just no link between the two and we cannot allow the proponents of these laws to continue using false arguments with the American people."

According to a report recently released by the Brennan Center for Justice, at least 38 states are considering or have considered voter ID and/or proof of citizenship laws including: New York, New Jersey, Connecticut and Delaware.

The battleground states of Ohio and Pennsylvania were among those actively moving forward on voter ID legislation.

Hazel Dukes, President of the NAACP NYS Conference, added, "It is truly disheartening to see that nearly 50 years after passage of landmark Civil Rights legislation, our nation has not fully embraced the idea of change and equality. The enactment of these state election laws is

a reflection of a troubled past that we are forced to relive, and will only continue to impede progress of America and its people."

National Urban League President Marc Morial contended, "Attacks on voting rights are nothing short of attacks on democracy itself. We join with the NAACP in standing for freedom to resist these systemic attacks on voting rights."

"For nearly a century, there were Jim Crow laws in place that discouraged people of color from voting, said Wade Henderson, President of the Leadership Council on Civil and Human Rights. "Today, there are different laws, but the objective is the same-to prevent millions from exercising their right to vote."

UC Berkeley Riot Police Use Batons to Clear Students from Sproul Plaza

The unarmed 'Occupy Cal' protesters were ousted from their encampment late Wednesday, but regrouped for a mass rally and sit-in

In iconic Sproul Plaza, many hundreds or perhaps thousands of UC Berkeley students and Occupy Oakland activists clashed with university police late into the night Wednesday, after officers carried out instructions from administrators to clear Occupy Cal protesters from their makeshift encampment. "We formed a human barricade around our tents, and they just beat their way through it with batons," said one student. "It really, really hurt - I got the wind knocked out of me," another protester, doctoral student Shane Boyle, told the San Francisco Chronicle, showing the reporter a red welt on his chest. "I was lucky I only got hit twice," he added.

"After warning protesters that camping at the university is illegal, officers moved in and shoved demonstrators out of the way as they pushed toward the camp," the Contra Costa Times reported. "Six UC Berkeley students and an associate professor were arrested; charges included resisting officers and failing to disperse." The police succeeded in clearing away tents, but protesters refused to leave the plaza, insisting that they'd camp there with or without equipment. Protesters with smartphones took turns webcasting video from the scene, and ultimately voted around 1 am to approve a University of California-wide general strike to be held Tuesday of next week.

It took a couple hours to settle on that plan. Around 11:30 pm, students were massed in the plaza shouting at perhaps a couple hundred officers.

Quoth one chant, "Your families will see this."

Only afterward did they begin deliberating en masse.

The scene played out in a space most famous as ground zero during the 1964 Free Speech Movement. Sproul Plaza has since seen anti-Vietnam War sit-ins, anti-apartheid rallies, anti-Iraq War protests, and any number of smaller activist gatherings. A stroll through the plaza on an average day when school is in session is as colorful a scene as there is on campus, as student groups advertise, activists hand out leaflets, and nearby drum circles beat away.

The Daily Cal explains what precipitated the day's events:

The campuswide day of action in support of affordable higher education and the Occupy movement has grown throughout the day to over a thousand students at its peak in the early afternoon, from teach-outs in the morning to a noontime rally that was attended by about 1,000 people.

The protest activities thus far have mirrored past protests with teach-outs and a rally on Sproul Plaza, but in addition to a focus on state budget cuts and the affordability of higher education, the protest has strongly identified with the national Occupy movement and included a march to Bank of America on Telegraph Avenue.

The video at the top of this post captures a violent clash that occurred earlier in the day, when police aggressively pummeled student protesters with their batons. Said Matt Welch, editor of Reason magazine, "Watch cops at Occupy Berkeley launch coordinated baton attack against unarmed students."

As midnight approached, police were summoning reinforcements as protesters chanted, "The chancellor took our tents, but look, we took the plaza." Said another speaker: "Police are not our enemy in this fight. We must above all remain peaceful." The "human microphone" was later seized by an OWS ally from across the bay. "Occupy SF has brought some wifi," he said. "If you want the password come up here -- I can't give it to everyone including the police." Activists live-streaming from the scene at midnight claimed around 10,000 viewers as one protester after another began calling for a University of California-wide all student strike. The proposal was debated via the human microphone, and ultimately passed with 569 in favor and 31 against.

One observer estimated that about half the people present participated in the vote.

In related news, The Oakland Tribune reported the following just before Wednesday's events:

Citing excessive force and free speech violations by police during protests in Oakland and at UC Berkeley, the Berkeley City Council this week refused a mutual aid agreement with university police and nixed agreements with other police agencies on regional domestic surveillance. Council members used news reports of police using excessive force at the Occupy Oakland protests and at previous protests at UC Berkeley as reason for not renewing the agreements that usually are approved each year without fanfare.

In addition, the council did not renew an agreement with the federal government on detaining illegal immigrants at the city jail. The 8-0 vote, with Mayor Tom Bates abstaining, means the council will revisit those agreements at a later date after scrutinizing them more thoroughly.

University of California campuses are patrolled by state police officers.

Students Marching Against Tuition Fees Met with 'Total Policing' Tactics

Large areas of city blocked off as 4,000 officers police largely peaceful protest but Trafalgar Square camp quickly cleared

Thousands of students and protesters marched through London to protest against tuition fees and the "privatisation" of the higher education system on Wednesday, flanked by a huge police presence determined to ensure the violent scenes that erupted last year were not repeated.

Fulfilling their promise of "total policing", 4,000 officers took to the streets as Metropolitan police commanders blocked off large areas of the capital, bringing in dozens of mounted officers and blocking off roads with 10-ft high barricades.

Protesters from the Occupy movement - which has been at St Paul's since mid-October - set up camp in Trafalgar Square with the aim of remaining until the mass strike of 30 November. They were quickly moved on by police, who also announced "additional conditions" for the march after it had begun.

A group of 50 protesters who set up about 30 "pop-up" tents refused to leave and were arrested for contravening the Public Order Act, according to the police.

Minor clashes broke out during the march but highly organised police units acted immediately to disrupt the snaking line of protesters and block off areas of trouble.

Despite 24 arrests and intermittent attacks on police with bottles and pieces of wood the protest was largely peaceful.

Last year 153 were arrested when protests spiralled out of control after a fringe group of protesters hurled missiles at police and occupied the building housing Conservative party headquarters, after up to 50,000 took to the streets.

Before the protests police warned that baton rounds of plastic bullets could be used to prevent disorder for "extreme" measures. They also sent hundreds of letters to anti-cuts activists arrested in connection with previous public disorder offences warning of the consequences of attending the student demonstration.

One group of about 30 protesters calling themselves the Black Bloc, with covered faces and matching black hoodies, linked arms and could be seen through the crowd on occasions but no major disturbances were reported.

Many on the march - which began outside the University College London campus at midday before travelling to Trafalgar Square then on to the City - complained of "intimidating" tactics by the police.

"People who were involved in the protests last year were sent letters, police are threatening to use plastic bullets

- I think it's put a lot of people off," said Anthony, a 19- year-old Liverpool University student who did not want to give his surname. "People have been worried, I've been hurt by the police, I've got friends who have been injured by the police. But it's not going to stop us, we are going to keep coming back."

National Campaign against Fees and Cuts, which organised the protests, said 10,000 had attended; police put the number at about 2,500. Evidence from helicopter pictures suggested the figure was somewhere between the two.

One of the protesters who briefly set up in Trafalgar Square, calling himself Leon, said they wanted to "bring people together" in the space but were soon moved on.

At 2pm, two hours after the march had begun, police announced protesters had to restrict the rally to the route and were prohibited from entering seven areas of the city.

Anyone who failed to comply would be "committing an offence and may be liable to arrest", said a police spokesperson.

As the march passed through London's narrower streets, accompanied by a bass-heavy sound system, tension between demonstrators and police mounted as police held the front of the march to keep the thousands of protesters on the three- mile route together. Plain- clothes officers made snatch arrests, sparking volleys of bottles and placard sticks at police. Similar skirmishes continued until the march reached its destination in the City of London.

At the end of the demonstration the crowd were released into the Moorgate area of the City of London, where protesters were informed that a dispersal order would begin at precisely 5.41pm. By 6pm the streets were clear.

Yasmin Elgouze, an A-level student, 17, said protesters would not be distracted by police "bully tactics". She said:

"Today is not about violence, it's about talking. It is not a violent revolution it is a revolution of ideas. The majority of people are here to exercise their right to peaceful protest, not to fight."

Like many at the protest she identified with the worldwide Occupy movement, which has seen the occupation at St Paul's and dozens of cities around the world. "People are hugely discontented about what is happening in this country, they know it isn't right they have ideas about how it could be better and they want to discuss that."

Amid chants of "No ifs, no buts, no education cuts" and a variety of disparaging remarks about the educational backgrounds of much of the cabinet, a history student, Mohamed, 21, said the protests were part of a movement to raise public awareness. "It's an exciting opportunity for justice and fairness. Together we have the power to change things," he said. He was protesting against the "privatisation" of the education system as well as the hike in tuition fees, which are set to rise to a maximum of £9,000 a year at England's universities next year, he added.

"The white paper is set to turn our university system into a training ground for companies; education should be about the pursuit of knowledge."

Taking a break from loudspeaker duties, Becci Heangney said protesters needed to unite. "The government isn't listening," she said. "Everyone here needs to get involved in the strike on November 30, and support Occupy. That is what is going to make the government sit up and listen. "Along the route workmen downed tools to watch the protest, some holding up placards and shouting support. Cab drivers caused tailbacks around Trafalgar Square after holding a "mass drive-in" to protest over licensing rules, while electricians, plumbers and engineers from across the country joined a rally at Blackfriars.

Michael Chessum of the National Campaign against Fees and Cuts, said university education was being reduced to a "consumer commodity". He said: "The government's higher education white paper is a chaotic, frankly kind of incompetent attempt to introduce a market into higher education. It will end higher education as a public service in the UK, it will introduce forprofit providers, it will mean a market in fees, and it will mean universities [...] may well be forced to close or to privatise."

By the early evening the protest was over, but those at St Paul's caught a surprise gig by Tom morello from Rage Against the Machine, who said he was there to "express his solidarity with the 99%." He said: "This is a worldwide class-based movement of people standing up against the oppression of corporate power. The lesson of the Arab spring is if you want change all you have to do is walk out of your front door and just do it."

* Comcast workers petition Labor Board for vote on collective bargaining

Customer Communication Technicians who work out of Comcast's Fall River and Fairhaven offices have petitioned the National Labor Relations Board (NLRB) to supervise a union representation election. If a majority of the techs vote for union representation it will finally compel management to begin talks with employees for improvements in wages and working conditions.

The technicians have been pursuing collective bargaining for over a year. In September 2010, a majority of the workers signed up with IBEW Local 2322 and requested that management voluntarily recognize their new union. Workers sought voluntary recognition because of management's history of aggressive -- and sometimes illegal -- interference in workers' freedom to choose a voice at work.

When Comcast management refused to voluntarily begin talks about wages and working conditions, the techs enlisted support from their elected officials, other Comcast workers and community groups to pressure Comcast into recognizing their union.

Congressmen Barney Frank, Jim McGovern, Stephen Lynch, Bill Keating, John Tierney and Senator John Kerry have repeatedly urged Comcast to begin talks with its employees. Hundreds of unionized Comcast workers across the country have signed letters of solidarity and support

for their co-workers in Massachusetts. In another show of support, many Massachusetts communities have sought to include workers' rights as part of their franchise agreements with Comcast.

"While we weren't successful at getting Comcast to sit down and talk with us, we are more confident than ever that collective bargaining and a union contract is what we need to have job security at Comcast," said Brian Almeida, a tech from the Fall River garage with ten years of service.

"Management recently made some changes in our working conditions that could adversely affect our service and our work," Almeida continued. "We really need collective bargaining to have a stronger voice on a broad range of issues."

"Over the last year we have become better informed about our rights and more united on the job," said Christine Dexter, a tech who spoke at a White House forum on workers' rights last March. "It has given us the confidence to move ahead with an NLRB election."

The workers' petition was filed with the NLRB on November 4. The union vote is expected in about six weeks.

Dear Friends,

Um, we won. You won.

Not completely. The President didn't outright reject the Keystone XL pipeline permit. My particular fantasy -- that he would invite the 1253 people arrested on his doorstep in August inside the gates for a victory picnic by the vegetable garden -- didn't materialize.

But a few minutes ago the President sent the pipeline back to the State Department for a thorough re-review, which most analysts are saying will effectively kill the project. The president explicitly noted climate change, along with the pipeline route, as one of the factors that a new review would need to assess. There's no way, with an honest review, that a pipeline that helps speed the tapping of the world's second-largest pool of carbon can pass environmental muster.

And he has made clear that the environmental assessment won't be carried out by cronies of the pipeline company -- that it will be an expert and independent assessment. We will watch that process like hawks, making sure that it doesn't succumb to more cronyism. Perhaps this effort will go some tiny way towards cleaning up the Washington culture of corporate dominance that came so dramatically to light here in emails and lobbyist disclosure forms.

It's important to understand how unlikely this victory is. Six months ago, almost no one outside the pipeline route even knew about Keystone XL. One month ago, a secret poll of "energy insiders" by the National Journal found that "virtually all" expected easy approval of the pipeline by year's end. As late as last week the CBC reported that Transcanada was moving huge quantities of pipe across the border and seizing land by eminent domain, certain that its permit would be granted. A done deal has come spectacularly undone.

Our movement spoke loudly about climate change and the President responded. There have been few even partial victories about global warming in recent years so that makes this an important day. We need to let the president and oil companies know that we're ready to take action should they try to push this pipeline through in a couple of years. There's a pledge to take bold action against the pipeline up on our site, and I'll be keeping your names an emails safely stored away so that you'll be the first to know about anything we need to do down the road.

The deepest thanks, however, go to you: to indigenous peoples who began the fight, to the folks in Nebraska who rallied so fiercely, to the scientists who explained the stakes, to the environmental groups who joined with passionate common purpose, to the campuses that lit up with activity, to the faith leaders that raised a moral cry, to the labor leaders who recognized where our economic future lies, to the Occupy movement that helped galvanize revulsion at insider dealing, and most of all to the people in every state and province who built the movement that made this decision inevitable.

Our fight, of course, is barely begun. Some in our movement will say that this decision is just politics as usual: that the President wants us off the streets -- and off his front lawn -- until after the election, at which point the administration can approve the pipeline, alienating its supporters without electoral consequence. The president should know that If this pipeline proposal somehow reemerges from the review process we will use every tool at our disposal to keep it from ever being built; if there's a lesson of the last few months,

both in our work and in the Occupy encampments around the world, it's that sometimes we have to put our bodies on the line.

In the meantime, since federal action will be in abeyance for a long stretch, we need to figure out how best to support our Canadian brothers and sisters, who are effectively battling against proposed pipelines west from the tar sands to the Pacific. And we need to broaden our work to take on all the forms of `extreme energy' now coming to the fore: mountaintop removal coal mining, deepsea oil drilling, fracking for gas and oil. We'll keep sending you updates; you keep letting us know what we need to do next.

Last week, scientists announced that the planet had poured a record amount of CO2

into the atmosphere last year; that's a sign of how desperate our battle is. But we take courage from today's White House announcement; it gives us some clues about how to fight going forward.

And I simply can't say thank you enough. I know, because of my own weariness, how hard so many of you have worked. It was good work, done in the right spirit, and it has secured an unlikely victory. You are the cause of that victory; you upended enormous odds.

I'm going to bed tired tonight. But I'll get up in the morning ready for the next battle, more confident because I know you're part of this fight too.

Onwards.

Progressive Victories in Ohio, Mississippi, Maine, Arizona Provide Seven Key Lessons for 2012

A year ago the Empire struck back. Right Wing money capitalized on anger at the economic stagnation that their own policies caused just two years before. They brought a halt to the hard-won progressive victories that marked the first two years of Barack Obama's presidency.

Last night the progressive forces tested some of the weapons and tactics they will use in next year's full-blown counter offensive. They worked very, very well.

Progressives won key elections in Ohio, Maine, Mississippi, and Arizona.

The importance of yesterday's labor victory in Ohio cannot be overstated. It could well mark a major turning point in the history of the American labor movement -and the future of the American middle class.

The people of Ohio rejected right wing attempts to destroy public sector unions by an astounding 61% to 39%.

Progressives in Ohio won 82 out of 88 counties.

In his "concession," the author of the union-stripping bill, Governor John Kasich, looked like a whipped dog. He was.

Last night's victory will have a direct and immediate impact on the livelihoods of thousands of middle class state employees in Ohio. It will stall similar attempts to destroy unions in other states. It will turbo-charge the campaign to oust Wisconsin Governor Scott Walker who jammed a union- stripping measure through his own legislature. And it will massively weaken Kasich and other Republicans in Ohio.

But last night's victory also carried critical lessons for the progressive forces throughout America as we prepare for the crossroads, defining battle of 2012.

Lesson #1: Creating a Movement. The industrial state labor battles that culminated in last night's overwhelming Ohio success transformed the image of unions from a large bureaucratic "special interest" that negotiates for workers and are part of the "establishment" -- into a movement to protect the interests of the American Middle Class.

The Republican Governors who began these battles hoped to make a bold move to destroy union power. In fact, they have succeeded in creating their worst nightmare -- the rebirth of a labor movement.

That is critically important for the future of unions - which by any measure provide the foundation of progressive political power in the United States. It also provides an important lesson for every element of the Progressive community.

These battles put the "movement" back in "labor movement."

And the importance of "movement" can't be overstated. Particularly at a time when people are unhappy with the direction of the country and desperately want change -- they don't want leaders who appear to be embedded parts of the status quo. They want to be part of movements for change.

Movements have three critical characteristics:

They make people feel that they are part of something bigger than themselves.

They make people feel that they themselves can play a significant role in bringing about that larger goal.

They involve "chain reactions" -- they go viral. You don't have to only engage people in movements one by one or one or group by group. They begin to engage each other.

Because they make people feel that they are part of something larger than themselves -- and that they can personally be a part of achieving that larger goal -- movements inspire and empower. And for that reason they give people hope.

To win, Progressives must turn the anger and dissatisfaction with the present into inspiration and hope for the future.

The labor movement turned the battle in Ohio into a fight for the future of America's middle class. It turned the battle into a fight over the dignity of everyday working people -- and their right to have a say in their future.

Instead of being about "contracts," it was about "freedom."

Lesson #2: It's much easier to mobilize people to protect what they have than to fight for something to which they aspire.

Every one of the big victories yesterday involved battles that had been framed as attempts by the Right -- or their allies on Wall Street - to take away the rights of everyday Americans.

In Ohio, it was the right to collectively bargain about their future. In Maine, it was the right to same-day voter registration. In Mississippi it was the right to use contraceptives - once it became clear that the so-called "personhood" amendment was not just about abortion, but ultimately about a woman's right to use birth control. In Arizona, it was the rights of Latino Americans.

And of course, that's why the Republicans' plan to privatize Social Security and eliminate Medicare are so toxic for them in the election next year.

Among referenda yesterday, the one progressive setback came in the largely symbolic vote -- once again in Ohio -- against the Health Care Reform Act's mandate to buy insurance. The very same people who had voted against taking away the rights of their neighbors to join a union -- also voted against being "forced" to buy health insurance.

The whole issue of the "mandate" is the major card the Right has played against the critically important Health Care Reform Act. Of course the whole issue could have been framed differently. The "mandate" to start paying Medicare premiums when you're sixty-five isn't framed as a "mandate." People do it, both because they really want to get on Medicare, and because if they wait to pay premiums until they need it, their premiums go way up.

That's why a Public Option was so popular with the voters.

You got to choose to join something you wanted. But it's also the way we should have framed the overall "mandate" to get insurance -- with premium penalties if you fail to "opt in."

Once the health care law becomes a fact on the ground that benefits ordinary people, every day, it will certainly become very popular. But that will wait until 2014 when most of its provisions go into effect. Once it does goes into effect, if they try to take away those benefits and the Right will run into a firestorm of opposition.

Of course if Romney is the Republican candidate next year, we don't have to worry about the "mandate" issue at all. In fact, our attitude should be "go ahead, make my day." It will be simple to neutralize any attack by Romney or Super- Pacs on Democrats about "mandates" by simply pointing out that the entire question is just one more example of how Romney has no core values -- since he authored and passed the Massachusetts health care law built around "mandates."

In the end, Romney's lack of core values is a much more powerful message than anything having to do with "mandates."

Lesson #3: Framing the battle is key. In every one of these issue referenda, Progressives won the framing battle.

In Ohio, Progressives made the fight into a battle for the rights of the middle class -- part of the overarching battle between the 99% and the 1%.

In Maine, Progressives made the battle into a fight over the right to register to vote. Of course the right wing frame was that eliminating same-day registration provided protection against "voter fraud." That was pretty hard to sustain given the fact that there had been exactly two instances of "voter fraud" involving same-day registration in 28 years.

The Mississippi "personhood amendment" was framed as a battle over the rights of women to use birth control - not to make "miscarriage" a crime.

Lesson #4: Turnout is king. In Virginia, a Republican candidate leads his Democratic opponent by only 86 votes, so a recount will determine whether the Republicans there take control of the State Senate.

Turnout in the Virginia contests was low.

In Ohio, by contrast, 400,000 more voters went to the polls yesterday than in the elections in 2010. That's one big reason why Progressives won.

And it wasn't just inspiration and great messaging that turned them out. Rank and file union members and Progressives of all sorts conducted massive get out the vote efforts in every corner of the state.

After all, victory isn't just about great strategy, mostly it's about nuts and bolts -- it's about great execution. In Ohio they had both.

In Arizona, the Latino community mobilized to defeat the author of Arizona's "papers please" law, State Senator Russell Pearce. He lost a recall election, by seven points, 52.4% to 45.4%. The Pearce defeat is just one more example of how the Republicans play the

"immigration" card at their peril -- and how important the Latino vote will be to the outcome next year in critical states like New Mexico, Nevada, Colorado, Florida -- and Arizona.

Pearce didn't count on Latinos going out to vote. They did.

Lesson #5: Progressives win when we stand up straight. We won last night where we stood proudly for progressive values

-- planted the flag -- mobilized our forces and took the offensive.

People in America are not looking for leaders who apologize for their progressive beliefs or are willing to compromise those principles even before they enter the fight. They want leaders who will fight for the middle class, and fight for change; who stand up against the big Wall Street banks and the CEO class that they believe - correctly - have siphoned off the nation's wealth, and whose greed has caused the economy to collapse.

People are willing to compromise when it seems to advance the common good -- but only after their leaders have done everything in their power to defend their interests -- and have mobilized them to defend their own interests.

Lesson #6: The face of the battle in Ohio was your neighbor.

The Republicans bet that they could make public employees the "Welfare Queens" of our time. They bet that they could make public employees the scapegoats for all that has gone wrong with the American economy -- that they could divide the middle class against itself.

They bet wrong.

Turned out to be impossible to convince everyday Americans that firefighters, cops, and teachers were greedy villains.

Normal voters recognized them as their neighbors -- as people just like themselves.

The 99% versus the 1% frame is critical to making clear that the problem with our economy has nothing to do with how much teachers, or firefighters, or steel workers, or home care workers, or Social Security recipients make for a living. It has everything to do with growing economic inequality, the exploding financial sector, and an unproductive class of speculators and gamblers who don't make anything of value but siphon off all of our increased productivity.

Lesson #7: Progressives win when we frame the issue as a moral choice.

In Ohio, Progressives did not frame the debate as a choice between two sets of policies and programs. They posed the question as a choice between two different visions of the future.

It was a choice between an America with a strong, vibrant, empowered middle class, where every generation can look forward to more opportunity than the one that went before - or, a society with a tiny wealthy elite and a massive population of powerless workers who do their bidding.

It was posed as a choice between a society where we're all in this together -- where we look out for each other and take responsibility for our future as a country -- or as a society where we're all in this alone -- where only the strong, or the clever, or the ruthless can thrive.

If given a clear, compelling choice, Americans will chose a progressive vision of the future every time.

Hi Steve,

I just read CC might be voting on repealing the city crosswalk ordinance. I'm not happy that a motion is being brought to change the wording. The only other wording of the ordinance that would work would be if the person is STANDING waiting to cross, istead of approaching it. This is the law in most European countries. The pedestrian has to be standing, obviously waiting to cross.

Today confirmed to me that the new law regarding crosswalks should NOT be repealed competely. Under the state's version, you can wait forever to cross. And we teach our children not to walk out into "on-coming traffic", which for them means if they see a car - which means they'll never make it. My 10-year-old daughter pedestrian and bicyclist is the measuring stick - not a huge SUV hurdling down the road over the speed limit.

The tinting on all modern windows prevents the predestrian from seeing the diver's eyes, to make contact.

If cars are being rear-ended, then that is the fault of the drivers doing the rear-ending. This has always been the law, also the insurance requirement. No matter whether a deer, a squirrel, for whatever reason. And besides, all those complaining that they were rammed form behind: that would have happened even under the old law! If people are saying they refuse to stop because they're afraid of being rammed from behind should be considere lawbreakers.

This is an issue the city council would do better to show real robust strength on. No going back. The future belongs to all of us: pedestrians, bicycles and cars, all equal. The car is no longer lord of the road. If some crosswalks have to be remarked or better marked or relocated, then so be it. Overhead walkways are crap, and create huge problems (rocks dropped on cars), and they are expensive, monolithic and ugly.

I hope there's no revision of the current law. People have to get use to it, slow down, look up from their texting, and obey the law.




