I - Call to Order:

Chairperson Leslie Stambaugh called the meeting to order and Richard Martonchik – Human Resources, recorded the minutes. A quorum of Committee members was present, and the meeting, having been duly convened, was ready to proceed with business.

II - Opening

III - Matters Discussed - Old Business

- ➤ The Video Privacy Ordinance Proposal and Resolution- specific wording in the proposal and resolution was discussed and wording was altered as needed and agreed. L. Winkler will review and make all changes as agreed. N. Elyakin moved to accept the resolution and proposal seconded by E. Adenekan. Voted in favor 4, voted against 1.
- Approval of July Minutes N. Elyakin moved to approve, seconded by L. Winkler all in favor.
- Community Response status and hate incident. HRC would like to invigorate response and education looking into the work of M. Brown re: dialogue @ schools. Discussed recent "hate" incident from the prior Sunday. Commissioners Stambaugh and Winkler will be meeting with the woman as part of a larger group response.
- Race Project Riot Youth Presentation brief discussion on the work of W. Hampton.
- Revision of Non-Discrimination Ordinance follow-up needed with N. Niemela. Commissioner Winkler recommended that a study committee be formed (with members from HRC, City Legal, City Council) to be run by the HRC. Meeting with S. Smith and N. Niemela suggested to address this recommendation.
