- 1) Paragraph A. of Article III., Services is amended to read as follows:
 - A. The Consultant agrees to provide professional environmental and engineering services ("Services") in connection with the Project as described in <u>First Amended Exhibit A</u>. The City retains the right to make changes to the quantities of service within the general scope of the Agreement at any time by a written order. If the changes add to or deduct from the extent of the services, the contract sum shall be adjusted accordingly. All such changes shall be executed under the conditions of the original Agreement.
- 2) Exhibit A, Scope of Services, is amended to read as shown in attached First Amended Exhibit A.
- 3) Paragraphs A. and B. of Article IV., Compensation, are amended to read as follows:
 - A. The Consultant shall be paid in the manner set forth in <u>First Amended</u> Exhibit B. Payment shall be made monthly, unless another payment term is specified in <u>First Amended</u> Exhibit B, following receipt of invoices submitted by the Consultant, and approved by the Contract Administrator.
 - B. The Consultant will be compensated for Services performed in addition to the Services described in Section III, only when those additional Services have received prior written approval of the Contract Administrator. Compensation will be on the basis of reasonable time spent and reasonable quantities of materials used, according to the schedule of rates in First Amended Exhibit B. The Contract Administrator shall be the sole arbitrator of what shall be considered "reasonable" under this provision.
- 4) Exhibit B, Fee Schedule, is amended to read as shown in attached First Amended Exhibit B:

All terms, conditions, and provisions of the original agreement between the parties executed <u>February 2 ,2009</u>, unless specifically amended above, are to apply to this amendment and are made a part of this amendment as though expressly rewritten, incorporated, and included herein.

This amendment to the agreement between the parties shall be binding on the heirs, successors and assigns of the parties.

SmithGroupJJR (SGJJR) is submitting the following request for additional services for the Ann Arbor Municipal Airport. If approved, these services will be considered as an amendment to the existing Agreement between SGJJR and the City of Ann Arbor dated 2 February 2009. It is understood that the conditions of that Agreement shall apply to this Contract Amendment.

SCOPE OF SERVICES

Basic Services

This project has received a much higher volume of comments on the Environmental Assessment (EA) than anticipated. As a result, the coordination of review and preparation of the response to comments will require additional budget. The preparation and attendance at the public hearing also required greater effort than originally scoped and coordination with FAA appears to be getting more complex. We have prepared the following summary of additional services in order to advance the project.

Public Hearing

Extra costs were incurred associated with the multiple newspaper notices, two (2) court reporters and more staff attending than originally scoped.

Revise EA

Review EA document to confirm data is valid, remove references to items requiring FAA coordination (ODALS) and update title page, footers, etc.

Sort and Code All Comments Received

All of the comments received, including both public and agency comments, will be numbered and coded to coincide with the Comments and Responses section of the Final EA.

Finalize Response to Comments, Errata and FONSI

Review and finalize the Response to Comments and prepare the Errata and FONSI (Final EA to be signed by MDOT).
