#### **I – Call to Order**

Chairperson Leslie Stambaugh called the meeting to order and Amy Seavitt recorded the minutes for members' information. A quorum of Commission members was present, and the meeting, having been duly convened, was ready to proceed with business.

- **HRC in City’s Organizational Structure** – L. Stambaugh and L. Winkler recapped the meeting that was held with Robyn Wilkerson, Director of HR, and Steven Powers, City Administrator regarding the Commission’s role and where it should be housed in the City’s organizational structure.
- **Nondiscrimination Ordinance** – The Commission will convene again to finish revisions and send to the City Attorney’s Office.

- **Council Proclamation for Victor Turner** – The Commission discussed reading the proclamation created for Victor Turner at the City Council meeting on Monday, March 18<sup>th</sup>. It was determined that A. Wilson would read the proclamation.
