Н **NEW BUSINESS** Wednesday Evening Market Operating Rules Memo and Resolution H-1 13-0213

The changes to the evening market's operating rules will eliminate its categorization as a "pilot" market. The market hours and months will be

adjusted to coincide more accurately with customer and vendor wishes. Vendor absence and stall assignment rules will be adjusted to be in line with current staff protocal and practices.

Commissioner Germain asks whether moving the start time of the evening market to 4pm would cause more congestion for daytime vendors who are leaving. Market manager Sarah DeWitt explains that the crossover is not exceedingly problematic and better weekly practices will be implemented to see that daytime vendors can leave and evening vendors can set up without too much intereference.

Response from Commissioners:

On the matter of applications for artisans and baked goods: commissioners recommend adding information to the website for applicants to understand what products are not desired at this time. Commissioner Goetz reminds of a time when artisan vendor applicants were not being accepted.

On the matter of franchised businesses: commissioners do not see the market as a place for franchised businesses to sell. Market manager DeWitt recommends that the commission articulate what the phrase "the concept of the market" means for non-acceptance of applicants on the grounds that products do not fall under the concept of the market.

On the matter of hiring as second inspector, Commissioner Santacroce requests a fiscal snapshot of the market's budget over the last two years. Market manager DeWitt explains that the budget will be brought to PMAC for review in the coming months.
