1. Thomas Partridge - Housing and Human Services; Access to affordable public transportation needed; Amendments needed to all annexations, zoning and site plan ordinances; Improvements needed in access to Human Rights, Greenbelt and City Labor Committee Meetings and improvements needed to access polling places. (H-3, I-3, I-5, I-7)

Thomas Partridge, Ann Arbor resident, addressed Council regarding the most vulnerable citizens.

2. Seth Best - Camp Take Notice Communication (H-4)

Seth Beth, 1940 W. Liberty St., thanked Mayor and Council, as well as Parks and Recreation staff, for the work they are doing to get the Vineyard Church back into the parks to continue humanitarian efforts. He asked for a commitment from the City in writing regarding their commitment to Pizza in the Park and the ability of the church and other groups to provide humanitarian aid without the assessment of fees. He urged Council to make this decision in writing to ensure that there isn't any confusion in the years to come.

3. Nicholas Goodman - Camp Take Notice Communication (H-4)

Nicholas Goodman, 1327 White St., addressed Council regarding Pizza in the Park and asked that Council put in writing their affirmation that the program should continue into the future without fees being assessed.

4. Antonio Benton - Camp Take Notice Communication (H-4)

Antonio Benton, 3299 Morris, thanked Council for agreeing that Pizza in the Park should continue and asked that an official document be submitted into the record protecting the program. He said that he and others are very grateful for the service.

5. Mark Tucker - Funding for Art in Public Places (DC-3 & DC-5)

Mark Tucker, 1716 Shadford Rd., addressed Council regarding the proposed changes to the Public Art Ordinance. He said, if adopted, he hoped that Council would take the proposed changes to heart and would take time to consider the relatively high impact that public art has had in this community.

6. Julie Steiner - Transfer Ownership of 26 parcels Owned by the City of Ann Arbor to the Ann Arbor Housing Commission (DB-4)

Julie Steiner, 502 Sunset Rd., addressed Council regarding transferring ownership of 26 parcels owned by the City. She urged Council to transfer the properties to the Housing Commission so that they could participate in the Federal Rental Assistance Demonstration Project.

7. Bob Miller - Funding for Art in Public Places (DC-3 & DC-5)

Bob Miller, 801 W. Liberty, addressed Council regarding the Art in Public Places Ordinance. He asked that Council explore the possibility of adding a requirement that private development and construction contribute to a public art general fund that would have the potential to offset a portion of the financial needs pertaining to art in public places.

8. Jeffrey Crockett - Zoning

Jeffrey Crockett, 506 E. Kingsley, addressed Council regarding a threat to the preservation of Ann Arbor's landmark trees. He said that the existing downtown zoning is a threat to the City's heritage and landmark trees. Mitigation of natural features is threatening the environment.

9. Peter Nagourney - Zoning

Peter Nagourney, 914 Lincoln Ave., expressed concern with the current zoning in the downtown area. He said that hidden legal opinions harm the public, inadequate information from City staff hinders Council decisions, and flaws in Ann Arbor's current zoning and codes allow undesirable outcomes for everyone. He urged Council and staff to learn from the mistakes of 413 E. Huron.

10. Steve Kaplan - Zoning

Steve Kaplan, 3085 Charing Cross, expressed concern with the current D1 zoning in the downtown and the impact of the 413 E. Huron St. project, which was recently approved by City Council. He stated this zoning will continue to be a problem on Huron Street if changes are not made.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER PETERSEN

Councilmember Petersen announced that she and Councilmember Lumm would be hosting the next 2nd Ward town hall meeting on June 4, 2013, at 6:30 p.m. at the Songbird Cafe located on Plymouth Road. Police Chief John Seto will be in attendance to explain the City's response to pedestrian safety issues, particularly the hot spots in Ward 2. Councilmember Petersen said that she would also be presenting the results of the Citizens' Satisfaction Study at that meeting.

COUNCILMEMBER BRIERE

Councilmember Briere said that the North Main Task Force held its first public meeting on May 22, 2013. It also closed out its survey on the 24th of May. The Task Force received responses from the public through the survey and there were also a lot of responses made at the public meeting. Those citizen responses would be incorporated into the draft report which would be coming to Council. Another public meeting is scheduled for June 12, 2013 at the Ann Arbor Community Center at 6:30 p.m. Councilmember Briere encouraged all to attend.

COUNCILMEMBER ANGLIN

Councilmember Anglin thanked the Mayor and others who attended the Allen Creek Greenway celebration that showcased the three greenway properties. He said that interest is still there regarding the vision for the three sites in the greenway, and that there are still people who are genuinely interested and are working behind the scenes on a greenway vision.

COUNCILMEMBER LUMM

Councilmember Lumm said that four Re-Imagine Washtenaw meetings were held last week. The Office of Community Economic Development hosted the meetings and did a nice job providing an update on the recommendations of the Joint Technical Advisory Committee. Various consultants were in attendance who gave presentation on the corridor. Information regarding Re-Imagine Washtenaw is available online by logging onto www.washtenawave.org. A copy of the presentation and a form to provide feedback can be found on the City's link on the website.

COUNCILMEMBER TAYLOR

Councilmember Taylor clarified some information that was presented at the last meeting regarding a 2008 email from DDA Director Susan Pollay. The 2008 email stated that no TIF funds would be used in support of the financing of the Library Lane parking garage. Councilmember Taylor stated that we now know some TIF dollars have been used to support the bonds for Library Lane; however, he stated the information provided in 2008 was accurate at that time. With the economic changes over the last few years and the DDA transfer of money to the City General Fund, the plan for Library Lane changed from what was envisioned in 2008.

MAYOR HIEFTJE

Mayor Hieftje also spoke about the Allen Creek Greenway. He stated they held a very nice picnic at First and William on June 2 in support of the future greenway. He stated efforts are still ongoing, including work by the North Main Task Force, as well as staff efforts to working with the Michigan Natural Resources Trust Fund Grant. Mayor Hieftje stated he hoped that in the next year grant applications could be made for 415 W. Washington and the greenway could begin to really take shape.

Mayor Hieftje addressed the speakers regarding the Pizza in the Park efforts to feed the homeless and hungry. He stated staff looked into the issue after last week and discovered that the problem was that the "pizza truck" was actually parked on private property. The private property owners took exception to this and the City stepped in. When other parks were suggested as a solution, those parks with picnic shelters, by policy, have a set fee. Mayor Hieftje said the entire situation was not understood when the park shelters, with fees, were proposed. He stated he has since spoken to the City Administrator and City staff and they are confident that Liberty Plaza can be used again once the parking situation is resolved.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

STREET CLOSURES

City Administrator Steve Powers highlighted a number of street closures and related events coming to Ann Arbor in the next few weeks. Mr. Powers stated the consent agenda includes approval of several closures for parades, running events and block parties. Mr. Powers also mentioned that the 2nd annual Ann Arbor Marathon will be held this Sunday, June 9, 2013 starting at 6:30 a.m., with an anticipated re-opening of the City's streets no later than 12:30 p.m. Numerous streets throughout the City will be temporarily closed for the event. There is a link to the event course map and website on the City's webpage. Lessons learned from last year's marathon have been included in the planning for this year's event, including race martial training, tour maps, mailings, website notifications, door-to-door contact with businesses, places of worship and coordination with the University of Michigan and the Ann Arbor Transit Authority.

ARTIST PRESENTATION FOR PUBLIC ART

There will be an artist presentation of proposed public art for the new Ann Arbor bridges this Friday, June 7, 2013 from 2-6 p.m. at City Hall in Council Chambers.

RED FISH BLUE FISH EVENT

The event Red Fish Blue Fish is scheduled for Sunday, June 9, 2013. The event was set up to teach children to fish and will be taking place at Gallup Canoe Livery, as part of the State of Michigan's Free Fishing weekend.

TEST OF THE OUTDOOR SIREN WARNING SYSTEM

Mr. Powers stated that on June 11, 2013, the City will undergo a testing of the Outdoor Siren Warning System. The test is schedule for 1 p.m.
