CALL TO ORDER

Mayor called the meeting to order at 7:14 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

MOMENT OF SILENCE

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

SEVERE WEATHER UPDATE

City Administrator Steve Powers updated Council on the severe weather in Ann Arbor on November 17 and 18. He stated that Ann Arbor was not hit as hard as other Midwest cities, however, there were impacts. Mr. Powers stated that as of 6:30 p.m. today, there were eight traffic signals that were operating on generator power during rush hour and have since been converted to four-way stops. If power is not restored by morning, the back-up generators will be used again to accommodate the morning rush hour.

Mr. Powers stated City Forestry crews came in at 7 p.m. and worked until approximately 3 a.m. this morning and removed nine tree limbs that had fallen into City streets. An additional 15 tree limbs were reported to be removed. Forestry is now prioritizing those locations and working through the list.

CONSENT AGENDA ITEMS

City Administrator Powers noted two items on the Consent Agenda; The Puck Drops Here, an event that would take place in downtown Ann Arbor on New Year's Eve and the National Hockey League's Winter Classic Hockey Game at Michigan Stadium on New Year's Day. Mr. Powers noted that the City plans to treat the NHL game at Michigan Stadium in the same manner as a football Saturday with regards to parking enforcement, street closures and vendor permits.

NO TRASH-RECYCLING-COMPOST COLLECTION ON THANKSGIVING DAY

Mr. Powers reminded the public that there would be no trash, recycling or compost collection on Thanksgiving Day. Thursday pick-up would occur one day later on Friday and Friday pick-up would occur on Saturday.

Thomas Partridge, Ann Arbor resident, addressed Council regarding honoring the legacy of John F. Kennedy and enacting accessible County-wide transportation and affordable housing.

2. Jeanine DeLay - Education on Professional Standards of Conduct (DC-2)

Jeanine DeLay, 2972 Hickory Ln., representing A2 Ethics, spoke in support of the proposed Resolution to Support Education on Professional Standards of Conduct and thanked Councilmember Petersen for her work to bring this resolution together. Ms. DeLay also thanked Councilmember Kunselman for his support on this issue.

3. Nancy Schewe - Education on Professional Standards of Conduct (DC-2)

Nancy Schewe, 428 Spring St., representing The League of Women Voters, spoke in support of the proposed Resolution to Support Education on Professional Standards of Conduct. Ms. Schewe stated this is an important issue to the League. Voters must have confidence that their elected officials are working for the good of the community and not personal gain. Trust is an essential component for a strong community.

4. Kathy Griswold - Crosswalk Ordinance (C-4)

Kathy Griswold, 3565 Fox Hunt Dr., addressed Council regarding the proposed repeal of the City's existing crosswalk ordinance. She urged Council to support the State law regarding pedestrian crossings. She expressed concern about the fact that pedestrians are ignored in Ann Arbor.

5. Erin Mattimoe - Education on Professional Standards of Conduct (DC-2)

Erin Mattimoe spoke in support of the proposed Resolution to Support Education on Professional Standards of Conduct. She said that in a democracy, confidence in government depends upon the trust of the people in their elected representatives. High ethical standards of conduct in government are essential and this resolution would serve as a reminder for officers and employees of the City of Ann Arbor.

6. Erica Briggs - Pedestrian Safety Ordinance (C-4)

Erica Briggs, 719 W. Jefferson St., Chair of the Washtenaw Bicycling and Walking Coalition, spoke in opposition to the proposed repeal of the existing Pedestrian Crossing Ordinance. She stated she was speaking on behalf of thousands of people in the community who are supporters of the current ordinance. Ms. Briggs provided a petition signed by over 500 members of the community urging Council to reconsider this repeal. She asked that Council take additional time to review this proposed change.

7. Joanna DeCamp - Education on Professional Standards of Conduct (DC-2)

Joanna DeCamp, 909 Heather Way, a volunteer with A2 Ethics, spoke in support of the proposed Resolution to Support Education on Professional Standards of Conduct. Ms. DeCamp stated this policy would establish a common understanding of professional behavior for our elected and appointed officials. Adopting the resolution would help foster public trust in local government at a time when trust in government is at historic low levels at the national and state levels.

8. Jim Mogensen - AAATA and Ypsilanti Township (DC-1)

Jim Mogensen spoke in support of expansion of transit in the urban core area. He said that this current proposal to expand the AAATA is a continuation of a process that started over 40 years ago.

9. Chris Hewett - Traffic Pedestrian Safety/Crosswalk Ordinance (C-4)

Chris Hewett, 553 S. Seventh, representing Safety on Seventh and Madison Streets, addressed Council regarding the proposed repeal of the Traffic Pedestrian Safety Crosswalk Ordinance. He stated whether Council repeals its pedestrian crossing ordinance and adopts State law or maintains the current ordinance, Council needs to address the traffic and speeding issues in Ann Arbor.

10. Alan Haber - Participation in the Michigan Economic Development Corporation's Redevelopment Ready Communities Certificate Program (CA-4)

Alan Haber, 531 Third St., addressed Council regarding the proposed Resolution to Authorize Participation in the MEDC's Redevelopment Ready Communities Certification Program. Mr. Haber expressed concern and urged Council to consider human needs first.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER BRIERE

Councilmember Briere announced that the City would be holding a meeting on November 21, 2013 at 6:30 p.m. at the Traverwood Library to discuss parking options for the Argo Cascades.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that he made a comment at the last meeting that street lights were out on Packard and in Doyle Park. They are now on in both areas. He thanked staff for their timely response.

Councilmember Kunselman also commented on a member of the public's comment regarding Stone School Road and the reconstruction project underway.

Councilmember Kunselman reiterated that he has specifically asked for street lighting to be included in this project. He stated there is not a moratorium on street lighting. He urged Council to support street lights for this project when it comes to them.

COUNCILMEMBER PETERSEN

Councilmember Petersen thanked AAPD Officer Springer for her presence on Devonshire during the recent storms. She stated Officer Springer assisted with a large tree limb that was down in the streets and was present until Forestry crews arrived. She also thanked Colin Smith, Parks Manager, and Eli Cooper, Transportation Manager, for following through on her request for "Pathway Etiquette" signs in City parks.

Councilmember Petersen also reminded Ward 2 residents that she has re-launched the Ward 2 Citizens Satisfactory Survey. It is located on the website www.a2.Ward 2.com. Click on the link near the end of the page to take the survey. Councilmember Petersen stated the survey is open to all residents and is available until the end of November.

COUNCILMEMBER EATON

Councilmember Eaton thanked City staff for the two-day New Councilmember Orientation.

COUNCILMEMBER TEALL

Councilmember Teall announced that the Michigan Theater Board would be meeting on November 19, 2013 at 5 p.m. to talk about options for the State Theatre building and how to keep it open as a theatre.

Councilmember Teall said that they had a really great DDA Partnerships meeting last Wednesday. A presentation regarding the Ypsilanti/Ann Arbor Chamber Impact 2013 was given at the meeting. Councilmember Teall stated she would like to see the presentation again as part of a City Council Work Session.

COUNCILMEMBER ANGLIN

Councilmember Anglin spoke about the traffic and pedestrian safety issues. He stated he does not yet have the details, but there will be a meeting in December regarding traffic on Seventh between Pauline and Stadium.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy also spoke about traffic and speed enforcement in the City. She mentioned that at budget time the funding of police officers should not always be about violent crimes, but also about pro-active policing and prevention. Councilmember Kailasapathy stated quality of life is also a component of the discussion.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski said that he attended a rally by an organization called Washtenaw Regional Organizing Coalition, WeROC. The focus of the group is on three points: education, transportation, and criminal justice. Councilmember Warpehoski said one initiative they are working on is a "Ban the Box" policy, regarding the use of a check box on job applications for criminal history. He stated a criminal background check is enforced where needed, but having this box on all job applications results in automatic removal for consideration in some cases. Councilmember Warpehoski stated he would be working with the Human Rights Commission and other City staff on this issue. He stated he welcomed feedback from his colleagues.
