City Council

CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:08 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

MOMENT OF SILENCE

Council stood for a moment of silence.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR*WINTER WEATHER ACTIVITY UPDATE*

City Administrator Steve Powers introduced staff members Craig Hupy, Public Services Area Administrator, and Mary Jo Callan, Community Development Director, to discuss the severe winter weather and its effects on the City.

Mr. Hupy updated Council regarding snowplow and salting efforts. He stated the Field Operations Unit will need to come before Council for their third request for salt purchase due to the high usage this season. He expected that a resolution would be ready for Council in early March. Mr. Hupy also mentioned that water main breaks are on the rise due to the extreme weather and this pattern has been true historically.

Mayor Hieftje commented on the condition of the sidewalks throughout the City, noting that the recent rain on top of wet snow has made it difficult for residents to manage. He asked how the City was doing with City-owned property.

Ms. Callan spoke about the needs of the homeless in these extreme conditions. She stated the Delonis Center continues to serve as an emergency shelter and has waived its normal drug and alcohol restrictions. Ms. Callan stated her office is also in constant communication with other non-profits who serve as emergency shelters and warming centers.

1. Bob Miller - Public Art Ordinance (C-1)

Bob Miller, 801 W. Liberty St., addressed Council regarding public art, speaking in support. He encouraged Council to find local artists for projects.

2. Seth Best - Regulation of Smoking in Outdoor Public Places (C-2)

Seth Best, 2949 Cascade Dr., addressed Council regarding the proposed outdoor smoking ordinance. He expressed concern with the \$50.00 fine proposed in the ordinance for smoking in a City park. He said smoking outdoors is one of the few enjoyable things that the very poor or homeless can still do, noting that while smoking may not be a healthy habit, it is legal.

3. Susan Froelich - Public Art Ordinance (C-1)

Susan Froelich, 1218 Ardmoor, addressed Council regarding the proposed Public Art Ordinance changes. She said that is important that Council keep the existing art funds for future projects and fund a Public Art Administrator.

4. Shoshana Hurand - Public Art Ordinance and Professional Services Agreement with Aaron Seagraves (C-1, DB-1)

Shoshana Hurand, 1206 Brooklyn Ave., Apt. 1, spoke in support of public art and encouraged Council to continue the contract with the City's public art administrator. She stated public art is an important piece of living in a remarkable city.

5. Lily Au - Public Art Ordinance (C-1)

Lily Au, 682 Peninsula Ct., shared the City's mission statement with the public and expressed concern with the City funding art when people are in need of food and shelter in the community. She also spoke in opposition to the eviction of the folks in Troll Village.

6. David Olson - Public Art Ordinance (C-1)

David Olson, 513 Fountain St., spoke in support of public art. He encouraged Council to spend the remaining public art fund monies on public art.

7. Chris McKeown - Camp Evictions

Chris McKeown, representing people living in the streets and those being evicted from what is called Troll Village, spoke about the proposed evictions by the Ann Arbor Police. He encouraged the Council to show some compassion for the people living at Trill Village.

8. Joel Reinstein - Camp Evictions

Joel Reinstein, 3 Medford Cir., addressed Council regarding the evictions of the homeless at Troll Village. He said that he was happy that the evictions were not carried out. He stated it would have been devastating in this extreme weather.

9. Tracy Williams - Camp Evictions

Tracy Williams, a member of the homeless community, spoke about the proposed evictions at Troll Village. He urged Council to support the homeless; he stated they were not going away and he and others would continue to speak before Council.

10. James D'Amour - Thank Council for support of Climate Change Action Plan

James D'Amour, 2771 Maplewood Ave., thanked Council for supporting the Climate Change Action Plan.

CC COMMUNICATIONS FROM COUNCIL*COUNCILMEMBER EATON*

Councilmember Eaton announced that the Friends of Dicken Woods and the Dicken Elementary PTO were holding the 10th annual Dicken Candlelight Winter Walk on February 11, 2014, with a winter weather alternative date of February 13, 2014. The public was welcome to join them at the elementary school for the walk.

Councilmember Eaton thanked the Ann Arbor Police Department for their handling of the homeless camp evictions in City parks. He stated some of the AAPD officers acted almost as social workers, working with PORT to find alternative shelter for those in need and ensuring that no one was left out in the cold.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski responded to some of the comments made regarding the extreme cold and the challenges of finding shelter and support for those in need. He noted that this crisis will continue as long as there continues to be substance abuse and mental health struggles for some folks, in addition to the downturn in the economy. He stated the City's response to the crisis is only one piece; they also need to work on prevention and help for these larger problems. People should not be treated as "throw away."

MC COMMUNICATIONS FROM THE MAYOR

Mayor Hieftje also responded to the comments regarding the extreme cold and available shelter options. He stated that it is his understanding that the Delonis Shelter has not turned anyone away during this extreme weather, including folks with prior problems at the shelter.

Regarding the Troll Village, Mayor Hieftje stated the City received complaints about an illegal camp in Riverside Park. He stated the eviction was never for the folks under the bridge, the area referred to as Troll Village, but for those folks illegally camping in the park. Mayor Hieftje reminded the public that the City does have an ordinance against camping in City parks and it is enforced when complaints are received.
