CALL TO ORDER

Mayor called the meeting to order at 7:09 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

STREET CLOSURES ON CONSENT AGENDA

City Administrator Steve Powers called to Council's attention several resolutions for street closings on the Consent Agenda, including closures for the Ann Arbor Marathon and the Ann Arbor Art Fairs.

SUPPLEMENTAL ROAD FUNDING FROM THE STATE

Mr. Powers also reported that the State legislature is considering supplemental road funding to help cities and counties, as well as the State with the impacts of the winter weather on road conditions. The funding would help further the City's resources as they move from snow and ice removal to pothole patching and other spring and summer maintenance items.

Mr. Powers asked residents that could, to assist the City by clearing snow and ice from the storm drains in their neighborhoods. He said that this will be a challenging spring melt because of the deep frost this winter. The frost line is approximately four feet deep and a hard rain would be problematic at this time, as the ground would not be able to absorb that rain.

Margaret Parker, 1218 Olivia, co-owner of Downtown Home and Garden, addressed Council on the proposed Resolution regarding Uncommitted Public Art Funds and the Resolution to Establish a Timeline for Transition and to Return Uncommitted Public Art Funds to Originating Sources. She urged Council not to destroy the City's public art program.

2. Bob Miller - Resolution regarding Uncommitted Public Art Funds and the Resolution to Establish a Timeline for Transition and to Return Uncommitted Public Art Funds to Originating Sources (DC-1 & DC-2)

Bob Miller, 801 W. Liberty St., Chair of the Public Art Commission, addressed Council on the proposed Resolution regarding Uncommitted Public Art Funds and the Resolution to Establish a Timeline for Transition and to Return Uncommitted Public Art Funds to Originating Sources. He said that two projects have been jeopardized by this process and the Commission is currently at risk to lose grant money for the Canoe Imagine Art Project. The Coleman Jewett Memorial Chair is another project that is in jeopardy because a local association is hesitant to donate to the project because they are unsure about Council's position on public art and how it could be affected by the outcome, he said.

3. Dave Olson - Resolution regarding Uncommitted Public Art Funds and the Resolution to Establish a Timeline for Transition and to Return Uncommitted Public Art Funds to Originating Sources (DC-1 & DC-2)

Dave Olson, 513 Fountain St., also addressed Council regarding the proposed Resolution regarding Uncommitted Public Art Funds and the Resolution to Establish a Timeline for Transition and to Return Uncommitted Public Art Funds to Originating Sources. He read from a statement that had been circulating the last few days in the arts community called Moving Forward with Public Art. Mr. Olson stated Council cannot claim to support the arts and at the same time eliminate personnel and funding to support the public art program.

4. Rita Loch-Caruso - Green Streets (DB-1)

Rita Loch-Caruso, 556 Glendale, member of the Environmental Commission, spoke in support of the Resolution adopting Green Streets Policy Guidelines for Public Streets. She urged Council to approve the proposed resolution and said that the guidelines would promote the use of technologies on new and reconstructed streets that have the goals of treating stormwater and increasing stormwater infiltration, ultimately improving water quality, and reducing flooding in the city during storm events.

5. Tom Partridge - Create a more racially and politically just Michigan. Build a more people friendly Democratic Ann Arbor. Fund expanded affordable housing.

Tom Partridge, Ann Arbor resident, called upon Council to create a more racially and politically just Michigan, build a more people-friendly democratic Ann Arbor and fund the expansion of affordable housing. He added that the public art issue should be postponed to a later date and time.

6. Mary Underwood - Resolution to Return Uncommitted Public Art Funds to Originating Sources (DC-1)

Mary Underwood, 1518 Pine Valley Blvd., addressed Council regarding the proposed Resolution to Return Uncommitted Public Art Funds to Originating Sources. She stated that she does support the arts, but right now the City's priorities need to be about core services. She noted that the City has reduced its workforce from 863 employees to 686 and the impacts are felt.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman spoke about a recent article in the Ann Arbor Observer, written by Mr. Leonard. Councilmember Kunselman expressed concern that the article was not factual in regards to his relationship and involvement with the DDA. Councilmember Kunselman asked City Administrator Steve Powers to respond to the misinformation in the Observer and ask for a correction.

Administrator Powers replied that he would be happy to share his response with anyone interested.

COUNCILMEMBER BRIERE

Councilmember Briere announced that a meeting on the Barton sidewalk and the Newport Road traffic calming effort was scheduled for February 25, 2014 at Northside Elementary School starting at 6:30 p.m.

COUNCILMEMBER PETERSEN

Councilmember Petersen said that in honor of their 100th Anniversary, the Rotary Club of Ann Arbor has committed \$250,000.00 to fund a universal access playground in Gallup Park. The playground will go above and beyond the ADA requirements and is in collaboration with the Parks and Recreation Services Area. Councilmember Petersen stated there is a public meeting on February 20, 2014 at 7:00 p.m., at the Ann Arbor Parks and Recreation Senior Center. She encouraged residents to come out to share their feedback and learn more about universal access playgrounds.

CONCILMEMBER ANGLIN

Councilmember Anglin spoke about concerns regarding the high cost of repairs for issues like sewer back-ups, furnaces, and other home repairs. He urged the Council to think about options to assist those in need.

COUNCILMEMBER LUMM

Councilmember Lumm inquired about reporting water main breaks. Public Services Area Administrator Craig Hupy said that anyone who discovers a break should call 994-2840. The Water Treatment Plant is staffed 24 hours, 7 days a week.

COUNCILMEMBER EATON

Councilmember Eaton said that on February 14, the City Attorney's Office circulated a confidential memo regarding the property assessment process. Mr. Eaton informed Council that he intends to sponsor a resolution at the next meeting to waive the attorney/client privilege on that memo so that the information could be shared with constituents.

Councilmember Eaton noted that Arbor Wiki had a handy page of all of the

emergency numbers a person would need, including whom to call for water main leaks, poison and a variety of other things.

MAYOR HIEFTJE

Mayor Hieftje spoke about the condition of the City's sidewalks. He stated the weather has made it very difficult for homeowners to clear their sidewalks, especially due to the high volume of snow, followed by rain and then more freezing temperatures. Mayor Hieftje noted that a brief period of warmer temperatures has been forecasted and he urged residents to get out and clear their walks while the ice melts.
