PUBLIC COMMENT ON DRAFT URBAN AND COMMUNITY FOREST MANAGEMENT PLAN

City Administrator Steve Powers said that public comment on the draft Community Forest Management Plan would be accepted until March 28, 2014. The draft plan is available on the City's web site on the Forestry page at a2gov.org.

CURBSIDE COMPOST COLLECTION

Administrator Powers announced that curbside compost collection would resume on March 31, 2014. A new program for "plate scrapings" would be starting soon. All residents who have compost carts will receive a postcard coupon in the mail for a free 1.9 gallon kitchen composter. Kitchen compost buckets may be picked up at the City Customer Service Center beginning March 31, 2014.

PUBLIC ENGAGEMENT AND INFORMATIONAL MEETINGS

Administrator Powers announced that the first in a series of public engagement and informational meetings for the Ann Arbor Station project would begin in March and continue through April, 2014. 1. Will Hathaway - Design Library Lot Park (DC-1)

Will Hathaway, 3424 Stow St., spoke in support of the proposed resolution designating an urban public park location on the Library Lot Site. He said that Council's support would allow the public process to continue.

2. Tom Partridge - By-law changes to City Planning Commission, Library Lot Park, Access to 15th District Court (DS-1, DC-1, DS-2)

Tom Partridge, Ann Arbor resident, addressed Council regarding issues in Ukraine, the proposed by-law changes to City Planning Commission, Library Lot park proposals, and access to the 15th District Court.

3. Barbara Bach - Library Lot Park (DC-1)

Barbara Bach, 2061 Day St., spoke in support of the proposed resolution regarding the design of an urban park on the Library Lot. She said that planning could begin once the boundaries for a park have been defined and that the proposal encourages neighboring properties to think creatively with the City. She urged Council to support the proposal.

4. Eric Lipson - Design Library Lot Park (DC-1)

Eric Lipson, 1318 Rosewood, member of the Library Green Conservancy, spoke in support of the proposed resolution regarding the design of the Library Lot park.

5. Peter Allen - Sale of Library Lot (DC-8)

Peter Allen, 2224 Applewood, addressed Council regarding the proposed resolution on the sale of the Library Lot. He said that Council should not sell the property, but instead should look into long-term leasing. He spoke about the long-term economic value of the property.

6. Ingrid Ault - Library Lot Park (DC-1)

Ingrid Ault, 2531 Meade, Chair of the Park Advisory Commission, spoke in opposition to the proposed resolution regarding the design of Library Lot Park. She said that PAC has concerns on how the project would be funded and they are uncomfortable moving forward at this time.

7. Alan Haber - Sale of Library Lot (DC-8)

Alan Haber, 351 Third St., spoke in support of a downtown urban park on the Library Lot site.

8. Henry Herskovitz - Synagogue Vigils at Beth Israel Congregation

Henry Herskovitz, 404 Mark Hannah Place, said that the peaceful demonstrations that have taken place at Beth Israel Congregation have been met with criticism.

9. Rita Mitchell - Library Lot Park (DC-1)

Rita Mitchell, 621 Fifth Street, spoke in support of the proposed resolution regarding the design of Library Lot Park. She said that a downtown public park would draw people to local businesses, as they are business generators. She added that downtown residents would also benefit from having access to open space, giving them a version of a backyard. Ms. Mitchell said that a portion of the parking fees for the parking structure below could be used for funding an urban park on top of the parking structure.

One presentation in particular talked about how much rain falls on Ann Arbor in a season. The Michigan Stadium can be filled 126 times with the amount of rain that falls on Ann Arbor. That is 10% more rain coming down than just 10 years ago. Mayor Hieftje said he would provide numbers surrounding water fall at a later date.
