Safety Services Area Administrator John Seto provided an update of the operations of the Police and Fire Departments. Chief Seto said that it is his recommendation that the City hire a new fire chief, as the department has been without a chief since the retirement of Chief Hubbard.

Chief Seto also spoke about his proposed budget recommendations, including the hiring of three new police officers and one firefighter. Council asked questions regarding the appropriate level of staffing for both departments and how the new police officers would be utilized.

Councilmember Eaton inquired whether the Ann Arbor Fire Department is currently meeting National Standards for fire response times.

Councilmember Kunselman asked for more information regarding the use of heroin in the City and related arrests.

Councilmember Lumm questioned if some of the firefighters assigned to Fire Prevention could be reassigned to trucks.
