Carla Miller, an attorney with CityEthics.org, presented to Council regarding Standards of Conduct and the need for an ethics policy. She spoke about the elected official's duties to the public and their own obligations to family and friends. Ms. Miller stated the number one element of ethics in government is the concept of fairness. She stated corruption can be personal or institutional and it is not necessarily always illegal.

Ms. Miller stated a good ethics policy should include an ethics code, training and communication, advise, disclosures, and independent enforcement body and a hotline for whistleblower protection.

Kathy Griswold, 3565 Fox Hunt, spoke about overgrown vegetation in the City. She stated tall grass and vegetation in the right-of-way is a safety issue for pedestrians.
