**SUBJECT: Famurewa Property Annexation and Zoning  
(2115 Victoria Circle)  
Project Nos. A14-005 and Z14-021**

### PROPOSED CITY PLANNING COMMISSION MOTION

The Ann Arbor City Planning Commission hereby recommends that the Mayor and City Council approve the Famurewa Property Annexation and R1A (Single-Family Dwelling District) Zoning.

### STAFF RECOMMENDATION

Staff recommends this petition be **approved** because the property is within the City's water and sewer service area and the proposed R1A zoning is consistent with the adjacent zoning, surrounding land uses and the Master Plan Land Use Element.

### LOCATION

This site is located on Victoria Circle, west of Newport Road, just north of M-14 (West Area). This site is in the Huron River Watershed.

### DESCRIPTION OF PETITION

The petitioner requests annexation of a 0.5-acre property from Ann Arbor Township and zoning to R1A single-family residential. The site currently is vacant. The petitioner would like to construct a single-family home and connect to public water and sanitary sewer service after construction.

## **HISTORY AND PLANNING BACKGROUND**

The Master Plan Land Use Element recommends single-family residential use for this site.

## **COMMENTS PENDING, DISMISSED OR UNRESOLVED**

Public Services (Systems Planning Unit and Project Management Unit) – There are city utilities available to service this parcel, including an 8” water main and an 8” sanitary sewer in Victoria Circle. Storm sewer is not available. At the time of connection to the city water and sewer mains and the services becoming active (i.e., when the water meter is set), the current fixed improvement charges in effect at that time will be due.






