- 1. Kai Petainen Resolution Authorizing an Agreement with Adrian/Tecumseh SmartZone (DC-1)

Kai Petainen, City resident, expressed concerns about the expansion of SPARK, with the proposed agreement with the Adrian/Tecumseh SmartZone. He stated the job creation numbers are exaggerated, noting that Toyota, for example, did not come to Ann Arbor because of SPARK.

2. Alan Haber - Park Advisory Commission Recommendation for Redevelopment of Liberty Plaza and Development of the Library Lot (F-3)

Alan Haber, 531 Third Street, spoke in support of the proposed World Peace Day on September 21. He stated he signed up to speak under Item F-3, regarding the redevelopment of Liberty Plaza and the Library Lot, and he would like to see the World Peace Day event take place downtown.

 John Heed - Resolution to Direct City Administrator to Negotiate One or More Operating Agreements with Transportation Network Companies (DC-2)

John Heed, a local taxicab owner, spoke in opposition to the resolution to negotiate an operating agreement with TNC companies. He stated these types of agreements are a violation of State law.

4. Michael Benson - Resolution to Direct City Administrator to Negotiate One or More Operating Agreements with Transportation Network Companies (DC-2)

Michael Benson, Taxicab Board Chairman, spoke in opposition to the resolution to negotiate operating agreements with TNC Companies. He stated these types of companies, like Uber and Lyft, do not have the same requirements as taxi cab companies, including commercial insurance and licensing requirements.

5. Lu Anne Bullington - Resolution to Direct City Administrator to Negotiate One or More Operating Agreements with Transportation Network Companies (DC-2)

Lu Anne Bullington, Third Ward resident, spoke in opposition to the resolution to negotiate operating agreements with Transportation Network Companies. She stated the City should regulate taxicabs.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER EATON

Councilmember Eaton stated that he had previously announced a public meeting that would be held with the developer of the Packard Square project. He stated that due to scheduling problems, the meeting has been postponed. The meeting will be rescheduled at a later date, but is not yet known, he stated.

COUNCILMEMBER ANGLIN

Councilmember Anglin spoke about his resolution to support World Peace Day on September 21 and to schedule a downtown event. He thanked Council for their support. He stated this event will be the first test of the use of downtown parks and public spaces for large events.

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy acknowledged the last meeting tonight of Mr. Dave Askins, of the Ann Arbor Chronicle, and thanked him and Mary Morgan for all their years of service to the City of Ann Arbor with The Chronicle's reporting. She spoke of the importance of a free press.

COUNCILMEMBER BRIERE

Councilmember Briere stated she and Councilmember Lumm attended multiple sessions of the charrette at the former Washtenaw County Juvenile Detention Center on the corner of Platt Road and Huron Parkway between August 26 and 28. She stated they looked at the site regarding its availability and the possibility of use as an affordable housing site.

COUNCILMEMBER LUMM

Councilmember Lumm reminded Council and the public that the annual Dog Swim would be taking place on September 3 and 4 at Buhr Pool. She stated the City Clerk's Office would have a banner announcing dog licensing efforts to those in attendance at the swim.

Councilmember Lumm thanked Dave Askins for his work with The Chronicle.

Liz Meneck, a taxicab driver, expressed concerns about deregulation, but noted that while owners and drivers disagree on deregulation, they are all in agreement that companies like Uber and Lyft are illegally operating and agreements to allow this to continue are also illegal.

LuAnne Bullington, Taxicab Board member, spoke in support. She stated this gives the taxicab companies flexibility to allow them to be competitive, but stated they could not exceed the maximums established.

Rick Clark, Amazing Blue Taxi, spoke in support of deregulation.

Tom Partridge, City resident, spoke in support of the ordinance, but stated this needs to extend to companies like Uber and Lyft.

Michael White, General Manager of Uber locally, spoke in support of the ordinance.

Michael Benson, Chair of the Taxicab Board, spoke in support of the ordinance and deregulation. He stated he is available for any questions on this issue.
