
Description and Discussion:



 It is requested that you contact the Building Official by the end of the business day on Monday, July28th, 2014 to discuss your intentions for restoring the property listed above.

Failure to respond will result in further action for recommendation to the Building Board of Appeals, and other possible legal action.

Because of the immediacy of these health and safety concerns, it is highly recommended that a dialogue be initiated at the earliest instance between the property owner/parties in interest and the City. I can be reached by email or telephone.

In addition you are expected to solicit bids from contractors to replace the roof and acquire permits for the work. Mr. Ralph Welton will work with your chosen contractor to inspect the trusses, decking and frame work of the roof structure before final decking, and shingles are installed.


