#### 1. Larry Baird - Fuller Road/Maiden Lane Bridges Rehabilitation (DS-2)

Larry Baird, City resident, stated he is an advocate for the border-to-border trail. He urged Council to make the pedestrian elements of the bridges a priority.

#### 2. Jeff Hayner - Implementation of Recommended Best Practices to Receive Redevelopment Ready Communities Certification (CA-12)

Jeff Hayner, 1807 Pontiac Trail, urged Council to remove CA-12 from the Consent Agenda. He expressed concern about the consequences of the "Redevelopment Ready" program, including the possibility of loss of control by City Council over the site plan approval process.

#### 3. Frank Commiskey - Thurston Pond Fee Waiver (DC-4)

Frank Commiskey, 2647Antietam, on behalf of Thurston Nature Center, spoke in support of the Resolution to Waive Site Plan Review Fees for the Thurston Pond Restoration Site Plan Petition.

#### 4. Robert McGee - Deer Issues

Robert McGee, 2245 Placid, stated he is opposed to a deer cull. He expressed concerns about the City's deer management public process, stating residents were not allowed at the public meetings to speak on certain topics and some were cut off by the consultant if their comments were not as instructed. He urged the Council to take this issue to the ballot so the voters can decide.

# 5. John Milne - Resolution in Support of State Ballot Proposal 15-1 on May 5, 2015 Ballot (DC-1)

John Milne, Saginaw City resident, asked Council to delay their vote of support for the State Ballot Proposal, 15-1. He stated there are many discrepancies and drafting errors in this law that have not been made public, including many financial shortfalls.

#### CC COMMUNICATIONS FROM COUNCIL

#### COUNCILMEMBER ANGLIN

Councilmember Anglin stated a dialogue between the City and the University of Michigan is needed regarding municipal funding. He suggested some type of payment in lieu of taxes.

#### COUNCILMEMBER GRAND

Councilmember Grand stated a public meeting regarding the Manchester Water Tank project will be held at Tappan Middle School on March 25 at 7p.m.

Councilmember Grand thanked the AAPD for their professional service at the Ann Arbor School Board meeting at Huron High School. The meeting included a discussion of carrying weapons on school property and the officers in attendance kept the situation calm and orderly.

#### COUNCILMEMBER BRIERE

Councilmember Briere stated the Pedestrian Access and Safety Task Force was hosting a meeting at the Downtown Library on March 25 to discuss the proposed changes to the Sidewalk Ordinance. The meeting will be held at 6:30 p.m. and she urged the public to attend.

Councilmember Briere noted that students from Skyline High School were recognized with a national second place award for a film they produced about the impacts of the No Child Left Behind legislation. The film will be shown on CSpan on April 3 and is also available on the website.

#### COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski updated Council and the public regarding a series of Sheriff's Department forums with topics on relations between the police and the public, the use of body cameras, and youth issues. Councilmember Warpehoski also stated the Interfaith Council on Peace and Justice is also hosting a "Toxic" talk at Brown Chapel AME Church on March 29 from 5 - 6p.m. He stated the Ann Arbor community is racially divided economically.

#### COUNCILMEMBER LUMM

Councilmember Lumm responded to a public speaker regarding the City's deer management outreach efforts. She stated the Huron Valley Humane Society was invited to the recent meeting and declined to attend. She stated a few speakers were critical of others in attendance and were asked not to make personal attacks at other speakers.
