RESOLVED, That City Council directs the City Administrator to ~~recommends the following:~~

~~1) That plans for the design and funding of the central B2B section be approved by City Council, and~~

1) ~~That a safe~~ design to develop a design to facilitate safe bicycle, pedestrian and wheelchair access through and/or around the intersections, crossing lanes, and driveways as well as on and off road bike lanes on Fuller Road, Maiden Lane and Medical Center Drive and identify elements suitable for near-term construction ~~be fully developed,~~ and

2) establish the costs for constructing this section of the B2B Trail system; seek funding opportunities through discussion with the University of Michigan; and apply for appropriate grants to the Washtenaw County Parks & Recreation Commission and the State of Michigan. ~~5) That the costs of this section of the B2B Trail system and source of funding be established jointly by the City of Ann Arbor, the University of Michigan, and the Washtenaw County Parks & Recreation Commission.~~

3) ~~That complete improvements to the Border to Border trail improvements be completed~~ prior to, or concurrently with any improvements to the intersection of Fuller, Maiden Lane and Medical Center Drive, and ~~construction of other transportation projects, and~~

~~4) That any future transportation construction preserves the integrity of the B2B Trail system, and~~

~~5) That the costs of this section of the B2B Trail system and source of funding be established jointly by the City of Ann Arbor, the University of Michigan, and the Washtenaw County Parks & Recreation Commission.~~

Dear Paul, Thanks for your note, and very sorry to hear about the damage to your garden. Know this is so discouraging, and, honestly and sadly, not surprised that the damage is getting worse. The deer population nearly doubles every two years, and without doing anything to reduce the herds of deer, and I agree we have a serious over population problem, the problem will, of course, only worsen -- as you're seeing first hand. Absolutely agree we need to take action, and I will support culling. I also agree that this is not a one-time cure all, and that, as other communities have determined, the deer reduction effort will need to be an annual undertaking as long as the over population problem exists. I am doing what I can to help advocate for an effective deer management plan, and would just encourage you and anyone who shares these concerns to contact council. We are to receive the deer management recommendations this week.

Very sorry about the toll on your plants and garden, Paul, and please know I want the City to take the needed action to address the overpopulation problem.

Dear Jane This is a brief note to let you know about the awful damage the deer have done to our garden the past winter. We have lived here for nearly 10 years and this past winter was by far the worst for plant loss. When we returned from Florida April 10th. I took a quick inventory of our losses: 3 ornamental arborvitae , 1 arborvitae, 2 hollies, all our tulips, 3 blueberry plants, 6 large yews all eaten up to the 5 foot height, and numerous hostas. Planting evergreens is a waste of time and money. We need the City Council to act. There is a serious over population of deer in our Ward and

some action is needed. The deer are undersized despite their feeding frenzy. Please see this matter is dealt with an action that is ongoing. This is not a one time issue but will be with us for the foreseeable future. Thanks in advance for your help in this matter. Regards Paul Morel

Recommendations for consideration to be presented in the report include, e.g., education, a deer feeding ban, continued monitoring and culling in Wards 1 and 2. It will then be up to council to consider the report and the community feedback and support a deer management program. I am aware as well that a councilmember is proposing to recommend a city council work session and to invite a representative of the HSUS. I was not provided the councilmember's work session resolution by the councilmember who is proposing this work session "path", so heard about it inadvertently. In response, I spoke with Mr. Bahl to encourage the city, if it determines a work session would be helpful, to host a work session with balanced representation (i.e., with an MDNR representative, potentially a Cornell deer study representative, et. al.).
