City Council will meet in caucus the Sunday prior to each regular session at 7 p.m. in Council Chambers.

#### **CALL TO ORDER**

Mayor Taylor called the meeting to order at 7:04 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron Street. Mayor Taylor apologized for the late start, due to technical difficulties.

#### MOMENT OF SILENCE

Council stood for a moment of silence.

#### APPROVAL OF AGENDA

Councilmember Briere requested to remove CA-7 from the agenda, due to some necessary changes to the contract and additional negotiations that are needed.

A motion was made by Councilmember Krapohl, seconded by Councilmember Warpehoski, that the Agenda be approved with changes. On a voice vote, the Mayor declared the motion carried.

#### AC COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Steve Powers updated Council on the following:

The outdoor swimming pools ended the season on a high note, due to the warmer than average temperatures over the Labor Day weekend. The Labor Day weekend had a 66% increase in visitors this year compared to last year, said Mr. Powers. He also noted that Mack Indoor Pool is now open and Buhr Pool will host its annual dog swim this Wednesday and Thursday from 3pm to 8pm each day.

Mr. Powers stated Police Chief interviews are tentatively scheduled for mid-October.

The City is continuing its National Citizens Survey. Postcards will be going out in the next several weeks to a statistically significant random sample of residents alerting them to their participation in the upcoming survey. Survey results should be available by December 1, said Mr. Powers.

Mr. Powers stated community engagement dates are being scheduled for the Library Lane development project.

Mr. Powers reminded Council of the upcoming Work Session scheduled for September 14, stating that the Pedestrian Safety and Access Task Force will be presenting their report.

#### CC COMMUNICATIONS FROM COUNCIL

#### COUNCILMEMBER BRIERE

Councilmember Briere spoke about the disruption to the neighbors along the river due to the increased use and the new Cascades. She urged staff to address the parking and traffic issues.

#### COUNCILMEMBER WESTPHAL

Councilmember Westphal updated Council and the public on the Michigan Hidden Talent Tour that is coming to Ann Arbor. He stated the tour focuses on hiring people with disabilities, stating many of the persons in the disability community who are unemployed have college degrees. Councilmember Westphal stated the tour is coming to Washtenaw Community College on September 24 at 5pm.

Councilmember Westphal also spoke about distracted driving and urged Council to reconsider a discussion on this issue again.

#### COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy addressed the outcome of the lawsuit filed against the DDA by former Chronicle owner Dave Askins. Councilmember Kailasapathy stated she has long opposed the appointments to the DDA due to concerns about the way the Authority has conducted themselves. She noted that the DDA was found in violation of the Open Meetings Act, the Freedom of Information Act and the Downtown Development Authority enabling legislation.

#### **COUNCILMEMBER LUMM**

Councilmember Lumm spoke about the Liquor License Review Committee, stating the Committee discussed the new "Pedal Pubs" legislation at their recent meeting. Councilmember Lumm stated Assistant City Attorney Mary Fales is working on an ordinance to regulate the operation of pedal pubs in Ann Arbor and the ordinance is being reviewed currently, with feedback sought from the DDA, Police, City staff, Parks and possibly the Taxicab Board. She stated she hopes to have the ordinance ready for Council in approximately one month.

#### COUNCILMEMBER GRAND

Councilmember Grand spoke about an upcoming run/walk in Gallup Park. The race, "Rick's Run for Kids" will be held on October 24 at 9am and will benefit the Ann Arbor Rec and Ed Scholarship Fund.

No person may place or permit to be placed on the ground, or less than five feet (5') above the ground surface any grain, fodder, salt licks, fruit, vegetables, nuts, hay or other edible materials [including feed for birds] which may reasonably be expected to result in deer feeding, unless such items are screened or protected in a manner that prevents deer from feeding on them. Living fruit trees and other live vegetation shall not be considered as deer feeding.
