COUNCILMEMBER GRAND

Councilmember Grand noted that longtime staff member Ginny Trocchio was leaving the City. She thanked her for her leadership with the Greenbelt program and land preservation in the City.

Councilmember Grand stated she plans to propose an amendment to the Council Rules that would place staff items on the Consent Agenda or immediately following. She stated there should be a better way to organize business than to have staff sit through many hours of Council debates to get to routine City business items.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski concurred with Councilmember Grand and stated he supports a similar type of change to the Rules. He also stated he has some suggestions for Rules that include motions to continue the meeting beyond 11:00 p.m.

Councilmember Warpehoski stated he is looking at the City's ordinance regarding the placement of fences and whether an amendment could address some of the questions raised about deer management and keeping deer out of yards.

Jane Klingsten, 3347 Elsinore, thanked Jeff Brainard from Toll Brothers for his outreach to neighbors. She asked Council to postpone the proposals to allow neighbors more time to reach consensus with the developer.

Kami Meader, 3140 Dunwoodie, asked Council to postpone the project for one more month to allow the neighbors to work with the developer on the last of their concerns. Tom Wieder, attorney representing neighbors near Nixon Road, urged Council to postpone or defeat this project. He expressed concern regarding the definition of the easement in the development agreement and the traffic improvement plan. Jeff Brainard, Toll Brothers, spoke about the project, stating the design is award-winning and many acres of woodlands and open space have been preserved as part of the project.

Dave Friedricks, representing Barclay Park Condominiums, expressed concern with the density of the project. He urged Council to consider an R1 zoning.
